#### A BILL FOR AN ACT

CONCERNING THE FAIR SETTLEMENT OF CLAIMS FOR BENEFITS UNDER 102 AN INSURANCE POLICY.

### **Bill Summary**

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Current law authorizes double benefits, attorney fees, and costs to a first-party claimant whose claims for benefits under an insurance policy have been delayed or denied without a reasonable basis for that action. The bill establishes a presumption of unreasonableness when an insurer either:

- ! Denies or delays a claim without a reasonable basis for the action; or
- ! Denies or delays the payment of a claim for medical benefits or a request for authorization for medical services by a first- or third-party claimant; the decision to delay or deny payment of the medical claim relates to medical necessity, appropriateness, or reasonableness; and the decision is made by a person who is not licensed in good standing in Colorado and in active clinical practice in the same field or specialty area as the field or specialty area to which the medical claim or requested medical service relates.

The bill extends the remedies available under current law to third-party claimants who assert a claim for medical benefits or request for authorization for medical services against an insured under a liability policy when the claim is denied or delayed as described in the second bullet, above.

shall take effect at 12:01 a.m. on the day following the expiration of the ninety-day period after final adjournment of the general assembly (August 11, 2010, if adjournment sine die is on May 12, 2010); except that, if a referendum petition is filed pursuant to section 1 (3) of article V of the state constitution against this act or an item, section, or part of this act within such period, then the act, item, section, or part shall not take effect unless approved by the people at the general election to be held in November 2010 and shall take effect on the date of the official declaration of the vote thereon by the governor.
