A BILL FOR AN ACT

CONCERNING THE ELIGIBILITY REQUIREMENTS FOR THE NURSING TEACHER LOAN FORGIVENESS PILOT PROGRAM.

Bill Summary

The bill changes certain eligibility requirements for the nursing teacher loan forgiveness pilot program, including reducing the required employment in teaching from full time to half time and allowing the teaching position to begin within 2 years after the completion of the nursing teacher's advanced degree.
