A BILL FOR AN ACT

101 **CONCERNING A COURT'S AUTHORITY TO WAIVE CERTAIN CHARGES**
102 **LEVIED AGAINST INDIGENT DEFENDANTS.**

Bill Summary

The bill clarifies that a court may suspend or waive surcharges and costs for victims and witness services that are levied against a defendant upon conviction of certain criminal actions and traffic offenses or infractions, if the court determines that the defendant is indigent.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** 24-4.1-119 (1) (f) (II), Colorado Revised Statutes,
3 is amended, and the said 24-4.1-119 is further amended BY THE
4 ADDITION OF A NEW SUBSECTION, to read:

5 **24-4.1-119. Costs and surcharges levied on criminal actions**
6 **and traffic offenses.** (1) (f) (II) All calculated surcharge amounts
7 pursuant to this paragraph (f) resulting in dollars and cents shall be
8 rounded down to the nearest whole dollar. ~~A surcharge levied pursuant~~
9 ~~to this paragraph (f) may not be suspended or waived by the court unless~~
10 ~~the court determines that the defendant against whom the surcharge is~~
11 ~~levied is indigent.~~

12 (1.5) A COST OR SURCHARGE LEVIED PURSUANT TO THIS SECTION
13 MAY NOT BE SUSPENDED OR WAIVED BY THE COURT UNLESS THE COURT
14 DETERMINES THAT THE DEFENDANT AGAINST WHOM THE COST OR
15 SURCHARGE IS LEVIED IS INDIGENT.

16 **SECTION 2. Safety clause.** The general assembly hereby finds,
17 determines, and declares that this act is necessary for the immediate
18 preservation of the public peace, health, and safety.
