1 *Be it enacted by the General Assembly of the State of Colorado:*

3 **SECTION 1.** 42-3-304 (18) (d) (I), Colorado Revised Statutes,
4 as it will become effective July 1, 2010, is amended to read:

5 **42-3-304. Registration fees - passenger and passenger-mile**
6 **taxes - clean screen fund - repeal.** (18) (d) (I) In addition to any other
7 fee imposed by this section, the owner shall pay, at the time of
8 registration of a motor vehicle or low-power scooter, a motorist insurance
9 identification fee. The fee shall be adjusted annually by the department,
10 based upon moneys appropriated by the general assembly for the
11 operation of the motorist insurance identification database program. In
12 no event shall the fee exceed fifty cents. The fee shall be transmitted to
13 the state treasurer, who shall credit it to a special account within the
14 highway users tax fund, to be known as the motorist insurance
15 identification account, which is hereby created. Moneys in the motorist
16 insurance identification account shall be used, subject to appropriation by
17 the general assembly, to cover the costs of administration and
18 enforcement of the motorist insurance identification database program,
19 created in section 42-7-604 and, for state fiscal year 2008-09, for
20 expenses incurred in connection with the administration of article 2 of
21 this title by the division of motor vehicles within the department; except
22 that:

23 (A) FOR THE 2010-11 AND 2011-12 FISCAL YEARS, THE STATE
24 TREASURER SHALL TRANSFER MONEYS IN THE ACCOUNT IN EXCESS OF THE
25 AMOUNT OF MONEYS APPROPRIATED FROM THE ACCOUNT TO THE

1 COLORADO STATE TITLING AND REGISTRATION ACCOUNT IN THE HIGHWAY
2 USERS TAX FUND FOR ALLOCATION AND EXPENDITURE AS REQUIRED BY
3 SECTION 42-1-211 (2). THIS SUB-SUBPARAGRAPH (A) IS REPEALED,
4 EFFECTIVE JULY 1, 2012.

5 (B) FOR THE FISCAL YEAR COMMENCING JULY 1, 2012, the state
6 treasurer shall transfer moneys in the account in excess of the amount of
7 moneys appropriated from the account to the highway users tax fund for
8 allocation and expenditure as specified in section 43-4-205 (5.5) (c),
9 C.R.S.

10 **SECTION 2. Safety clause.** The general assembly hereby finds,
11 determines, and declares that this act is necessary for the immediate
12 preservation of the public peace, health, and safety.
