**A BILL FOR AN ACT**

101 **CONCERNING THE IMPLEMENTATION OF CERTAIN RECOMMENDATIONS**  
102 **OF THE COUNTY ELECTED OFFICIALS' SALARY COMMISSION.**

**Bill Summary**

The bill implements 2 of the requests made by the county elected officials' salary commission in its 2010 report to the general assembly.

**Section 1** of the bill changes the timing and frequency of when the commission will meet and submit its report to the general assembly.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** 30-3-105 (3) and (4), Colorado Revised Statutes,  
3 are amended to read:

4 **30-3-105. Commission duties and responsibilities.** (3) No later  
5 than the first day of convening of the ~~second regular session of the~~  
6 ~~sixty-fifth general assembly~~ FIRST REGULAR SESSION OF THE SIXTY-EIGHTH  
7 GENERAL ASSEMBLY and on the first day of convening of the general  
8 assembly every ~~four~~ TWO years thereafter, the commission shall submit  
9 to the local government committees of the general assembly a report that  
10 satisfies the requirements of subsection (4) of this section. The  
11 commission may also submit any interim reports as it deems necessary.  
12 Such interim report may include salary recommendations.

13 (4) The report required to be submitted pursuant to subsection (3)  
14 of this section shall contain recommendations of the commission as to the  
15 appropriate levels of salaries to be paid to county elected officials in each  
16 category of county as set forth in section 30-2-102 for the ~~quadrennial~~  
17 BIENNIAL period following the submission of the report and any additional  
18 facts and information in the judgment of the commission that are relevant  
19 to this determination. The recommendations contained in the report shall  
20 be based on sound and systematic occupational analysis and job  
21 evaluation methods and shall consider the information studied in  
22 subsection (1) of this section.

23 **SECTION 2.** 30-10-905 (1), Colorado Revised Statutes, is  
24 amended to read:

25 **30-10-905. Remuneration - expenses.** (1) In counties of every

1 class, the board of county commissioners may provide for additional  
2 compensation to be paid to a THE COUNTY surveyor who performs  
3 services for the county in addition to the duties specified in section  
4 30-10-903, which compensation shall be paid out of the county treasury.

5 **SECTION 3. Safety clause.** The general assembly hereby finds,  
6 determines, and declares that this act is necessary for the immediate  
7 preservation of the public peace, health, and safety.
