A BILL FOR AN ACT

101 CONCERNING A UNIVERSAL APPLICATION FOR PROGRAMS RELATED TO
102 EARLY CHILDHOOD ISSUES.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Early Childhood and School Readiness Legislative Commission. The bill establishes an early childhood universal application subcommittee (subcommittee) to the government data advisory board (advisory board) created in the office of information technology. The bill specifies membership of and duties for the

subcommittee. The subcommittee will report to the chief information officer (CIO) and the advisory board. The CIO will prepare a report on a universal application to be used by all state agencies, school districts, and federally funded early childhood programs and will combine that report into the annual report the CIO submits to the general assembly. The subcommittee is repealed effective July 1, 2013.
