**Bill Summary**

**Early Childhood and School Readiness Legislative Commission.** The bill establishes an early childhood universal application subcommittee (subcommittee) to the government data advisory board (advisory board) created in the office of information technology. subcommittee. The subcommittee will report to the chief information officer (CIO) and the advisory board. The CIO will prepare a report on a universal application to be used by all state agencies, school districts, and federally funded early childhood programs and will combine that report into the annual report the CIO submits to the general assembly. The subcommittee is repealed effective July 1, 2013.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** Part 7 of article 37.5 of title 24, Colorado Revised  
3 Statutes, is amended BY THE ADDITION OF A NEW SECTION to  
4 read:

5           **24-37.5-703.7. Early childhood universal application**  
6 **subcommittee - created - duties - funding - repeal.** (1) THE EARLY  
7 CHILDHOOD UNIVERSAL APPLICATION SUBCOMMITTEE IS HEREBY CREATED  
8 AS A SUBCOMMITTEE OF THE ADVISORY BOARD. THE EARLY CHILDHOOD  
9 UNIVERSAL APPLICATION SUBCOMMITTEE SHALL CONSIST OF THE  
10 FOLLOWING MEMBERS:

11           (a) THE ADVISORY BOARD MEMBERS APPOINTED PURSUANT TO  
12 SECTION 24-37.5-703 (1) (b) (II) AND (1) (b) (III) TO REPRESENT SCHOOL  
13 DISTRICTS OR THE MEMBERS' DESIGNEES;

14           (b) THE ADVISORY BOARD MEMBER SELECTED FROM THE  
15 DEPARTMENT OF EDUCATION OR THE MEMBER'S DESIGNEE;

16           (c) THE ADVISORY BOARD MEMBER SELECTED FROM THE  
17 DEPARTMENT OF HUMAN SERVICES OR THE MEMBER'S DESIGNEE;

18           (d) THE ADVISORY BOARD MEMBER SELECTED FROM THE  
19 DEPARTMENT OF HEALTH CARE POLICY AND FINANCING OR THE MEMBER'S  
20 DESIGNEE;

21           (e) THE LIEUTENANT GOVERNOR OR HIS OR HER DESIGNEE;

22           (f) THE CHIEF INFORMATION OFFICER OR HIS OR HER DESIGNEE;

1 (g) THE PRESIDENT OF THE STATE SYSTEM OF COMMUNITY AND  
2 TECHNICAL COLLEGES OR HIS OR HER DESIGNEE; AND

3 (h) AT LEAST FIVE MEMBERS APPOINTED BY THE GOVERNOR WITH  
4 EXPERTISE IN EARLY CHILDHOOD PROGRAMS, INCLUDING AT LEAST ONE  
5 PERSON REPRESENTING THE FOLLOWING ENTITIES:

6 (I) A PRIVATE PROVIDER UNDER THE COLORADO CHILD CARE  
7 ASSISTANCE PROGRAM CREATED PURSUANT TO PART 8 OF ARTICLE 2 OF  
8 TITLE 26, C.R.S.;

9 (II) A PRIVATE EARLY HEAD START OR HEAD START AGENCY, AS  
10 DEFINED IN SECTION 22-28-103 (6), C.R.S., THAT DIRECTLY PROVIDES  
11 SERVICES TO FAMILIES;

12 (III) AN EARLY CHILDHOOD CARE AND EDUCATION PROVIDER THAT  
13 IS A CERTIFIED ASSISTANCE SITE FOR MEDICAID AND THE CHILDREN'S BASIC  
14 HEALTH PLAN;

15 (IV) THE DIVISION OF YOUTH CORRECTIONS IN THE DEPARTMENT  
16 OF HUMAN SERVICES; AND

17 (V) THE PREVENTION SERVICES DIVISION WITHIN THE DEPARTMENT  
18 OF PUBLIC HEALTH AND ENVIRONMENT.

19 (2) MEMBERS OF THE EARLY CHILDHOOD UNIVERSAL APPLICATION  
20 SUBCOMMITTEE SHALL SERVE WITHOUT COMPENSATION AND WITHOUT  
21 REIMBURSEMENT FOR EXPENSES.

22 (3) (a) THE CHIEF INFORMATION OFFICER SHALL SCHEDULE THE  
23 FIRST MEETING OF THE EARLY CHILDHOOD UNIVERSAL APPLICATION  
24 SUBCOMMITTEE NO LATER THAN AUGUST 1, 2010. AT THE FIRST MEETING,  
25 THE EARLY CHILDHOOD UNIVERSAL APPLICATION SUBCOMMITTEE SHALL  
26 ELECT A CHAIR FROM AMONG ITS MEMBERS TO SERVE FOR A TERM NOT  
27 EXCEEDING TWO YEARS, AS DETERMINED BY THE SUBCOMMITTEE. A

1 MEMBER SHALL NOT BE ELIGIBLE TO SERVE AS CHAIR FOR MORE THAN TWO  
2 SUCCESSIVE TERMS.

3 (b) THE EARLY CHILDHOOD UNIVERSAL APPLICATION  
4 SUBCOMMITTEE SHALL MEET AS OFTEN AS NECESSARY, AT THE CALL OF  
5 THE CHAIR, TO COMPLETE ITS DUTIES.

6 (c) THE OFFICE, TO THE EXTENT PRACTICABLE WITHIN EXISTING  
7 RESOURCES, SHALL PROVIDE TECHNICAL ASSISTANCE AND SUPPORT TO THE  
8 EARLY CHILDHOOD UNIVERSAL APPLICATION SUBCOMMITTEE TO ASSIST  
9 THE SUBCOMMITTEE IN COMPLETING ITS DUTIES PURSUANT TO THIS  
10 SECTION.

11 (4) THE EARLY CHILDHOOD UNIVERSAL APPLICATION  
12 SUBCOMMITTEE SHALL HAVE THE FOLLOWING DUTIES:

13 (a) TO RECOMMEND TO THE CHIEF INFORMATION OFFICER AND THE  
14 ADVISORY BOARD PROTOCOLS AND PROCEDURES FOR CREATING AND  
15 IMPLEMENTING A UNIVERSAL APPLICATION TO BE USED BY ALL STATE  
16 AGENCIES AND SCHOOL DISTRICTS FOR APPLICATIONS FOR PROGRAMS  
17 RELATED TO EARLY CHILDHOOD CARE AND EDUCATION, INCLUDING BUT  
18 NOT LIMITED TO:

- 19 (I) MEDICAID;
- 20 (II) THE CHILDREN'S BASIC HEALTH PLAN;
- 21 (III) THE HEAD START PROGRAM;
- 22 (IV) THE COLORADO PRESCHOOL PROGRAM;
- 23 (V) THE FREE OR REDUCED-COST LUNCH PROGRAM;
- 24 (VI) THE COLORADO CHILD CARE ASSISTANCE PROGRAM;
- 25 (VII) THE CHILD AND ADULT CARE FOOD PROGRAM;
- 26 (VIII) THE COLORADO WORKS PROGRAM;
- 27 (IX) THE SPECIAL SUPPLEMENTAL FOOD PROGRAM FOR WOMEN,

1 INFANTS, AND CHILDREN;

2 (X) THE FOOD STAMP PROGRAM;

3 (XI) EARLY CHILDHOOD COUNCIL PROGRAMS;

4 (XII) THE LOW-INCOME ENERGY ASSISTANCE PROGRAM; AND

5 (XIII) AFFORDABLE HOUSING PROGRAMS.

6 (b) UPON REQUEST BY THE CHIEF INFORMATION OFFICER, TO  
7 ADVISE THE CHIEF INFORMATION OFFICER ON OTHER ISSUES PERTAINING  
8 TO APPLICATIONS FOR PROGRAMS RELATED TO EARLY CHILDHOOD CARE  
9 AND EDUCATION.

10 (5) THE EARLY CHILDHOOD UNIVERSAL APPLICATION  
11 SUBCOMMITTEE SHALL ENSURE THAT ITS RECOMMENDATIONS CONFORM  
12 WITH THE INTERDEPARTMENTAL DATA PROTOCOL AND ARE IN COMPLIANCE  
13 WITH ALL STATE AND FEDERAL LAWS, RULES, AND REGULATIONS  
14 CONCERNING THE PRIVACY OF INFORMATION, INCLUDING BUT NOT LIMITED  
15 TO THE FEDERAL "FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT OF  
16 1974", 20 U.S.C. SEC. 1232g.

17 (6) ON OR BEFORE DECEMBER 1, 2010, AND AT LEAST EVERY SIX  
18 MONTHS THEREAFTER, THE EARLY CHILDHOOD UNIVERSAL APPLICATION  
19 SUBCOMMITTEE SHALL SUBMIT TO THE CHIEF INFORMATION OFFICER AND  
20 THE ADVISORY BOARD RECOMMENDATIONS PREPARED PURSUANT TO  
21 SUBSECTION (4) OF THIS SECTION. THE CHIEF INFORMATION OFFICER  
22 SHALL REVIEW THE RECOMMENDATIONS AND TAKE THEM INTO ACCOUNT  
23 IN PREPARING A REPORT CONCERNING PROTOCOLS AND PROCEDURES FOR  
24 CREATING AND IMPLEMENTING A UNIVERSAL APPLICATION TO BE USED BY  
25 ALL STATE AGENCIES AND SCHOOL DISTRICTS FOR APPLICATIONS FOR  
26 PROGRAMS RELATED TO EARLY CHILDHOOD CARE AND EDUCATION. THE  
27 CHIEF INFORMATION OFFICER SHALL COMBINE THE REPORT WITH THE

1 REPORT PREPARED PURSUANT TO SECTION 24-37.5-703 (6) AND SUBMIT  
2 THE COMBINED REPORT TO THE GENERAL ASSEMBLY ON OR BEFORE  
3 MARCH 1, 2011, AND ON OR BEFORE MARCH 1 EACH YEAR THEREAFTER.

4 (7) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2013.

5 **SECTION 2. Safety clause.** The general assembly hereby finds,  
6 determines, and declares that this act is necessary for the immediate  
7 preservation of the public peace, health, and safety.
