Bill Summary

Sunset Process - Senate Judiciary Committee. The bill removes the repeal of the interagency task force on drunk driving and adds members to the task force's membership.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Repeal.** 2-3-1203 (3) (x) (V), Colorado Revised
3 Statutes, is repealed as follows:

4 **2-3-1203. Sunset review of advisory committees.** (3) The
5 following dates are the dates for which the statutory authorization for the
6 designated advisory committees is scheduled for repeal:

10 **SECTION 2.** 42-4-1306 (3) and (5), Colorado Revised Statutes,
11 are amended to read:

12 **42-4-1306. Interagency task force on drunk driving - creation.**

13 (3) (a) The task force shall consist of:

14 (I) The executive director of the department of transportation or
15 his or her designee who shall also convene the first meeting of the task
16 force;

17 ~~(II) The executive director of the department of revenue or his or~~
18 ~~her designee~~ TWO REPRESENTATIVES APPOINTED BY THE EXECUTIVE
19 DIRECTOR OF THE DEPARTMENT OF REVENUE, WITH THE FOLLOWING
20 QUALIFICATIONS:

21 (A) ONE REPRESENTATIVE WITH EXPERTISE IN DRIVER'S LICENSE
22 SANCTIONING; AND

23 (B) ONE REPRESENTATIVE WITH EXPERTISE IN ENFORCEMENT OF
24 THE STATE'S LIQUOR SALES LAWS;

25 (III) The state court administrator or his or her designee;

26 (IV) The chief of the Colorado state patrol or his or her designee;

27 (V) The state public defender or his or her designee;

5 (VIII) THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF PUBLIC
6 HEALTH AND ENVIRONMENT, OR HIS OR HER DESIGNEE;

8 member serving pursuant to subparagraph (I) of this paragraph (a):

9 (A) A representative of a statewide association of chiefs of police
10 with experience in making arrests for drunk or impaired driving;

11 (B) A representative of a statewide organization of county sheriffs
12 with experience in making arrests for drunk or impaired driving;

13 (C) A victim or a family member of a victim of drunk or impaired
14 driving;

15 (D) A representative of a statewide organization of victims of
16 drunk or impaired driving;

17 (E) A representative of a statewide organization of district
18 attorneys with experience in prosecuting drunk or impaired driving

19 offenses;

20 (F) A representative of a statewide organization of criminal
21 defense attorneys with experience in defending persons charged with
22 drunk or impaired driving offenses;

23 (G) A representative of a statewide organization that represents
24 persons who sell alcoholic beverages ~~at retail~~ FOR CONSUMPTION
25 ON-PREMISES;

26 (G.5) A REPRESENTATIVE OF A STATEWIDE ORGANIZATION THAT
27 REPRESENTS PERSONS WHO SELL ALCOHOLIC BEVERAGES FOR

1 CONSUMPTION OFF-PREMISES;

2 (H) A representative of a statewide organization that represents
3 distributors of alcoholic beverages in Colorado;

4 (I) A manufacturer of alcoholic beverages in Colorado; and

5 (J) A person under twenty-four years of age who is enrolled in a
6 secondary or postsecondary school; AND

7 (K) A REPRESENTATIVE OF A STATEWIDE ORGANIZATION THAT
8 REPRESENTS ALCOHOL AND DRUG ADDICTION COUNSELORS.

9 (b) Members selected pursuant to ~~subparagraph (VIII)~~
10 SUBPARAGRAPH (IX) of paragraph (a) of this subsection (3) shall serve
11 terms of two years but may be selected for additional terms.

12 (c) Members of the task force shall not be compensated for or
13 reimbursed for their expenses incurred in attending meetings of the task
14 force.

15 (d) The initial meeting of the task force shall be convened on or
16 before August 1, 2006, by the member serving pursuant to subparagraph
17 (I) of paragraph (a) of this subsection (3). At the first meeting, the task
18 force shall elect a chair and vice-chair from the members serving pursuant
19 to ~~subparagraphs (I) to (VII)~~ SUBPARAGRAPHS (I) TO (VIII) of paragraph
20 (a) of this subsection (3), who shall serve a term of two years but who
21 may be reelected for additional terms.

22 (e) The task force shall meet not less frequently than bimonthly
23 and may adopt policies and procedures necessary to carry out its duties.

24 (5) (a) ~~This section is repealed, effective July 1, 2011.~~

25 (b) ~~Prior to said repeal, the interagency task force on drunk
26 driving created pursuant to this section shall be reviewed as provided in
27 section 2-3-1203, C.R.S.~~

1 **SECTION 3. Safety clause.** The general assembly hereby finds,
2 determines, and declares that this act is necessary for the immediate
3 preservation of the public peace, health, and safety.
