A BILL FOR AN ACT

101 **CONCERNING CLASSIFICATION AS AN UNSUBSIDIZED IN-STATE STUDENT**
102 **FOR TUITION PURPOSES AT STATE INSTITUTIONS OF HIGHER**
103 **EDUCATION.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill allows a student, other than certain foreign students or trainees defined in federal law, to be classified as an unsubsidized in-state student for tuition purposes so long as the student:

or more years immediately preceding the date the student graduated from a Colorado high school or earned a general educational development certificate (certificate) in Colorado; and

- ! Is admitted to an institution of higher education in Colorado within 12 months after graduating from high school or earning a certificate.

The bill provides a one-year exception to the eligibility requirements for a student who meets all of the eligibility requirements but was not admitted into an institution of higher education within 12 months after graduating from high school or earning a certificate. The exception is repealed on July 1, 2012.

A student applying for the tuition classification who does not have documentation of lawful immigration or nationality status shall submit an affidavit to the institution of higher education, stating that he or she is requesting documentation of, has applied for, or will be applying for lawful status as soon as he or she is eligible. The information contained in the affidavit is confidential and is a protected education record of the student.

A student classified as an unsubsidized in-state student is not eligible for a college opportunity fund stipend or for any state-funded, need-based financial aid.

Eligibility for the tuition classification is not based upon residency. A student who qualifies for unsubsidized in-state student tuition classification shall not be counted as a resident, and the tuition classification shall not be deemed to establish residency or domicile for any purpose.

Verification of lawful presence in the United States is not required for persons applying for unsubsidized tuition classification.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** Part 1 of article 7 of title 23, Colorado Revised
3 Statutes, is amended BY THE ADDITION OF A NEW SECTION to
4 read:

5 **23-7-112. Classification for unsubsidized in-state tuition -**
6 **repeal.** (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS ARTICLE
7 TO THE CONTRARY, A STUDENT == WHO MEETS ALL OF THE FOLLOWING
8 REQUIREMENTS SHALL BE ELIGIBLE FOR CLASSIFICATION AS AN

1 UNSUBSIDIZED IN-STATE STUDENT FOR TUITION PURPOSES:

2 (a) THE STUDENT ATTENDED A PUBLIC OR PRIVATE HIGH SCHOOL
3 IN COLORADO FOR THREE OR MORE YEARS IMMEDIATELY PRECEDING THE
4 DATE THAT THE STUDENT EITHER GRADUATED FROM A COLORADO HIGH
5 SCHOOL OR EARNED A GENERAL EDUCATIONAL DEVELOPMENT
6 CERTIFICATE IN COLORADO; AND

7 (b) THE STUDENT IS ADMITTED TO AN ACCREDITED INSTITUTION OF
8 HIGHER EDUCATION IN COLORADO WITHIN TWELVE MONTHS AFTER
9 GRADUATING FROM A COLORADO HIGH SCHOOL OR EARNING A GENERAL
10 EDUCATIONAL DEVELOPMENT CERTIFICATE IN COLORADO.

11 (2) (a) NOTWITHSTANDING ANY PROVISIONS OF SUBSECTION (1) OF
12 THIS SECTION TO THE CONTRARY, A STUDENT SHALL BE ELIGIBLE FOR
13 CLASSIFICATION AS AN UNSUBSIDIZED IN-STATE STUDENT FOR TUITION
14 PURPOSES IF:

15 (I) THE STUDENT IS A MINOR AT THE TIME HE OR SHE IS APPLYING
16 FOR CLASSIFICATION AS AN UNSUBSIDIZED IN-STATE STUDENT FOR TUITION
17 PURPOSES; AND

18 (II) THE STUDENT MEETS ALL OF THE REQUIREMENTS SPECIFIED IN
19 SUBSECTION (1) OF THIS SECTION; EXCEPT THAT THE STUDENT WAS NOT
20 ADMITTED TO AN INSTITUTION OF HIGHER EDUCATION WITHIN TWELVE
21 MONTHS AFTER GRADUATING FROM A COLORADO HIGH SCHOOL OR
22 EARNING A GENERAL EDUCATIONAL DEVELOPMENT CERTIFICATE IN
23 COLORADO.

24 (b) THIS SUBSECTION (2) IS REPEALED, EFFECTIVE JULY 1, 2012.

25 (3) (a) PRIOR TO CLASSIFICATION OF A STUDENT AS AN
26 UNSUBSIDIZED IN-STATE STUDENT FOR TUITION PURPOSES, THE
27 INSTITUTION OF HIGHER EDUCATION SHALL REQUIRE A STUDENT WHO DOES

1 NOT HAVE DOCUMENTATION OF LAWFUL IMMIGRATION OR NATIONALITY
2 STATUS TO SUBMIT AN AFFIDAVIT TO THE INSTITUTION OF HIGHER
3 EDUCATION TO WHICH THE STUDENT IS ADMITTED STATING THAT THE
4 STUDENT HAS REQUESTED DOCUMENTATION OF, HAS APPLIED FOR, OR WILL
5 FILE AN APPLICATION FOR LAWFUL STATUS AS SOON AS HE OR SHE IS
6 ELIGIBLE TO DO SO.

7 (b) INFORMATION OBTAINED FROM A STUDENT FOR THE PURPOSES
8 OF IMPLEMENTING THIS SECTION IS CONFIDENTIAL. AN INSTITUTION OF
9 HIGHER EDUCATION THAT RECEIVES AN AFFIDAVIT DESCRIBED IN
10 PARAGRAPH (a) OF THIS SUBSECTION (3) SHALL TREAT THE AFFIDAVIT AS
11 AN EDUCATION RECORD OF THE STUDENT UNDER THE PROVISIONS OF THE
12 FEDERAL "FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT OF 1974", 20
13 U.S.C. SEC. 1232g.

14 (4) A STUDENT WHO IS CLASSIFIED AS AN UNSUBSIDIZED IN-STATE
15 STUDENT FOR TUITION PURPOSES PURSUANT TO THIS SECTION IS NOT
16 ELIGIBLE FOR A STIPEND PURSUANT TO THE COLLEGE OPPORTUNITY FUND
17 PROGRAM CREATED IN SECTION 23-18-201 AND IS NOT ELIGIBLE TO
18 RECEIVE STATE-FUNDED, NEED-BASED FINANCIAL AID.

19 (5) (a) ELIGIBILITY FOR CLASSIFICATION AS AN UNSUBSIDIZED
20 IN-STATE STUDENT FOR TUITION PURPOSES PURSUANT TO THIS SECTION IS
21 NOT BASED UPON RESIDENCY.

22 (b) A STUDENT CLASSIFIED AS AN UNSUBSIDIZED IN-STATE
23 STUDENT FOR TUITION PURPOSES PURSUANT TO THIS SECTION SHALL NOT
24 BE COUNTED AS A RESIDENT AND SHALL NOT BE DEEMED A RESIDENT OR
25 DOMICILIARY AS A RESULT OF HIS OR HER TUITION CLASSIFICATION
26 PURSUANT TO THIS SECTION.

27 (c) THE PROVISIONS OF THIS SECTION ARE INTENDED TO SATISFY

1 THE PROVISIONS OF 8 U.S.C. SEC. 1621 (d) TO THE EXTENT THAT IT MAY
2 BE APPLICABLE.

3 **SECTION 2.** 23-1-104, Colorado Revised Statutes, is amended
4 **BY THE ADDITION OF A NEW SUBSECTION** to read:

5 **23-1-104. Financing the system of postsecondary education -**
6 **report - repeal.** (1.5) FOR FISCAL YEARS 2011-12 THROUGH 2015-16,
7 CASH FUNDS RECEIVED BY AN INSTITUTION AS UNSUBSIDIZED IN-STATE
8 TUITION PURSUANT TO SECTION 23-7-112 SHALL NOT BE SUBJECT TO
9 ANNUAL APPROPRIATION BY THE GENERAL ASSEMBLY OR INCLUDED IN THE
10 SINGLE LINE ITEM APPROPRIATION TO EACH GOVERNING BOARD PURSUANT
11 TO PARAGRAPH (a) OF SUBSECTION (1) OF THIS SECTION. THE INSTITUTION
12 SHALL REPORT UNSUBSIDIZED IN-STATE TUITION, CLASSIFIED AS SUCH
13 PURSUANT TO SECTION 23-7-112, IN THE SAME MANNER THAT THE
14 INSTITUTION REPORTS ALL OTHER TUITION RECEIPTS.

15 **SECTION 3.** 24-76.5-103 (3) (g), Colorado Revised Statutes, is
16 amended, and the said 24-76.5-103 (3) is further amended BY THE
17 ADDITION OF A NEW PARAGRAPH, to read:

18 **24-76.5-103. Verification of lawful presence - exceptions -**
19 **reporting - rules.** (3) Verification of lawful presence in the United
20 States shall not be required:

21 (g) For individuals over the age of eighteen years and under the
22 age of nineteen years who continue to be eligible for medical assistance
23 programs after their eighteenth birthday; OR

24 (h) FOR CLASSIFICATION AS AN UNSUBSIDIZED IN-STATE STUDENT
25 FOR TUITION PURPOSES PURSUANT TO SECTION 23-7-112, C.R.S.

26 **SECTION 4.** **Safety clause.** The general assembly hereby finds,

- 1 determines, and declares that this act is necessary for the immediate
- 2 preservation of the public peace, health, and safety.
