**A BILL FOR AN ACT**

101 **CONCERNING THE VOLUNTARY CONTRIBUTION DESIGNATION**  
102 **BENEFITING THE 9HEALTH FAIR FUND THAT APPEARS ON THE**  
103 **STATE INDIVIDUAL INCOME TAX RETURN FORMS, AND, IN**  
104 **CONNECTION THEREWITH, EXTENDING THE PERIOD FOR THE**  
105 **CONTRIBUTION DESIGNATION.**

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** 39-22-3402, Colorado Revised Statutes, is amended  
3 to read:

4 **39-22-3402. Voluntary contribution designation - procedure.**

5 For income tax years commencing on or after ~~January 1, 2008~~ JANUARY  
6 1, 2011, but prior to ~~January 1, 2011~~ JANUARY 1, 2016, the Colorado state  
7 individual income tax return form shall contain a line whereby each  
8 individual taxpayer may designate the amount of the contribution, if any,  
9 the individual wishes to make to the 9Health Fair fund created in section  
10 39-22-3403.

11 **SECTION 2.** 39-22-3404, Colorado Revised Statutes, is amended  
12 to read:

13 **39-22-3404. Repeal of part.** This part 34 is repealed, effective  
14 ~~January 1, 2012~~ JANUARY 1, 2017, unless the voluntary contribution to the  
15 9Health Fair fund established by section 39-22-3403 is continued or  
16 reestablished by the general assembly acting by bill prior to said date.

17 **SECTION 3. Act subject to petition - effective date.** This act  
18 shall take effect at 12:01 a.m. on the day following the expiration of the  
19 ninety-day period after final adjournment of the general assembly (August  
20 10, 2011, if adjournment sine die is on May 11, 2011); except that, if a  
21 referendum petition is filed pursuant to section 1 (3) of article V of the  
22 state constitution against this act or an item, section, or part of this act  
23 within such period, then the act, item, section, or part shall not take effect  
24 unless approved by the people at the general election to be held in

1 November 2012 and shall take effect on the date of the official  
2 declaration of the vote thereon by the governor.
