9 CONVENED PURSUANT TO SECTION 23-1-108.5 (3), C.R.S.;

10 **SECTION 3.** 23-1-108.5 (3) (a) and (3) (e), Colorado Revised
11 Statutes, are amended to read:

12 **23-1-108.5. Duties and powers of the commission with regard**
13 **to common course numbering system - repeal.** (3) (a) On or before
14 July 1, 2001, the commission shall convene a council consisting of
15 representatives from each of the higher education governing boards, each
16 of the four-year higher education institutions, and a representative sample
17 of the two-year higher education institutions; ~~a representative of students~~
18 ~~enrolled in state-supported state colleges, a representative of students~~
19 ~~enrolled in state-supported community colleges, and a representative of~~
20 ~~students enrolled in state-supported universities;~~ and a representative of
21 the commission. THE COMMISSION SHALL CONSULT WITH THE GOVERNING
22 BOARDS WHEN CONVENING REPRESENTATIVES FROM THE HIGHER

1 EDUCATION INSTITUTIONS. BY JULY 1, 2011, THE COUNCIL SHALL CREATE
2 A PROCESS THROUGH WHICH IT SHALL SEEK INPUT FROM AND CONSULT
3 WITH VARIOUS HIGHER EDUCATION STUDENT ORGANIZATIONS FOR EACH
4 ARTICULATION AGREEMENT AND FOR THE REVIEW OF GENERAL EDUCATION
5 COURSES AND THE COURSE NUMBERING SYSTEM AS REQUIRED IN
6 PARAGRAPH (c) OF THIS SUBSECTION (3).

7 (e) This subsection (3) is repealed, effective July 1, ~~2011~~ 2016.
8 Prior to such repeal, the council of higher education representatives shall
9 be reviewed as provided for in section 2-3-1203, C.R.S.
