- 23 **"SECTION 7.** Part 1 of article 2 of title 22, Colorado Revised
24 Statutes, is amended BY THE ADDITION OF A NEW SECTION to
25 read:

1 **22-2-140. Parent involvement policies - resource bank.**

2 (1) THE DEPARTMENT SHALL CREATE AND MAINTAIN A RESOURCE BANK
3 OF MATERIALS PERTAINING TO PARENT INVOLVEMENT IN EDUCATION FOR
4 SCHOOL DISTRICTS, THE STATE CHARTER SCHOOL INSTITUTE, AND PUBLIC
5 SCHOOLS IN THE STATE. THE DEPARTMENT SHALL WORK WITH THE
6 COLORADO STATE ADVISORY COUNCIL FOR PARENT INVOLVEMENT IN
7 EDUCATION, CREATED IN SECTION 22-7-303, IN GATHERING THE
8 MATERIALS. AT A MINIMUM, THE RESOURCE BANK SHALL INCLUDE MODEL
9 PARENT INVOLVEMENT POLICIES, MODEL PROGRAMS TO INCLUDE PARENTS
10 IN IMPROVING THEIR CHILDREN'S EDUCATION, AND DESCRIPTIONS OF BEST
11 PRACTICES AND STRATEGIES FOR INCREASING PARENT INVOLVEMENT IN
12 SCHOOLS. TO THE EXTENT POSSIBLE, THE DEPARTMENT SHALL ENSURE
13 THAT THE MATERIALS INCLUDED IN THE RESOURCE BANK REPRESENT VERY
14 HIGH-QUALITY PROGRAMS THAT HAVE DEMONSTRATED EFFECTIVENESS.
15 THE DEPARTMENT SHALL MAKE THE MATERIALS AVAILABLE
16 ELECTRONICALLY THROUGH ITS WEB SITE.

17 (2) THE DEPARTMENT SHALL IMPLEMENT THE PROVISIONS OF THIS
18 SECTION TO THE FULLEST DEGREE POSSIBLE WITHIN EXISTING RESOURCES.
19 THE DEPARTMENT MAY SEEK, ACCEPT, AND EXPEND PUBLIC OR PRIVATE
20 GIFTS, GRANTS, OR DONATIONS TO IMPLEMENT THIS SECTION."
