# A BILL FOR AN ACT

101CONCERNING ACCOUNTABILITY FOR STATE PROCUREMENT, AND, IN102CONNECTION THEREWITH, ENACTING THE "COLORADO

103 TAXPAYER EMPOWERMENT ACT OF 2011".

#### **Bill Summary**

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill enacts the "Colorado Taxpayer Empowerment Act of 2011". Current law makes state procurement information available to the public. **Section 2** of the bill requires each contract entered into by a governmental body under the state "Procurement Code" to contain a

provision reflecting this current law and specifies that, with the exception of records exempt from inspection under the "Colorado Open Records Act", upon request, records relating to the costs of or any performance measures under the contract are available to the contracting governmental body, the president of the senate, the speaker of the house of representatives, the minority leaders of the senate and house of representatives, and legislative oversight committees of the general assembly. Authorizes the executive director of the department of personnel and administration to promulgate rules for the administration of the provisions enacted in the bill.

10	(2) EACH CONTRACT ENTERED INTO BY A GOVERNMENTAL
11	BODY PURSUANT TO THIS CODE SHALL SPECIFY THAT THE CONTRACT AND
12	PERFORMANCE MEASURES AND STANDARDS UNDER ARTICLE 103.5 OF THIS
13	TITLE ARE OPEN TO INSPECTION BY THE PUBLIC AS PROVIDED IN SECTIONS
14	<u>24-72-203 and 24-72-204.</u>
15	SECTION 3. Effective date - applicability. This act shall take
16	effect July 1, 2011, and shall apply to all state contracts on or after said
17	date.
18	SECTION 4. Safety clause. The general assembly hereby finds,
