HB11-1055 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 2, line 7, strike "OR TO USE LAND".
- 2 Page 2, line 11, strike "THIRTY" and substitute "SIXTY".
- 3 Page 2, line 14, strike "OR LAND".
- 4 Page 3, line 1, after the period insert "THE CHARTER SCHOOL SHALL BE
5 RESPONSIBLE TO THE DEPARTMENT FOR THE COST OF THE EVALUATION.".
- 6 Page 3, line 2, strike "OR LAND".
- 7 Page 3, line 4, strike "SPACE OR LAND." and substitute "SPACE. THE
8 DECISION OF THE DEPARTMENT SHALL BE FINAL AND NOT SUBJECT TO
9 APPEAL.".
- 10 Page 3, line 6, strike "OR LAND".
- 11 Page 4, line 2, strike "OR ON LAND".
- 12 Page 4, line 6, strike "THIRTY" and substitute "SIXTY".
- 13 Page 4, line 9, strike "OR LAND".
- 14 Page 4, strike line 11 and substitute "SCHOOL'S USE. THE INSTITUTE
15 CHARTER SCHOOL SHALL BE RESPONSIBLE TO THE DEPARTMENT FOR THE

1 COST OF THE EVALUATION. IF THE DEPARTMENT FINDS THE FACILITY
2 SPACE".

3 Page 4, line 13, strike "SPACE OR" and substitute "SPACE."

4 Page 4, strike line 14 and substitute "THE DECISION OF THE DEPARTMENT
5 SHALL BE FINAL AND NOT SUBJECT TO APPEAL."

6 Page 4, line 16, strike "OR LAND".

7 Page 4, after line 20 insert:

8 "(e) PURSUANT TO SECTION 24-30-1303 (1), C.R.S., THE
9 DEPARTMENT OF PERSONNEL SHALL BE RESPONSIBLE FOR NEGOTIATING
10 AND EXECUTING ANY LEASE FOR THE USE OF A STATE-OWNED FACILITY BY
11 AN INSTITUTE CHARTER SCHOOL PURSUANT TO THIS SUBSECTION (8)."

12 Reletter succeeding paragraphs accordingly.

13 Page 4, line 27, strike "(e)" and substitute "(f)".

14 Page 5, line 3, strike "(e)" and substitute "(f)".
