After consideration on the merits, the Committee recommends the following:

HB11-1236 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, strike everything below the enacting clause and
2 substitute:

3 "SECTION 1. 42-3-207 (2), Colorado Revised Statutes, is
4 amended to read:

5 **42-3-207. Special plates - rules - new plates - retirement.**
6 (2) Before a bill is introduced in the general assembly that contains, or
7 any bill is amended to contain, a provision that establishes a new category
8 or type of group special license plate, the person, group, or association
9 proposing ~~such~~ THE special license plate shall submit to the department
10 a proposal for a group special license plate and certify ~~by March 1 of each~~
11 ~~year~~ that at least three thousand of such special plates are to be issued
12 within one year after the authorization of such plates. The department
13 shall verify that any proposed group special license plates meet the
14 three-thousand-plate requirement. ~~and shall submit a consolidated~~
15 ~~proposal, containing all proposed group special license plates that meet~~
16 ~~such plate requirement.~~

17 SECTION 2. 42-3-214 (7), Colorado Revised Statutes, is
18 amended to read:

19 **42-3-214. Special plates - alumni associations - retirement.**
20 (7) The DEPARTMENT SHALL RETIRE THE special ALUMNI license plates
21 authorized by this section ~~shall be retired~~ unless ~~such~~ THE plates have
22 been issued for at least five hundred vehicles by ~~March 1, 2011~~ JULY 1,
23 2016. A PERSON WHO WAS ISSUED A SPECIAL ALUMNI LICENSE PLATE ON

1 OR BEFORE JULY 1, 2016, MAY CONTINUE TO USE THE PLATE AFTER JULY
2 1, 2016.

3 **SECTION 3.** 42-3-222 (3) and (6), Colorado Revised Statutes,
4 are amended to read:

5 **42-3-222. Special plates - support public education.** (3) (a) A
6 person may apply for a support public education special license plate if
7 the person pays the taxes and fees required under this section and
8 provides to the department or an authorized agent a certificate, issued by
9 impact on education, inc., COLORADO LEGACY FOUNDATION, or ~~its~~ EITHER
10 ENTITY'S successor, confirming that ~~such~~ THE person has donated twenty
11 dollars to ~~impact on education, inc.,~~ EITHER ORGANIZATION or ~~its~~ EITHER
12 ENTITY'S successor. When receiving ~~such~~ THE donation, impact on
13 education, inc., COLORADO LEGACY FOUNDATION, OR EITHER ENTITY'S
14 SUCCESSOR, shall ask the donor to specify in writing which nonprofit
15 education organization qualified under paragraph (c) of this subsection
16 (3) should receive the moneys. Impact on education, inc., COLORADO
17 LEGACY FOUNDATION, or ~~its~~ EITHER ENTITY'S successor, shall compile and
18 provide to the donor and the department a list of organizations that the
19 entity has verified qualify for donations under paragraph (c) of this
20 subsection (3).

21 (b) ~~All the moneys collected by~~ Impact on education, inc.,
22 COLORADO LEGACY FOUNDATION, or ~~its~~ EITHER ENTITY'S successor
23 ~~pursuant to this subsection (3)~~ shall be used USE THE MONEYS COLLECTED
24 UNDER THIS SUBSECTION (3) to support programs that focus on student
25 learning in public schools located in Colorado.

26 (c) Impact on education, inc., COLORADO LEGACY FOUNDATION,
27 OR EITHER ENTITY'S SUCCESSOR shall transmit the entire donation to the
28 nonprofit education organization pursuant to paragraph (a) of this
29 subsection (3) if the organization:

30 (I) Exists;

31 (II) Is affiliated with a school district or the state charter institute;

32 (III) Is a nonprofit entity exempt from federal income taxes
33 pursuant to section 501 (c) (3) of the federal "Internal Revenue Code of
34 1986", as amended; and

35 (IV) Agrees to spend all of the donation on programs that focus
36 on student learning in Colorado.

37 (d) ~~Moneys collected by~~ Impact on education, inc., COLORADO
38 LEGACY FOUNDATION, or ~~its~~ EITHER ENTITY'S successor ~~pursuant to this~~
39 ~~subsection (3)~~ shall not be used USE THE MONEYS COLLECTED UNDER THIS
40 SUBSECTION (3) to support political parties, candidates for public office,
41 ballot initiatives, referenda, or any other political activities.

1 (6) The department may stop issuing the support public education
2 special license plate if three thousand license plates are not issued by July
3 1, ~~2011~~ 2016. A person WHO WAS ISSUED A SUPPORT PUBLIC EDUCATION
4 SPECIAL LICENSE PLATE ON OR BEFORE JULY 1, 2016, may continue to use
5 the ~~support public education special license~~ plate after July 1, ~~2011~~ 2016.

6 **SECTION 4.** 42-3-224 (2) (a), Colorado Revised Statutes, is
7 amended to read:

8 **42-3-224. Special plates - Colorado "Kids First".** (2) (a) There
9 is hereby established the Colorado "Kids First" special license plate. The
10 department may stop issuing the Colorado "Kids First" special license
11 plate if three thousand license plates are not issued by July 1, ~~2011~~ 2016.
12 A person WHO WAS ISSUED A COLORADO "KIDS FIRST" SPECIAL LICENSE
13 PLATE ON OR BEFORE JULY 1, 2016, may continue to use the ~~Colorado~~
14 ~~"Kids First"~~ special license plate after July 1, ~~2011~~ 2016.

15 **SECTION 5.** 42-3-225 (2) (b), Colorado Revised Statutes, is

17 **42-3-225. Special plates - Italian-American heritage.**
18 (2) (b) The department may stop issuing the Italian-American heritage
19 special license plate if at least three thousand plates are not issued by July
20 1, ~~2011~~ 2016. A person WHO WAS ISSUED AN ITALIAN-AMERICAN
21 HERITAGE SPECIAL LICENSE PLATE ON OR BEFORE JULY 1, 2016, may
22 continue to use the ~~Italian-American heritage special license~~ plate after
23 July 1, ~~2011~~ 2016.

30 COLORADO HORSE DEVELOPMENT AUTHORITY SPECIAL LICENSE PLATE ON
31 OR BEFORE JULY 1, 2016, may continue to use the ~~Colorado horse~~
32 ~~development authority special license~~ plate after July 1, ~~2011~~ 2016.

12 OR BEFORE JULY 1, 2016, MAY CONTINUE TO USE THE PLATE AFTER JULY

5 **42-3-234. Special plates - adopt a shelter pet - repeal.**

6 (6) (a) The DEPARTMENT SHALL RETIRE THE adopt a shelter pet license
7 plate ~~shall be retired~~ if three thousand plates are not issued by July 1,
8 ~~2014~~ 2016. A PERSON WHO WAS ISSUED AN ADOPT A SHELTER PET LICENSE
9 PLATE ON OR BEFORE JULY 1, 2016, MAY CONTINUE TO USE THE PLATE
10 AFTER JULY 1, 2016.

11 (b) ~~Effective July 1, 2014, this section is repealed if the~~
12 ~~department notifies the revisor of statutes in writing that three thousand~~

14 **SECTION 14. Safety clause.** The general assembly hereby finds,
15 determines, and declares that this act is necessary for the immediate
16 preservation of the public peace, health, and safety."
