Summary of Legislation

This bill creates a 9-member interim committee to study issues related to the state procurement code, make recommendations, and report its findings to the Legislative Council during the 2011 legislative interim. The committee is to consider whether the procurement process can be made more accessible and efficient, whether to centralize procurement in a single office, and how to maximize the participation of Colorado residents. In the event that no General Fund moneys are available, the committee is allowed to accept gifts, grants, and donations. Collections are credited to the Legislative Department Cash Fund, and if sufficient funds are received, can be used to pay the costs of the interim committee.

Background

Under current law, state procurement rules apply only to executive branch agencies, although the legislative and judicial branches of government, and political subdivisions may choose to opt in. Institutions of higher education are included in the procurement code unless they formally elect to

be exempted. Procurement is overseen by the State Purchasing Office of the Department of Personnel and Administration (DPA). In addition to its responsibility for ensuring compliance with state law, DPA has policy and rule-making authority for procurement. A portion of DPA's authority is often delegated to state entities in order to manage routine, local, or discretionary purchases. Typically, a state entity with "delegated purchasing authority" has dedicated staff responsible for knowing and applying procurement rules and overseeing the resulting purchases.

State Revenue

If General Fund moneys are not available, gifts, grants, and donations may be collected to fund costs under HB11-1099. As it is unknown how many gifts, grants, or donations would be received, the amount of potential revenue cannot be estimated.

State Expenditures

The legislature is budgeted each year with resources to support a limited number of interim committees of the General Assembly (5). If this interim committee is not designated by the Legislative Council to be one of the prioritized committees, or if the costs of this interim committee are not included in the budgeted amount, the Legislative Branch will incur additional costs to support the interim committee, as show in Table 1. If no General Fund moneys are available, gifts, grants, and donations may be accepted. However, if sufficient moneys are not received, the committee will not meet. The committee includes 6 legislators, all of whom are entitled to per diem and reimbursement for expenses.

Expenditures Not Included

State Appropriations

No appropriations are required if this interim committee is prioritized by the Legislative Council. If the committee is not selected, in FY 2011-12, the Legislative Department will require \$24,776 and 0.4 FTE in either General Fund or gifts, grants, and donations deposited to the Legislative Department Cash Fund.
