The Senate amended the bill to transfer \$1.8 million from the General Fund to the Colorado Health Care Service Fund. The Legislative Council Staff Fiscal Note dated April 12, 2011 reduces the General Fund expenditure savings in this bill from \$15.8 million to \$14.0 million or by \$1.8 million. However, the General Fund reduction from the Senate Amendment was a revenue impact and not an expenditure impact. Therefore, the appropriation clause shows a decrease of \$15.8 million General Fund, an increase of cash funds of \$1.8 million, and an increase in federal funds of \$12.6 million as described in the Appropriation Status section below.

Amendments/Appropriation Status

The bill includes an appropriation clause that adjusts FY 2011-12 appropriations to the Department of Health Care Policy and Financing as described in the table below.

Bill Sponsor Amendments

Amendment **L.005** (attached) reverses the amendment adopted by the Senate that transferred \$1.8 million General Fund to the Colorado Health Care Services Fund and that increased appropriations to Denver Health and the Federally Qualified Health Centers by \$3.6 million. The bill's appropriation impact with amendment L.005 is described in the table below.

Points to Consider

- 1. The Joint Budget Committee (JBC) has introduced a balanced budget package for FY 2011-12 based on the March 2011 Office of State Planning and Budgeting revenue forecast. The JBC has included as part of its plan the General Fund savings that would result from the passage of this bill, as introduced. Thus, if this bill does not become law with at least \$15.8 million in General Fund savings for FY 2011-12, General Fund expenditures will need to be reduced elsewhere in the FY 2011-12 budget by \$15.8 million. Amendment **L.005** returns the bill to the introduced appropriations impact.
- 2. The Senate adopted an amendment that transferred \$1.8 million General Fund to the Colorado Health Care Services Fund. If S.B. 11-226 does not pass with at least a \$2.0 million transfer from the Licensing Services Cash Fund to the General Fund, the budget will be out of balance by \$1.8 million General Fund.
