HB11-1130 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 3 Page 5, line 27, strike everything before "person" and substitute:
4 "(5) A".
- 5 Page 6, line 7, strike "~~(a)~~ (I)" and substitute "(a)".
- 6 Page 6, line 9, strike "~~(b)~~ (II)" and substitute "(b)".
- 7 Page 6, strike lines 11 through 18.
- 8 Page 8, line 17, strike "CONSIDER POSSIBLE" and substitute "CONSIDER:
9 POSSIBLE".
- 10 Page 8, line 20, strike "MATERIALS." and substitute "MATERIALS;
11 RECOMMENDATIONS REGARDING WHEN AND HOW A COMMODITY METALS
12 PURCHASER SHOULD BE REQUIRED TO APPRISE LOCAL LAW ENFORCEMENT
13 AUTHORITIES IF A PURCHASED COMMODITY METAL IS A POTENTIAL MATCH
14 OF A COMMODITY METAL REPORTED STOLEN IN THE SCRAP THEFT ALERT

- 5 Page 9, line 3, strike "2021." and substitute "2016."
- 6 Page 9, strike lines 25 through 27.
- 7 Page 10, strike lines 1 through 15.
- 8 Renumber succeeding sections accordingly.
- 9 Page 10, line 16, strike "(3)," and substitute "(3) (cc)".
- 10 Page 10, line 17, strike "PARAGRAPH" and substitute
11 "SUBPARAGRAPH".
- 12 Page 10, strike line 21 and substitute:
13 "(cc) July 1, 2016:".
- 14 Page 10, line 22, strike "(I)" and substitute "(III)".
