After consideration on the merits, the Committee recommends the following:

HB11-1285 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, strike everything below the enacting clause and
2 substitute the following:
3 "SECTION 1. 25.5-5-402 (1), Colorado Revised Statutes, is
4 amended to read:
5 **25.5-5-402. Statewide managed care system - rules.**
6 (1) (a) The state board shall adopt rules to implement a managed care
7 system for Colorado medical assistance clients pursuant to ~~the provisions~~
8 ~~of~~ this article and articles 4 and 6 of this title. The statewide managed
9 care system shall be implemented to the extent possible.
10 (b) THE STATE DEPARTMENT SHALL INSTITUTE A PROCESS FOR
11 STAKEHOLDER INPUT WITH RESPECT TO ACHIEVING COST SAVINGS,
12 QUALITY OF PATIENT CARE, AND EFFICIENCIES THROUGH THE
13 COORDINATION OF LONG-TERM CARE SERVICES PRIOR TO CONSIDERATION
14 OF A STATEWIDE LONG-TERM CARE SYSTEM FOR COLORADO MEDICAL
15 ASSISTANCE CLIENTS.
16 (c) ON OR BEFORE JANUARY 2, 2012, THE STATE DEPARTMENT
17 SHALL REPORT THE RESULTS OF THE STAKEHOLDER PROCESS REQUIRED IN
18 PARAGRAPH (b) OF THIS SUBSECTION (1) AND ANY RECOMMENDATIONS
19 FOR LEGISLATIVE OR REGULATORY CHANGES THAT RESULT FROM THE
20 PROCESS TO THE HEALTH AND ENVIRONMENT COMMITTEE OF THE HOUSE
21 OF REPRESENTATIVES AND THE HEALTH AND HUMAN SERVICES COMMITTEE
22 OF THE SENATE.
23 **SECTION 2. Effective date.** This act shall take effect July 1,
24 2011.

1 **SECTION 3. Safety clause.** The general assembly hereby finds,
2 determines, and declares that this act is necessary for the immediate
3 preservation of the public peace, health, and safety."

4 Page 1, line 101, strike "**MANAGED CARE**" and substitute "**STAKEHOLDER**
5 **PROCESS**".

6 Page 1, line 102, strike "**SYSTEM FOR**" and substitute "**FOR THE**
7 **MANAGEMENT OF**".
