A BILL FOR AN ACT

101 **CONCERNING RIGHTS OF CERTAIN CHILDREN IN FOSTER CARE, AND, IN**
102 **CONNECTION THEREWITH, ESTABLISHING RIGHTS FOR CHILDREN**
103 **IN FOSTER CARE EXCEPT FOR THOSE IN THE CUSTODY OF THE**
104 **DIVISION OF YOUTH CORRECTIONS OR A STATE MENTAL**

rights for youth in foster care, excluding those in the custody of the division of youth corrections or a state mental hospital (youth).

The court shall ensure that youth who are 16 to 18 years of age are provided assistance in obtaining a free credit report for the youth. If there is evidence of identity theft, staff shall refer the case to a governmental or nonprofit entity, as approved by the state department of human services (department), to take remedial action to clear the youth's credit report.

The department is required to promulgate rules concerning policies for allowing youth 12 years of age and older greater access to extracurricular activities.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** Title 19, Colorado Revised Statutes, is amended BY
3 THE ADDITION OF A NEW ARTICLE to read:

5 **Protections for Youth in Foster Care**

6 **19-7-101. Legislative declaration.** (1) THE GENERAL ASSEMBLY
7 HEREBY FINDS AND DECLARES THAT YOUTH IN FOSTER CARE, EXCLUDING
8 THOSE IN THE CUSTODY OF THE DIVISION OF YOUTH CORRECTIONS OR A
9 STATE MENTAL HOSPITAL, SHOULD ENJOY THE FOLLOWING:

10 (a) TO LIVE IN A SAFE, HEALTHY, AND COMFORTABLE
11 ENVIRONMENT WHERE HE OR SHE IS TREATED WITH RESPECT AND DIGNITY;

12 (b) TO BE FREE FROM PHYSICAL, SEXUAL, EMOTIONAL, OR OTHER
13 ABUSE OR CORPORAL PUNISHMENT;

14 (c) TO RECEIVE ADEQUATE AND HEALTHY FOOD, ADEQUATE
15 CLOTHING, AND AN ADEQUATE ALLOWANCE, AS APPROPRIATE;

16 (d) TO RECEIVE MEDICAL, DENTAL, VISION, AND MENTAL HEALTH
17 SERVICES AS NEEDED;

18 (e) TO BE FREE OF THE ADMINISTRATION OF PRESCRIPTION
19 MEDICATION OR OTHER CHEMICAL SUBSTANCES, UNLESS AUTHORIZED BY
20 A PHYSICIAN;

1 (f) TO BE FREE TO CONTACT THOSE PERSONS WORKING ON HIS OR
2 HER BEHALF, INCLUDING BUT NOT LIMITED TO, CASE WORKERS,
3 ATTORNEYS, FOSTER YOUTH ADVOCATES AND SUPPORTERS,
4 COURT-APPOINTED SPECIAL ADVOCATES, AND PROBATION OFFICERS;

5 (g) TO BE FREE TO CONTACT THE CHILD PROTECTION OMBUDSMAN,
6 COUNTY DEPARTMENT OF SOCIAL SERVICES, OR THE DEPARTMENT OF
7 HUMAN SERVICES REGARDING ANY QUESTIONS, CONCERNS, OR VIOLATIONS
8 OF THE RIGHTS SET FORTH IN THIS ARTICLE, TO SPEAK TO
9 REPRESENTATIVES OF THOSE OFFICES PRIVATELY, AND TO BE FREE FROM
10 THREATS OR PUNISHMENT FOR MAKING COMPLAINTS;

11 (h) AS APPROPRIATE, TO MAKE AND RECEIVE CONFIDENTIAL
12 TELEPHONE CALLS AND TO SEND AND RECEIVE UNOPENED MAIL IN
13 ACCORDANCE WITH HIS OR HER PERMANENCY GOALS;

14 (i) TO BE FREE TO ATTEND RELIGIOUS SERVICES AND ACTIVITIES OF
15 HIS OR HER CHOICE;

16 (j) TO BE ALLOWED TO MAINTAIN AN EMANCIPATION BANK
17 ACCOUNT AND MANAGE PERSONAL INCOME, CONSISTENT WITH THE
18 YOUTH'S AGE AND DEVELOPMENTAL LEVEL, UNLESS PROHIBITED BY HIS OR
19 HER CASE PLAN;

20 ==
21 (k) TO ATTEND SCHOOL, HAVE ACCESS TO TRANSPORTATION, AND
22 PARTICIPATE IN EXTRACURRICULAR, CULTURAL, AND PERSONAL
23 ENRICHMENT ACTIVITIES CONSISTENT WITH THE YOUTH'S AGE AND
24 DEVELOPMENTAL LEVEL;

25 (l) AS APPROPRIATE, TO BE FREE TO WORK AND DEVELOP JOB
26 SKILLS IF IT IS IN HIS OR HER BEST INTERESTS AND IS IN ACCORDANCE WITH
27 HIS OR HER PERMANENCY GOALS;

1 (m) AS APPROPRIATE, TO BE FREE TO HAVE SOCIAL CONTACTS
2 WITH PEOPLE OUTSIDE THE FOSTER CARE SYSTEM, SUCH AS TEACHERS,
3 CHURCH MEMBERS, MENTORS, AND FRIENDS IN ACCORDANCE WITH HIS OR
4 HER PERMANENCY GOALS;

5 (n) TO BE FREE TO ATTEND INDEPENDENT LIVING CLASSES IF HE OR
6 SHE MEETS PROGRAM AND AGE REQUIREMENTS;

7 (o) TO CONSULT WITH THE COURT CONDUCTING THE YOUTH'S
8 PERMANENCY HEARING, IN AN AGE-APPROPRIATE MANNER, REGARDING
9 THE YOUTH'S PERMANENCY PLAN, PURSUANT TO SECTION 19-3-702 (3.7);

10 (p) TO HAVE A SAFE PLACE TO STORE PERSONAL BELONGINGS;

11 (q) AS APPROPRIATE TO HIS OR HER AGE AND DEVELOPMENTAL
12 LEVEL, TO BE ALLOWED TO PARTICIPATE IN AND REVIEW HIS OR HER OWN
13 CASE PLAN, IF HE OR SHE IS TWELVE YEARS OF AGE OR OLDER, AND TO
14 RECEIVE INFORMATION ABOUT HIS OR HER OUT-OF-HOME PLACEMENT AND
15 CASE PLAN, INCLUDING BEING INFORMED OF ANY CHANGES TO THE CASE
16 PLAN;

17 (r) TO CONFIDENTIALITY OF ALL JUVENILE COURT RECORDS,
18 CONSISTENT WITH EXISTING LAW;

19 (s) TO HAVE FAIR AND EQUAL ACCESS TO AVAILABLE SERVICES,
20 PLACEMENT, CARE, TREATMENT BASED ON HIS OR HER TREATMENT PLAN,
21 AND BENEFITS, AND TO NOT BE SUBJECTED TO DISCRIMINATION OR
22 HARASSMENT ON THE BASIS OF ACTUAL OR PERCEIVED RACE, ETHNIC
23 GROUP, NATIONAL ORIGIN, RELIGION, SEX, SEXUAL ORIENTATION, GENDER
24 IDENTITY, MENTAL OR PHYSICAL DISABILITY, OR HIV STATUS;

25 (t) AT SIXTEEN YEARS OF AGE OR OLDER, TO HAVE ACCESS TO
26 EXISTING INFORMATION REGARDING THE EDUCATIONAL OPTIONS
27 AVAILABLE TO HIM OR HER, INCLUDING, BUT NOT LIMITED TO, THE COURSE

1 WORK NECESSARY FOR VOCATIONAL AND POSTSECONDARY EDUCATIONAL
2 PROGRAMS, AND INFORMATION REGARDING FINANCIAL AID AVAILABLE FOR
3 POSTSECONDARY EDUCATION;

4 (u) TO HAVE SCHOOL STABILITY THAT PRESUMES THE YOUTH WILL
5 REMAIN IN THE SCHOOL IN WHICH HE OR SHE IS ENROLLED AT THE TIME OF
6 PLACEMENT, UNLESS REMAINING IN THAT SCHOOL IS NOT IN HIS OR HER
7 BEST INTERESTS;

8 (v) TO REMAIN IN THE CUSTODY OF HIS OR HER PARENT OR LEGAL
9 GUARDIAN UNLESS HIS OR HER WELFARE AND SAFETY OR THE PROTECTION
10 OF THE PUBLIC WOULD BE OTHERWISE ENDANGERED, AND THE RIGHT THAT
11 THE COURT PROCEED WITH ALL POSSIBLE SPEED TO A LEGAL
12 DETERMINATION THAT WILL SERVE HIS OR HER BEST INTERESTS PURSUANT
13 TO SECTION 19-1-102;

14 (w) TO BE PLACED IN A HOME WHERE THE FOSTER CAREGIVER IS
15 AWARE OF AND UNDERSTANDS THE YOUTH'S UNIQUE HISTORY AS IT
16 RELATES TO HIS OR HER CARE;

17 (x) TO RECEIVE EFFECTIVE CASE MANAGEMENT AND PLANNING
18 THAT WILL PRIORITIZE THE SAFE RETURN OF THE YOUTH TO HIS OR HER
19 FAMILY OR MOVE THE YOUTH ON TO OTHER FORMS OF PERMANENT
20 PLACEMENT;

21 (y) TO BE INVOLVED IN MEETINGS AT WHICH DECISIONS ABOUT HIS
22 OR HER FUTURE ARE BEING MADE, AND TO HAVE THE CHILD WELFARE
23 AGENCY BRING TOGETHER THE YOUTH'S FAMILY GROUP AND OTHER
24 SUPPORTERS TO DECISION-MAKING MEETINGS AT WHICH THE GROUP
25 CREATES A PLAN FOR THE YOUTH'S FUTURE;

26 (z) TO PLACEMENT IN THE LEAST RESTRICTIVE SETTING
27 APPROPRIATE TO THE YOUTH'S NEEDS;

1 (aa) TO HAVE A GUARDIAN AD LITEM APPOINTED TO REPRESENT
2 THE YOUTH'S BEST INTERESTS; AND

3 (bb) TO LIVE WITH OR BE VISITED BY HIS OR HER SIBLINGS AND TO
4 BE PLACED IN CLOSE PROXIMITY TO FAMILY, WHEN APPROPRIATE.

5 **19-7-102. Protection against identity theft.** (1) THE COURT
6 SHALL ENSURE THAT EACH YOUTH IN FOSTER CARE, EXCLUDING YOUTH IN
7 THE CUSTODY OF THE DIVISION OF YOUTH CORRECTIONS OR A STATE
8 MENTAL HOSPITAL, WHO IS SIXTEEN THROUGH EIGHTEEN YEARS OF AGE
9 OBTAINS A FREE CREDIT REPORT. IF THE CREDIT REPORT SHOWS EVIDENCE
10 OF POSSIBLE IDENTITY THEFT, THE PERSON ASSISTING THE YOUTH SHALL
11 REFER THE MATTER TO A GOVERNMENTAL OR NONPROFIT ENTITY ON THE
12 REFERRAL LIST DEVELOPED PURSUANT TO SUBSECTION (2) OF THIS SECTION
13 FOR REMEDIAL ACTION.

14 (2) (a) ON OR BEFORE JULY 31, 2012, THE DEPARTMENT OF HUMAN
15 SERVICES SHALL DEVELOP, IN CONSULTATION WITH COUNTY
16 DEPARTMENTS OF SOCIAL SERVICES, A REFERRAL LIST OF GOVERNMENTAL
17 AND NONPROFIT ENTITIES THAT ARE AUTHORIZED TO ASSIST A YOUTH IN
18 FOSTER CARE, EXCLUDING A YOUTH IN THE CUSTODY OF THE DIVISION OF
19 YOUTH CORRECTIONS OR A STATE MENTAL HOSPITAL, WHO HAS FOUND
20 EVIDENCE OF POSSIBLE IDENTITY THEFT ON HIS OR HER CREDIT REPORT.
21 AN ENTITY ON THE REFERRAL LIST DEVELOPED PURSUANT TO THIS
22 SUBSECTION (2) IS AUTHORIZED TO TAKE ANY NECESSARY REMEDIAL
23 ACTIONS TO CLEAR THE YOUTH'S CREDIT RECORD AND SHALL REPORT THE
24 RESULTS OF ITS ACTIONS TO THE COUNTY DEPARTMENT OF SOCIAL
25 SERVICES FOR THE COUNTY IN WHICH THE YOUTH RESIDES.

26 (b) IN COMPILING THE REFERRAL LIST PURSUANT TO PARAGRAPH
27 (a) OF THIS SUBSECTION (2), THE DEPARTMENT OF HUMAN SERVICES, AND

1 ANY COUNTY DEPARTMENTS OF SOCIAL SERVICES CONSULTED THEREIN,
2 SHALL BE IMMUNE FROM LIABILITY, CIVIL OR CRIMINAL, THAT MIGHT
3 OTHERWISE BE INCURRED OR IMPOSED, SO LONG AS THE DEPARTMENT OF
4 HUMAN SERVICES AND ANY COUNTY DEPARTMENTS OF SOCIAL SERVICES
5 CONSULTED ACTED IN GOOD FAITH.

6 **19-7-103. Access to extracurricular activities - legislative**
7 **declaration - rules.** (1) (a) THE GENERAL ASSEMBLY FINDS AND
8 DECLARES THAT IT IS IMPORTANT FOR YOUTH IN FOSTER CARE, EXCLUDING
9 THOSE IN THE CUSTODY OF THE DIVISION OF YOUTH CORRECTIONS OR A
10 STATE MENTAL HOSPITAL, TO HAVE INCREASED ACCESS TO NORMATIVE,
11 DEVELOPMENTALLY APPROPRIATE EXTRACURRICULAR ACTIVITIES TO HELP
12 PREPARE THEM FOR INDEPENDENCE. FOSTER PARENTS AND GROUP HOME
13 ADMINISTRATORS SHALL MAKE EVERY EFFORT TO ALLOW A YOUTH IN
14 THEIR CUSTODY TO PARTICIPATE IN EXTRACURRICULAR, CULTURAL,
15 EDUCATIONAL, WORK-RELATED, AND PERSONAL ENRICHMENT ACTIVITIES.
16 ON OR BEFORE JULY 31, 2012, THE DEPARTMENT OF HUMAN SERVICES
17 SHALL PROMULGATE RULES FOR THE IMPLEMENTATION OF THIS SECTION.
18 THE RULES SHALL ADDRESS POLICIES, INCLUDING BUT NOT LIMITED TO
19 WAIVER OF ANY FINGERPRINT-BASED CRIMINAL HISTORY RECORDS CHECKS
20 FOR ENTITIES PROVIDING EXTRACURRICULAR ACTIVITIES AND GUIDELINES
21 FOR DETERMINING IN WHAT SITUATIONS IT IS APPROPRIATE TO WAIVE
22 FINGERPRINT-BASED CRIMINAL HISTORY RECORDS CHECKS, TO ALLOW
23 YOUTH IN FOSTER CARE, EXCLUDING THOSE IN THE CUSTODY OF THE
24 DIVISION OF YOUTH CORRECTIONS OR A STATE MENTAL HOSPITAL, WHO
25 ARE TWELVE YEARS OF AGE AND OLDER TO PARTICIPATE IN
26 AGE-APPROPRIATE EXTRACURRICULAR ENRICHMENT, SOCIAL ACTIVITIES,
27 AND ACTIVITIES DESIGNED TO ASSIST THOSE YOUTH TO MAKE THE

1 TRANSITION TO INDEPENDENCE, BUILD LIFE SKILLS, AND ENHANCE
2 OPPORTUNITIES TO MAKE POSITIVE CONNECTIONS.

3 (b) IF THE DEPARTMENT OF HUMAN SERVICES OR A COUNTY
4 DEPARTMENT OF SOCIAL SERVICES WAIVES A FINGERPRINT-BASED
5 CRIMINAL HISTORY RECORDS CHECK PURSUANT TO PARAGRAPH (a) OF THIS
6 SUBSECTION (1), THE DEPARTMENT OF HUMAN SERVICES OR COUNTY
7 DEPARTMENT OF SOCIAL SERVICES SHALL BE IMMUNE FROM LIABILITY,
8 CIVIL OR CRIMINAL, THAT MIGHT OTHERWISE BE INCURRED OR IMPOSED,
9 SO LONG AS THE DEPARTMENT OF HUMAN SERVICES OR COUNTY
10 DEPARTMENT OF SOCIAL SERVICES ACTED IN GOOD FAITH WHEN MAKING
11 THE DETERMINATION TO WAIVE THE FINGERPRINT-BASED CRIMINAL
12 HISTORY RECORDS CHECK.

13 **SECTION 2. Act subject to petition - effective date.** This act
14 shall take effect at 12:01 a.m. on the day following the expiration of the
15 ninety-day period after final adjournment of the general assembly (August
16 10, 2011, if adjournment sine die is on May 11, 2011); except that, if a
17 referendum petition is filed pursuant to section 1 (3) of article V of the
18 state constitution against this act or an item, section, or part of this act
19 within such period, then the act, item, section, or part shall not take effect
20 unless approved by the people at the general election to be held in
21 November 2012 and shall take effect on the date of the official
22 declaration of the vote thereon by the governor.
