After consideration on the merits, the Committee recommends the following:

HB11-1211 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 3, line 20, strike "EMPLOYEE" and substitute
2 "PERSON".

3 Page 3, line 22, after "PURPOSES." add ""TRAVEL-RELATED
4 EXPENDITURES" SHALL NOT INCLUDE THE ACTUAL COSTS OF TRAVEL
5 UNDERTAKEN BY THE COVERED PERSON FOR BUSINESS-RELATED PURPOSES
6 INCLUDING, WITHOUT LIMITATION, AIRLINE FARES, TAXICAB FARES,
7 AUTOMOBILE RENTALS, OR REIMBURSEMENT FOR AUTOMOBILE MILEAGE
8 EXPENSES."

9 Page 3, line 24, after "(1)" insert "(a)".

10 Page 4, strike line 6 and substitute:

11 "IS TO BE USED.

12 (b) NOTWITHSTANDING ANY OTHER PROVISION OF THIS SECTION,
13 THE STATE-CHARTERED ENTITY MAY MAKE:

14 (I) LODGING EXPENDITURES THAT ARE ABOVE TWO TIMES THE
15 FEDERAL PER DIEM FOR AN EDUCATIONAL CONFERENCE WHERE THE HOTEL
16 IS HOSTING THE CONFERENCE AND THE PERSON OR ENTITY ORGANIZING
17 THE CONFERENCE SELECTED THE HOTEL; OR

1 (II) TRAVEL EXPENDITURES THAT ARE DIRECTLY RELATED TO A
2 PROGRAM OR A BUSINESS PURPOSE OF A STATE INSTITUTION OF HIGHER
3 EDUCATION OR A STATE HOSPITAL AUTHORITY.

4 (c) IN THE CIRCUMSTANCES DESCRIBED IN SUBPARAGRAPH (I) OR
5 (II) OF PARAGRAPH (b) OF THIS SUBSECTION (1), THE STATE-CHARTERED
6 ENTITY SHALL MAKE AVAILABLE FOR REVIEW BY ITS GOVERNING BODY OR
7 FOR PUBLIC INSPECTION, UPON THE PROVISION OF REASONABLE NOTICE,
8 ITEMIZATION OF ANY EXPENDITURES SATISFYING SUCH EXCEPTIONS TO THE
9 REQUIREMENTS OF THIS SECTION.

10 (2) IF THE STATE CHARTERED ENTITY MAKES".

11 Page 4, line 8, after "BY" insert "SUBSECTION (1) OF".

12 Page 4, line 12, strike "(2)" and substitute "(3)".
