After consideration on the merits, the Committee recommends the following:

HB11-1220 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 5, line 12, strike "FIVE".
- 2 Page 6, line 7, strike "AWAITING FUNDING".
- 3 Page 6, line 15, strike "TO BE COMPLETED." and substitute "BY THE LOCAL
4 GOVERNMENT."
- 5 Page 6, line 21, strike "EXCEPT".
- 6 Page 6, line 22, strike "FOR" and substitute "BEYOND".
- 7 Page 7, line 3, strike "RETAIL" and substitute "COMMERCIAL".
- 8 Page 10, after line 8 insert:
9 **"24-46-404. Conditional approval.** A LOCAL GOVERNMENT MAY
10 APPLY TO THE COMMISSION FOR CONDITIONAL APPROVAL OF A
11 TRANSPORTATION PROJECT THAT HAS NOT YET BEEN INCLUDED IN A
12 TRANSPORTATION IMPROVEMENT PROGRAM OR IN THE STATEWIDE
13 TRANSPORTATION IMPROVEMENT PROGRAM. THE APPROVAL SHALL BE
14 CONDITIONED UPON THE PROJECT BEING INCLUDED IN THE PROGRAMS
15 WITHIN FOUR YEARS FROM THE CONDITIONAL APPROVAL DATE. THE
16 COMMISSION MAY NOT REVOKE A CONDITIONAL APPROVAL, BUT FAILURE
17 OF A TRANSPORTATION PROJECT TO BE INCLUDED IN THE PROGRAMS

1 WITHIN FOUR YEARS SHALL DEEM THE APPLICATION DENIED WITHOUT
2 FURTHER COMMISSION ACTION AND NO STATE SALES TAX REVENUE SHALL
3 BE DEDICATED TO THE LOCAL GOVERNMENT UNDER THIS PART 4."

4 Renumber succeeding C.R.S. sections accordingly.

5 Page 11, line 22, after "DEPARTMENT." add "THE DEPARTMENT MAY ALSO
6 REQUIRE ANY BUSINESS LOCATED WITHIN THE ZONE THAT COLLECTS SALES
7 TAX TO FILE SALES TAX FORMS ELECTRONICALLY IF:

8 (a) THE AMOUNT OF INFORMATION THAT THE BUSINESS IS
9 REQUIRED TO INCLUDE ON THE SALES TAX FORMS EXCEEDS THE SPACE
10 AVAILABLE ON THE HARD COPY SALES TAX FORMS;

11 (b) INCREASING THE AMOUNT OF SPACE AVAILABLE ON THE HARD
12 COPY SALES TAX FORMS WOULD BE ADMINISTRATIVELY BURDENSOME OR
13 EXPENSIVE TO THE DEPARTMENT OF REVENUE; AND

14 (c) MANDATORY ELECTRONIC FILING WOULD NOT IMPOSE A
15 SIGNIFICANT ADMINISTRATIVE BURDEN OR EXPENSE ON THE BUSINESS."

16 Page 13, strike line 2.

17 Page 13, line 3, strike "TRANSPORTATION" and substitute "FOR ANY"

18 Page 13, line 4, after "4" insert "THAT WILL BE CONSTRUCTED BY THE
19 DEPARTMENT OF TRANSPORTATION, THE DEPARTMENT SHALL BEGIN THE
20 DESIGN AND CONSTRUCTION OF THE PROJECT".

21 Page 15, strike lines 24 through 26 and substitute:

22 **"SECTION 3. Act subject to petition - effective date.** This act
23 shall take effect at 12:01 a.m. on the day following the expiration of the
24 ninety-day period after final adjournment of the general assembly (August
25 10, 2011, if adjournment sine die is on May 11, 2011); except that, if a
26 referendum petition is filed pursuant to section 1 (3) of article V of the
27 state constitution against this act or an item, section, or part of this act
28 within such period, then the act, item, section, or part shall not take effect
29 unless approved by the people at the general election to be held in
30 November 2012 and shall take effect on the date of the official
31 declaration of the vote thereon by the governor."
