After consideration on the merits, the Committee recommends the following:

HB11-1198 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 5, strike lines 25 and 26 and substitute:
 - 2 "(20) "TOWING CARRIER" MEANS A MOTOR CARRIER THAT:
 - 3 (a) PROVIDES, AS ONE OF ITS PRIMARY FUNCTIONS, THE TOWING OF
 - 4 MOTOR VEHICLES BY USE OF A TOW TRUCK; AND
 - 5 (b) MAY ALSO PROVIDE STORAGE OF TOWED VEHICLES."
- 6 Page 6, strike lines 11 and 12 and substitute "AND ENFORCE COMPLIANCE
- 7 WITH THE CERTIFICATE AND PERMIT REQUIREMENTS OF THIS ARTICLE AND
- 8 ARTICLE 10.5 OF THIS TITLE."
- 9 Page 21, line 16, strike "IS NECESSARY" and substitute "REQUIRE THE
- 10 REGULATION OF CONTRACT CARRIERS".
- 11 Page 24, line 24, after "AUTHORITY" insert "FOR A PERIOD WHICH MAY
- 12 EXTEND".
- 13 Page 24, line 25, strike "AN EXTENSION" and substitute "A GRANT OF
- 14 TEMPORARY AUTHORITY OR AN EXTENSION THEREOF".
- 15 Page 25, line 12, strike "MOTOR".

- 17 EXTEND".

11 BOND IN THE AMOUNT OF AT LEAST FIFTY THOUSAND DOLLARS,".
- 12 Page 31, line 18, after the period add "THE SURETY BOND MUST BE MADE
13 PAYABLE TO THE COMMISSION AND IS FOR THE PURPOSE OF PAYING ANY
14 CIVIL PENALTY ASSESSMENTS AGAINST THE CARRIER THAT THE CARRIER
15 FAILS TO PAY WHEN DUE.
- 16 (b) A TOWING CARRIER THAT HELD A CURRENT AND VALID PERMIT
17 ON THE EFFECTIVE DATE OF THIS SUBSECTION (3) MUST FILE PROOF OF
18 WORKERS' COMPENSATION INSURANCE COVERAGE AND OF THE SURETY
19 BOND AS REQUIRED BY PARAGRAPH (a) OF THIS SUBSECTION (3) ON OR
20 BEFORE DECEMBER 31, 2011.".
