TITLE:

CONCERNING THE ADJUSTMENT OF CERTAIN DATES RELATED TO THE ADMINISTRATION OF ELECTIONS IN ORDER TO COMPLY WITH THE FEDERAL "MILITARY AND OVERSEAS VOTER EMPOWERMENT (MOVE) ACT" BUT EXCLUDING THE ADJUSTMENT OF ANY DATES RELATED TO VOTER

REGISTRATION.

Summary of Legislation

The bill moves up the dates for primary elections and precinct caucuses in even-year elections to earlier in the year and adjusts various election deadlines to comply with the federal Military and Overseas Voter Empowerment (MOVE) Act. Table 1 provides an overview of the dates and deadlines changed by the bill.

Assessment

The bill is not expected to affect state or local revenue or expenditures and is assessed as having no fiscal impact. Changing the various dates and deadlines may cause some duties of county clerks and the Secretary of State to occur within shorter time frames, while other duties will have more time to be completed. Therefore, the bill is not expected to have any significant impact on overall election costs.
