Committee on Transportation.

After consideration on the merits, the Committee recommends the following:

HB11-1264 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 3, line 1, strike "C.R.S." and substitute "C.R.S.,
2 AND THE DRIVER IS REQUIRED TO BE LICENSED UNDER SECTION 42-2-103,
3 C.R.S., TO OPERATE THE VEHICLE."

4 Page 6, line 24, strike "(58)" and substitute "(55), (58)".

5 Page 6, after line 27 insert:

6 "(55) "Motorcycle" means a motor vehicle ~~that uses handlebars to~~
7 ~~steer and~~ that is designed to travel on not more than three wheels in
8 contact with the ground; except that the term does not include A
9 LOW-SPEED ELECTRIC VEHICLE, a farm tractor, or A low-power scooter."

10 Page 9, line 16, after "VEHICLE" insert "REGISTERED UNDER ARTICLE 3 OF
11 THIS TITLE"

12 Page 9, strike lines 20 through 22 and substitute:

13 "(2) (a) (I) ~~An operator~~ A DRIVER of a low-power scooter shall
14 possess a valid driver's license or minor driver's license.

15 (II) THE DRIVER OF AN OFF-HIGHWAY VEHICLE ON A HIGHWAY
16 SHALL POSSESS A VALID DRIVER'S LICENSE OR MINOR DRIVER'S LICENSE
17 UNLESS THE OFF-HIGHWAY VEHICLE MAY BE OPERATED ON A HIGHWAY
18 UNDER SECTION 33-14.5-108 (1), C.R.S."

1 Page 20, strike lines 14 through 27.

2 Renumber succeeding paragraphs accordingly.

3 Page 21, line 22, strike "STANDARDS." and substitute "STANDARDS FOR
4 OFF-HIGHWAY VEHICLES."

5 Page 25, line 8, strike "BUSINESSES." and substitute: "BUSINESSES OR
6 POWERSPORTS VEHICLES THAT ARE AT LEAST FIFTEEN YEARS OLD AND
7 THAT ARE SOLD FOR SALVAGE."

8 Page 27, strike line 8 and substitute:

9 "(2) A ~~paper copy~~ of PERSON SHALL USE a certificate of title
10 ~~shall~~".

11 Page 56, strike lines 23 through 27.

12 Strike page 57 and substitute:

13 "SECTION 66. **Effective date - applicability.** This act shall take
14 effect July 1, 2011, and shall apply to acts or applications occurring on or
15 after April 1, 2012.

16 SECTION 67. **Safety clause.** The general assembly hereby finds,
17 determines, and declares that this act is necessary for the immediate
18 preservation of the public peace, health, and safety."
