Staff has prepared amendment **J.001** (attached) to add provisions making cash fund appropriations to the Office of the Governor and the Department of Higher Education for FY 2011-12 and adjusting the cash fund appropriations that will be included in the FY 2011-12 Long Bill to the Office of the Governor and the Department of Local Affairs. The appropriations clause adjusts line items to reflect the new distribution of limited gaming revenue at the end of FY 2010-11 that is called for in S.B. 11-159.
