After consideration on the merits, the Committee recommends the following:

HB11-1163 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 2, line 10, strike "A" and substitute "AN
- 2 EXPANDABLE DUAL-LANE TRANSPORT".

- 3 Page 2, strike lines 16 through 18 and substitute "ISSUE A PERMIT TO A
- 4 PERSON WHO HAS BEEN HELD BY AN ADMINISTRATIVE LAW JUDGE TO HAVE
- 5 DISOBEYED PERMIT RESTRICTIONS OR TO HAVE VIOLATED THIS SECTION OR
- 6 RULES PROMULGATED UNDER THIS SECTION IN A HEARING HELD IN
- 7 ACCORDANCE WITH ARTICLE 4 OF TITLE 24, C.R.S."

- 8 Page 3, line 18, strike "LOWEST SIZE AND WEIGHT" and substitute
- 9 "SMALLEST DIMENSIONS".

- 10 Page 3, line 24, strike "UPON ENTERING" and substitute "AT THE NEAREST
- 11 POINT WHERE THE SHIPMENT ENTERS THE STATE, AT A LOCATION SPECIFIED
- 12 BY THE COLORADO STATE PATROL,".

- 13 Page 3, line 25, strike "COLORADO".

- 14 Page 4, strike line 8 and substitute "HOURS."

- 15 Page 4, strike lines 17 through 23 and substitute:

- 16 **"SECTION 2.** 42-4-510(11)(a)(IV), Colorado Revised Statutes,
- 17 is amended to read:

1 **42-4-510. Permits for excess size and weight and for**
2 **manufactured homes - rules - repeal.** (11) (a) The department of
3 transportation, the motor carrier services division of the department of
4 revenue, or the Colorado state patrol may charge permit applicants permit
5 fees as follows:
6 (IV) Special permits for structural, oversize, or overweight moves
7 requiring extraordinary action or moves involving weight in excess of two
8 hundred thousand pounds, one hundred twenty-five dollars for a permit
9 for a single trip, INCLUDING A SUPER-LOAD PERMIT ISSUED UNDER
10 SUBSECTION (1.7) OF THIS SECTION; EXCEPT THAT A SUPER-LOAD PERMIT
11 FEE IS FOUR HUNDRED DOLLARS;"
