**A BILL FOR AN ACT**

101 **CONCERNING HEALTH CARE PROFESSIONAL LOAN FORGIVENESS**  
102 **PROGRAMS ADMINISTERED BY THE PRIMARY CARE OFFICE IN**  
103 **THE DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT, AND**  
104 **MAKING AN APPROPRIATION THEREFOR.**

student loans. Additionally, the Colorado commission on higher education (commission) administers the nursing faculty fellowship program, which funds fellowships for persons employed in a nursing school teaching position.

The bill retains the authority of collegeinvest to administer remaining obligations under the current nursing teacher loan forgiveness program, eliminates the authority of collegeinvest to enter into any new loan repayment obligations under the nursing teacher loan forgiveness program, repeals the nursing faculty fellowship program, and expands the health professional loan repayment program, known as the Colorado health service corps, which is administered by the primary care office (office) in the department of public health and environment, to allow health care professional faculty members to obtain loan repayment through the Colorado health service corps.

The bill retains \$132,000 of the balance in the nursing teacher loan forgiveness fund for purposes of paying outstanding loan repayment obligations and transfers the remaining balance in the nursing teacher loan forgiveness fund to the general fund. Additionally, starting July 1, 2011, \$250,000 of the second tier of tobacco settlement moneys are annually allocated to the Colorado health service corps fund, and the current allocation to the short-term grants for innovative health program grant fund is reduced by a corresponding amount.

2 **SECTION 1.** 25-20.5-604 (1), Colorado Revised Statutes, is  
3 amended BY THE ADDITION OF A NEW PARAGRAPH to read:

4 **25-20.5-604. Primary care office - powers and duties.** (1) The  
5 primary care office shall have, at a minimum, the following powers and  
6 duties:

7 (g) TO ADMINISTER NURSING AND HEALTH CARE PROFESSIONAL  
8 FACULTY LOAN REPAYMENT PURSUANT TO PART 7 OF THIS ARTICLE.

9 **SECTION 2.** 25-20.5-701, Colorado Revised Statutes, is  
10 amended to read:

11 **25-20.5-701. Legislative declaration.** (1) The general assembly  
12 hereby finds that there are areas of Colorado that suffer from a lack of  
13 health care professionals to serve, AND A LACK OF NURSING OR OTHER

1 HEALTH CARE PROFESSIONAL FACULTY TO TRAIN HEALTH CARE  
2 PROFESSIONALS TO MEET, the medical needs of communities. The general  
3 assembly further finds that THE STATE NEEDS TO IMPLEMENT incentives  
4 ~~are needed~~ to encourage health care professionals to practice in these  
5 underserved areas AND TO ENCOURAGE NURSING FACULTY AND OTHER  
6 HEALTH CARE PROFESSIONAL FACULTY TO TEACH THESE HEALTH CARE  
7 PROFESSIONALS.

8 (2) It is therefore the intent of the general assembly in enacting  
9 this part 7 to create a state health service corps program that uses state  
10 ~~and~~ MONEYS, federal moneys, WHEN PERMISSIBLE, and contributions from  
11 communities and private sources to help repay the outstanding education  
12 loans that many health care professionals, NURSING FACULTY, AND  
13 HEALTH CARE PROFESSIONAL FACULTY hold. In exchange for repayment  
14 of ~~these~~ loans INCURRED FOR THE PURPOSE OF OBTAINING EDUCATION IN  
15 THEIR CHOSEN HEALTH CARE PROFESSIONS, the health care professionals  
16 will commit to provide health care services in communities with

25 (3.5) "HEALTH CARE PROFESSIONAL FACULTY MEMBER" MEANS A  
26 PERSON WHO HAS AN ADVANCED DEGREE IN A HEALTH CARE  
27 PROFESSIONAL FIELD AND IS EMPLOYED IN A QUALIFIED FACULTY

1 POSITION.

2 (6.5) "NURSING FACULTY MEMBER" MEANS A PERSON WHO HAS AN  
3 ADVANCED DEGREE IN NURSING AND IS EMPLOYED IN A QUALIFIED  
4 FACULTY POSITION.

5 (9) "QUALIFIED FACULTY POSITION" MEANS A PART-TIME OR  
6 FULL-TIME TEACHING POSITION AT AN EDUCATIONAL INSTITUTION WITH

17 primary care office shall maintain and administer, subject to available  
18 appropriations, the Colorado health service corps. Subject to available  
19 appropriations, the Colorado health service corps shall provide loan  
20 repayment for certain eligible health care professionals who provide  
21 primary health services. BEGINNING JULY 1, 2011, THE COLORADO

11 CARE PROFESSIONAL FACULTY MEMBER SHALL AGREE TO SERVE TWO OR  
12 MORE CONSECUTIVE ACADEMIC YEARS IN A QUALIFIED FACULTY POSITION.

13 (b) Repayment of loans under the Colorado health service corps  
14 may be made using moneys in the Colorado health service corps fund.  
15 The primary care office is authorized to receive and expend gifts, grants,  
16 and donations or moneys appropriated by the general assembly for the  
17 purpose of implementing the Colorado health service corps. In  
18 administering the Colorado health service corps, the primary care office  
19 shall collaborate with the university of Colorado health sciences center  
20 and other appropriate partners as needed to maximize the federal moneys  
21 available to the state for state loan repayment programs through the  
22 federal department of health and human services. The selection of health  
23 care professionals, NURSING FACULTY MEMBERS, AND HEALTH CARE  
24 PROFESSIONAL FACULTY MEMBERS for participation in the Colorado health  
25 service corps is exempt from the competitive bidding requirements of the  
26 "Procurement Code", articles 101 to 112 of title 24, C.R.S.

27 (d) (I) As a condition of receiving a loan repayment through the

1 Colorado health service corps, a health care professional shall enter into  
2 a contract pursuant to which the health care professional ~~shall agree~~  
3 AGREES to practice for at least two years in a community that is located  
4 in a federally designated health professional shortage area. The health  
5 care professional, the primary care office, and the community employer  
6 with which the health care professional is practicing shall be parties to the  
7 contract.

8 (II) AS A CONDITION OF RECEIVING A LOAN REPAYMENT THROUGH  
9 THE COLORADO HEALTH SERVICE CORPS, A NURSING FACULTY OR HEALTH  
10 CARE PROFESSIONAL FACULTY MEMBER SHALL ENTER INTO A CONTRACT  
11 PURSUANT TO WHICH HE OR SHE AGREES TO SERVE AT LEAST TWO  
12 CONSECUTIVE ACADEMIC YEARS OR THEIR EQUIVALENT IN A QUALIFIED  
13 FACULTY POSITION. THE NURSING FACULTY OR HEALTH CARE

14 INSTITUTION, INCLUDING ASSOCIATE, BACHELOR'S, MASTER'S, OR

1 of and interest on a qualified loan if the person is hired for a qualified  
2 position and stays in a qualified position for a period of not less than five  
3 consecutive academic years after the person earned an advanced degree  
4 in nursing. Repayment of loans through the program may be made using  
5 moneys in the nursing teacher loan forgiveness fund, created in paragraph  
6 (b) of this subsection (1), or moneys allocated to the program by  
7 collegeinvest. Collegeinvest is authorized to receive and expend gifts,  
8 grants, and donations or moneys appropriated by the general assembly for

10 DATE OF THIS SUBSECTION (1), AS AMENDED, COLLEGEINVEST SHALL NOT

14 loan forgiveness fund, which shall consist of all moneys appropriated by

11 **SECTION 14. Appropriation - adjustment in the 2011 long**  
12 **bill.** For the implementation of this act, appropriations made in the  
13 annual general appropriation act, from the general fund, to the department

15 aid, special purpose, for nursing teacher loan forgiveness pilot, for the
