A BILL FOR AN ACT

101 CONCERNING MEASURES TO INCREASE PHYSICAL ACTIVITY IN PUBLIC schools.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://www.leg.state.co.us/billsummaries.)

The bill directs each school district board of education and the state charter school institute to adopt a policy that incorporates a minimum number of minutes of physical activity each week into each elementary school student's schedule. Each school district and the state charter school institute must report to the department of education

Children's wellness - physical activity 5 **requirement - legislative declaration.** (1) (a) THE GENERAL ASSEMBLY 6 HEREBY FINDS THAT: 7 HEALTHY CHILDREN ARE MORE LIKELY TO BE ENGAGED 8 LEARNERS, THEY DO BETTER IN SCHOOL, THEY HAVE IMPROVED 9 ATTENDANCE, AND THEY ARE LESS LIKELY TO HAVE BEHAVIORAL 10 PROBLEMS INSIDE AND OUTSIDE OF THE CLASSROOM; 11 (II) MANY STUDIES HAVE DOCUMENTED THE LINK BETWEEN THE 12 MIND AND BODY AND THE EFFECT OF MOVEMENT ON COGNITION AND 13 STIMULATED BLOOD FLOW AND OXYGEN TO A CHILD'S BRAIN; 14 (III) STUDIES ALSO SHOW THAT PHYSICAL ACTIVITY IMPROVES 15 STUDENTS' ABILITY TO FOCUS AND DECREASES THE SYMPTOMS OF 16 ATTENTION DEFICIT DISORDER AND RELATED CONDITIONS; 17 (IV) STATISTICS SHOW THAT BOYS, USUALLY DUE TO THEIR HIGH 18 ENERGY LEVELS, ARE MORE LIKELY TO BE MISDIAGNOSED AS HAVING 19 ATTENTION DEFICIT HYPERACTIVITY DISORDER AND NEEDING SPECIAL 20 EDUCATION SERVICES.
