1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Repeal.** 22-81-204, Colorado Revised Statutes, is  
3 repealed.

4 **SECTION 2. Repeal.** 2-3-1203 (3) (x) (I), Colorado Revised  
5 Statutes, is repealed as follows:

6 **2-3-1203. Sunset review of advisory committees.** (3) The  
7 following dates are the dates for which the statutory authorization for the  
8 designated advisory committees is scheduled for repeal:

9 (x) July 1, 2011:

10 (I) ~~The science and technology education center grants advisory~~  
11 ~~board, created in section 22-81-204, C.R.S.;~~

12 **SECTION 3. Repeal.** 22-81-202 (1), Colorado Revised Statutes,  
13 is repealed as follows:

14 **22-81-202. Definitions.** As used in this part 2, unless the context  
15 otherwise requires:

16 (1) ~~"Advisory board" means the science and technology education~~  
17 ~~center grants advisory board created in section 22-81-204.~~

18 **SECTION 4.** 22-81-203 (2) (a), (3) (b), and (4) (b), Colorado  
19 Revised Statutes, are amended to read:

20 **22-81-203. Science and technology education center grant**  
21 **program - created - applications - awards.** (2) (a) Beginning on or  
22 before January 2, 2002, the state board ~~based on the recommendations of~~  
23 ~~the science and technology education center grants program advisory~~  
24 ~~board created in section 22-81-204,~~ shall, subject to available  
25 appropriations, annually award one or more science and technology  
26 education center grants for the development and operation of science and  
27 technology education centers.

1           (3) (b) ~~The advisory board may not recommend and the state~~  
2 board may not award a science and technology education center grant to  
3 any applicant that fails to provide the information specified in  
4 subparagraphs (II) and (III) of paragraph (b) of subsection (2) of this  
5 section.

6           (4) (b) The state board ~~based on recommendations of the advisory~~  
7 ~~committee~~, shall specify the amount to be awarded to each science and  
8 technology education center that is selected to receive a grant. The  
9 amount awarded to a new science and technology education center for  
10 start-up costs shall not exceed five hundred thousand dollars for one fiscal  
11 year and may not be renewed. The amount awarded to an operating  
12 science and technology education center for operating costs shall not  
13 exceed two hundred thousand dollars for one fiscal year.

14           **SECTION 5. Safety clause.** The general assembly hereby finds,  
15 determines, and declares that this act is necessary for the immediate  
16 preservation of the public peace, health, and safety.
