A BILL FOR AN ACT

101 CONCERNING CRUELTY TO SERVICE ANIMALS IN LAW ENFORCEMENT.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill specifically defines cruelty to a service animal being used by a peace officer or person with a disability (service animal) and requires that, in addition to any other penalty imposed, a person who is convicted of aggravated cruelty to a service animal shall make restitution for any veterinary bills and, if necessary, replacement costs of the service animal that are a result of the cruelty incident.

4 SECTION 4. Act subject to petition - effective date. This act 5 shall take effect at 12:01 a.m. on the day following the expiration of the 6 ninety-day period after final adjournment of the general assembly (August 7 10, 2011, if adjournment sine die is on May 11, 2011); except that, if a referendum petition is filed pursuant to section 1 (3) of article V of the 8 9 state constitution against this act or an item, section, or part of this act 10 within such period, then the act, item, section, or part shall not take effect 11 unless approved by the people at the general election to be held in November 2012 and shall take effect on the date of the official 12 13 declaration of the vote thereon by the governor.
