A BILL FOR AN ACT

101 **CONCERNING THE ELIMINATION OF THE LIMIT ON THE NUMBER OF**
102 **REGIONAL TOURISM PROJECTS THAT THE COLORADO ECONOMIC**
103 **DEVELOPMENT COMMISSION MAY APPROVE.**

Bill Summary

Current law limits the number of regional tourism projects that the Colorado economic development commission may approve to 2 initial projects plus 2 additional projects in each of the calendar years following the year in which the commission approves 2 initial projects. The bill

eliminates the limit and specifies that a pending application must be approved or disapproved before the commission may consider new applications submitted subject to new application submission requirements or new application review procedures.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **amend** 24-46-304 (2)
3 introductory portion as follows:

4 **24-46-304. Regional tourism project - application -**
5 **requirements.** (2) A local government shall submit an application for a
6 regional tourism project to the Colorado office of economic development
7 in a form and manner to be determined by the commission. ONCE THE
8 COMMISSION BEGINS TO REVIEW AN APPLICATION SUBMITTED IN THE
9 REQUIRED FORM AND MANNER, THE COMMISSION SHALL NOT DELAY,
10 RESTART, OR MATERIALLY ALTER ITS REVIEW OF THE APPLICATION DUE TO
11 SUBSEQUENT CHANGES IN APPLICATION SUBMISSION REQUIREMENTS OR
12 APPLICATION REVIEW PROCEDURES AND SHALL APPROVE OR DISAPPROVE
13 THE APPLICATION BEFORE REVIEWING ANY NEW APPLICATION SUBMITTED
14 SUBJECT TO THE NEW SUBMISSION REQUIREMENTS OR REVIEW
15 PROCEDURES. The office shall provide the commission with each
16 application received after the director's review pursuant to section
17 24-46-305. The application shall include, but need not be limited to, the
18 following:

19 **SECTION 2.** In Colorado Revised Statutes, 24-46-305, **amend**
20 (2) (b) as follows:

21 **24-46-305. Regional tourism project approval - director -**
22 **commission - review.** (2) (b) ~~(f)~~ The commission shall not approve more
23 than two initial projects pursuant to this subsection (2).

10 **SECTION 3. Safety clause.** The general assembly hereby finds,
11 determines, and declares that this act is necessary for the immediate
12 preservation of the public peace, health, and safety.
