After consideration on the merits, the Committee recommends the following:

HB12-1261 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend reengrossed bill, page 3, line 22, after "and" insert "**repeal**".
- 2 Page 3, line 27, strike "one thousand six hundred" and substitute "~~one~~
3 ~~thousand six hundred~~ FOUR THOUSAND EIGHT HUNDRED".
- 4 Page 4, strike lines 1 through 4 and substitute "who is employed to teach
5 in a school district, a program operated by a board of cooperative services
6 a charter school authorized by a school district pursuant to part 1 of
7 article 30.5 of this title, or a charter school authorized by the state charter
8 school institute pursuant to part 5 of article".
- 9 Page 4, line 5, strike "30.5 of this title," and substitute "~~30.5 of this title;~~
10 LOW-PERFORMING, HIGH-NEEDS SCHOOL".
- 11 Page 4, line 12, strike "one thousand" and substitute "~~one thousand~~ FOUR
12 THOUSAND EIGHT HUNDRED".
- 13 Page 4, line 13, strike "six hundred" and substitute "~~six hundred~~".
- 14 Page 4, strike lines 23 through 27 and substitute:
15 "(2) ~~Beginning with the 2009-10 school year and ending with the~~
16 ~~2011-12 school year, subject to available appropriations, an additional~~
17 ~~annual stipend of three thousand two hundred dollars shall be awarded to~~

1 ~~any teacher who meets the criteria set forth in subsection (1) of this~~
2 ~~section and who is employed as of May 1 in a given school year in a~~
3 ~~school that is required to implement a priority improvement or turnaround~~
4 ~~plan pursuant to section 22-11-405 or 22-11-406, respectively. Subject to~~
5 ~~available appropriations, a teacher shall continue to receive the additional~~
6 ~~stipend award pursuant to this subsection (2) if he or she remains~~
7 ~~employed in a school that was previously required to implement a priority~~
8 ~~improvement or turnaround plan but improves sufficiently to implement~~
9 ~~an improvement or performance plan pursuant to section 22-11-404 or~~
10 ~~22-11-403, respectively. The additional stipend for such teachers shall be~~
11 ~~subject to the same restrictions and requirements as set forth in subsection~~
12 ~~(1) of this section."~~
