A BILL FOR AN ACT

101 **CONCERNING LICENSURE OF ANESTHESIOLOGIST ASSISTANTS.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <http://www.leg.state.co.us/billsummaries>.)

The bill prohibits an individual from practicing as an anesthesiologist assistant without a license issued by the Colorado medical board (board), effective July 1, 2013. In order to be licensed as an anesthesiologist assistant, an applicant must be at least 21 years of age and have:

- ! Successfully completed an education program for anesthesiologist assistants that conforms to standards

- ! delineated by the commission on accreditation of allied health education programs and approved by the board;
- ! Successfully completed the national certifying examination for anesthesiologist assistants that is administered by the national commission for certification of anesthesiologist assistants; and
- ! Submitted an application to the board in the manner designated by the board and paid the appropriate fee established by the board.

The bill allows a physician who specializes in anesthesiology to delegate medical tasks to a licensed anesthesiologist assistant, including the authority to administer medications. The tasks are limited to the medical functions that constitute the delivery of or provision of anesthesia services as practiced by the supervising physician.

An anesthesiologist assistant is subject to the same standards for licensing, unprofessional conduct, and discipline that exist for physician assistants.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 12-36-102.5, **amend**
 3 (6) and (7) as follows:

4 **12-36-102.5. Definitions.** As used in this article, unless the
 5 context otherwise requires:

6 (6) "License" means the authority to practice medicine, ~~or~~ practice
 7 as a physician assistant, OR PRACTICE AS AN ANESTHESIOLOGIST
 8 ASSISTANT under this article.

9 (7) "Licensee" means any physician, ~~or~~ physician assistant, OR
 10 ANESTHESIOLOGIST ASSISTANT who is licensed pursuant to this article.

11 **SECTION 2.** In Colorado Revised Statutes, 12-36-104, **amend**
 12 (3) as follows:

13 **12-36-104. Powers and duties of board.** (3) To facilitate the
 14 licensure of qualified applicants and address the unlicensed practice of
 15 medicine, ~~and~~ the unlicensed practice as a physician assistant, AND THE
 16 UNLICENSED PRACTICE AS AN ANESTHESIOLOGIST ASSISTANT, the president

1 of the board shall establish a licensing panel in accordance with section
2 12-36-111.3 to perform licensing functions in accordance with this article
3 and review and resolve matters relating to the unlicensed practice of
4 medicine, ~~and~~ unlicensed practice as a physician assistant, AND
5 UNLICENSED PRACTICE AS AN ANESTHESIOLOGIST ASSISTANT. Two panel
6 members ~~shall~~ constitute a quorum of the panel. Any action taken by a
7 quorum of the panel ~~shall constitute~~ CONSTITUTES action by the board.

8 **SECTION 3.** In Colorado Revised Statutes, 12-36-106, **amend**
9 (2); and **add** (7) as follows:

10 **12-36-106. Practice of medicine defined - exemptions from**
11 **licensing requirements - unauthorized practice by physician**
12 **assistants and anesthesiologist assistants - penalties - rules.** (2) If a
13 person who does not possess and has not filed a license to practice
14 medicine, ~~or~~ practice as a physician assistant, OR PRACTICE AS AN
15 ANESTHESIOLOGIST ASSISTANT in this state, as provided in this article, and
16 who is not exempted from the licensing requirements under this article,
17 performs any of the acts that constitute the practice of medicine as
18 defined in this section, the person shall be deemed to be practicing
19 medicine, ~~or~~ practicing as a physician assistant, OR PRACTICING AS AN
20 ANESTHESIOLOGIST ASSISTANT in violation of this article.

21 (7) (a) A PHYSICIAN LICENSED IN THIS STATE THAT PRACTICES AS
22 AN ANESTHESIOLOGIST MAY DELEGATE TASKS CONSTITUTING THE
23 PRACTICE OF MEDICINE TO AN ANESTHESIOLOGIST ASSISTANT LICENSED
24 PURSUANT TO SECTION 12-36-107.3 WHO HAS BEEN EDUCATED AND
25 TRAINED IN ACCORDANCE WITH RULES PROMULGATED BY THE BOARD. THE
26 DELEGATED MEDICAL TASKS REFERRED TO IN THIS PARAGRAPH (a) ARE
27 LIMITED TO THE MEDICAL FUNCTIONS THAT CONSTITUTE THE DELIVERY OR

1 PROVISION OF ANESTHESIA SERVICES AS PRACTICED BY THE SUPERVISING
2 PHYSICIAN.

3 (b) AN ANESTHESIOLOGIST ASSISTANT SHALL PERFORM
4 DELEGATED MEDICAL TASKS ONLY UNDER THE DIRECT SUPERVISION OF A
5 PHYSICIAN WHO PRACTICES AS AN ANESTHESIOLOGIST. UNLESS APPROVED
6 BY THE BOARD, A SUPERVISING PHYSICIAN SHALL NOT CONCURRENTLY
7 SUPERVISE MORE THAN THREE ANESTHESIOLOGIST ASSISTANTS; EXCEPT
8 THAT THE BOARD MAY, BY RULE, ALLOW AN ANESTHESIOLOGIST TO
9 SUPERVISE UP TO FOUR ANESTHESIOLOGIST ASSISTANTS ON AND AFTER
10 JULY 1, 2016. DIRECT SUPERVISION OF ANESTHESIOLOGIST ASSISTANTS
11 MAY BE TRANSFERRED BETWEEN ANESTHESIOLOGISTS OF THE SAME GROUP
12 OR PRACTICE IN ACCORDANCE WITH GENERALLY ACCEPTED STANDARDS OF
13 CARE.

14 **SECTION 4.** In Colorado Revised Statutes, **add** 12-36-107.3 as
15 follows:

16 **12-36-107.3. Anesthesiologist assistant license - qualifications.**

17 (1) TO BE LICENSED AS AN ANESTHESIOLOGIST ASSISTANT UNDER THIS
18 ARTICLE, AN APPLICANT MUST BE AT LEAST TWENTY-ONE YEARS OF AGE
19 AND MUST HAVE:

20 (a) SUCCESSFULLY COMPLETED AN EDUCATION PROGRAM FOR
21 ANESTHESIOLOGIST ASSISTANTS THAT CONFORMS TO STANDARDS
22 DELINEATED BY THE COMMISSION ON ACCREDITATION OF ALLIED HEALTH
23 EDUCATION PROGRAMS, OR ITS SUCCESSOR ORGANIZATION, AND
24 APPROVED BY THE BOARD;

25 (b) SUCCESSFULLY COMPLETED THE NATIONAL CERTIFYING
26 EXAMINATION FOR ANESTHESIOLOGIST ASSISTANTS THAT IS ADMINISTERED
27 BY THE NATIONAL COMMISSION FOR CERTIFICATION OF ANESTHESIOLOGIST

1 ASSISTANTS OR A SUCCESSOR ORGANIZATION; AND

2 (c) SUBMITTED AN APPLICATION TO THE BOARD IN THE MANNER
3 DESIGNATED BY THE BOARD AND PAID THE APPROPRIATE FEE ESTABLISHED
4 BY THE BOARD PURSUANT TO SECTION 24-34-105, C.R.S.

5 (2) A PERSON APPLYING FOR A LICENSE TO PRACTICE AS AN
6 ANESTHESIOLOGIST ASSISTANT IN THIS STATE SHALL NOTIFY THE BOARD,
7 IN CONNECTION WITH HIS OR HER APPLICATION FOR LICENSURE, OF THE
8 COMMISSION OF ANY ACT THAT WOULD BE GROUNDS FOR DISCIPLINARY
9 ACTION AGAINST A LICENSED ANESTHESIOLOGIST ASSISTANT UNDER
10 SECTION 12-36-117, ALONG WITH AN EXPLANATION OF THE
11 CIRCUMSTANCES OF THE ACT. THE BOARD MAY DENY LICENSURE TO ANY
12 APPLICANT AS SET FORTH IN SECTION 12-36-116.

13 (3) A PERSON LICENSED TO PRACTICE AS AN ANESTHESIOLOGIST
14 ASSISTANT SHALL NOT PERFORM ANY ACT THAT CONSTITUTES THE
15 PRACTICE OF MEDICINE WITHIN A HOSPITAL OR AMBULATORY SURGICAL
16 CENTER LICENSED PURSUANT TO PART 1 OF ARTICLE 3 OF TITLE 25, C.R.S.,
17 OR REQUIRED TO OBTAIN A CERTIFICATE OF COMPLIANCE PURSUANT TO
18 SECTION 25-1.5-103 (1) (a) (II), C.R.S., UNLESS THE LICENSED
19 ANESTHESIOLOGIST ASSISTANT OBTAINS AUTHORIZATION FROM THE
20 GOVERNING BOARD OF THE HOSPITAL OR AMBULATORY SURGICAL CENTER.
21 THE GOVERNING BOARD OF A HOSPITAL OR AMBULATORY SURGICAL
22 CENTER MAY GRANT, DENY, OR LIMIT A LICENSED ANESTHESIOLOGIST
23 ASSISTANT'S AUTHORIZATION BASED ON THE GOVERNING BOARD'S
24 ESTABLISHED PROCEDURES.

25 (4) THE BOARD MAY TAKE ANY DISCIPLINARY ACTION WITH
26 RESPECT TO AN ANESTHESIOLOGIST ASSISTANT LICENSE AS IT MAY WITH
27 RESPECT TO THE LICENSE OF A PHYSICIAN, IN ACCORDANCE WITH SECTION

1 12-36-118.

2 (5) THE BOARD SHALL LICENSE AND KEEP A RECORD OF
3 ANESTHESIOLOGIST ASSISTANTS WHO HAVE BEEN LICENSED PURSUANT TO
4 THIS SECTION. A LICENSED ANESTHESIOLOGIST ASSISTANT SHALL RENEW
5 HIS OR HER LICENSE IN ACCORDANCE WITH SECTION 12-36-123.

6 (6) THIS SECTION TAKES EFFECT JULY 1, 2013.

7 **SECTION 5.** In Colorado Revised Statutes, 12-36-111.3, **amend**
8 (3) as follows:

9 **12-36-111.3. Licensing panel.** (3) The licensing panel shall
10 review and resolve matters relating to the unlicensed practice of
11 medicine. If it appears to the licensing panel, based upon credible
12 evidence in a written complaint by any person or upon credible evidence
13 in a motion of the licensing panel, that a person is practicing or has
14 practiced medicine, ~~OR PRACTICED~~ as a physician assistant, ~~OR PRACTICED~~
15 ~~AS AN ANESTHESIOLOGIST ASSISTANT~~ without a license as required by this
16 article, the licensing panel may issue an order to cease and desist the
17 unlicensed practice. The order ~~shall~~ MUST set forth the particular statutes
18 and rules that have been violated, the facts alleged to have constituted the
19 violation, and the requirement that all unlicensed practices immediately
20 cease. The respondent may request a hearing on a cease-and-desist order
21 in accordance with section 12-36-118 (14) (b). ~~The provisions of Section~~
22 ~~12-36-118 (10), exempting board disciplinary proceedings and records~~
23 ~~from open meetings and public records requirements, shall~~ DOES not
24 apply to a hearing or any other proceeding held by the licensing panel
25 pursuant to this subsection (3) regarding the unlicensed practice of
26 medicine. The procedures specified in section 12-36-118 (15), (16), (17),
27 and (18) ~~shall~~ apply to allegations and orders regarding the unlicensed

1 practice of medicine before the licensing panel.

2 **SECTION 6.** In Colorado Revised Statutes, 12-36-114.5, **amend**
3 (1) and (2) as follows:

4 **12-36-114.5. Reentry license.** (1) Notwithstanding any other
5 provision of this article, the board may issue a reentry license to a
6 physician, ~~or~~ physician assistant, OR ANESTHESIOLOGIST ASSISTANT who
7 has not actively practiced medicine, ~~or~~ practiced as a physician assistant,
8 OR PRACTICED AS AN ANESTHESIOLOGIST ASSISTANT, as applicable, for the
9 two-year period immediately preceding the filing of an application for a
10 reentry license, or who has not otherwise maintained continued
11 competency during such period, as determined by the board. The board
12 may charge a fee for a reentry license.

13 (2) (a) In order to qualify for a reentry license, the physician, ~~or~~
14 physician assistant, OR ANESTHESIOLOGIST ASSISTANT shall submit to
15 evaluations, assessments, and an educational program as required by the
16 board. The board may work with a private entity that specializes in
17 physician, ~~and~~ physician assistant, OR ANESTHESIOLOGIST ASSISTANT
18 assessment to:

19 (I) Determine the applicant's competency and areas in which
20 improvement is needed, if any;

21 (II) Develop an educational program specific to the applicant; and

22 (III) Upon completion of the educational program, conduct an
23 evaluation to determine the applicant's competency.

24 (b) (I) If, based on the assessment, the board determines that the
25 applicant requires a period of supervised practice, the board may issue a
26 reentry license, allowing the applicant to practice medicine, ~~or~~ PRACTICE
27 as a physician assistant, OR PRACTICE AS AN ANESTHESIOLOGIST

1 ASSISTANT, as applicable, under supervision as specified by the board.

2 (II) After satisfactory completion of the period of supervised
3 practice, as determined by the board, the reentry licensee may apply to the
4 board for conversion of the reentry license to a full license to practice
5 medicine, ~~or to practice as a physician assistant, OR PRACTICE AS AN~~
6 ANESTHESIOLOGIST ASSISTANT, as applicable, under this article.

7 (c) If, based on the assessment and after completion of an
8 educational program, if prescribed, the board determines that the
9 applicant is competent and qualified to practice medicine ~~or to practice~~
10 ~~as a physician assistant, as specified in this article,~~ without supervision OR
11 PRACTICE AS A PHYSICIAN ASSISTANT OR AS AN ANESTHESIOLOGIST
12 ASSISTANT WITH SUPERVISION AS SPECIFIED IN THIS ARTICLE, the board
13 may convert the reentry license to a full license to practice medicine, ~~or~~
14 ~~to practice as a physician assistant, OR PRACTICE AS AN~~
15 ANESTHESIOLOGIST ASSISTANT, as applicable, under this article.

16 **SECTION 7.** In Colorado Revised Statutes, 12-36-116, **amend**
17 (1) (c) and (1) (d) as follows:

18 **12-36-116. Refusal of license - issuance subject to probation.**

19 (1) The board may refrain from issuing a license or may grant a license
20 subject to terms of probation if the board determines that an applicant for
21 a license:

22 (c) Has been disciplined in another state or foreign jurisdiction
23 with respect to his or her license to practice medicine, ~~or~~ license to
24 practice as a physician assistant, OR LICENSE TO PRACTICE AS AN
25 ANESTHESIOLOGIST ASSISTANT; or

26 (d) Has not actively practiced medicine, ~~or~~ practiced as a
27 physician assistant, OR PRACTICED AS AN ANESTHESIOLOGIST ASSISTANT

1 for the two-year period immediately preceding the filing of such
2 application or otherwise maintained continued competency during such
3 period, as determined by the board.

4 **SECTION 8.** In Colorado Revised Statutes, 12-36-117, **amend**
5 (2) and (3) (b) as follows:

6 **12-36-117. Unprofessional conduct.** (2) The discipline of a
7 license to practice medicine, ~~or~~ of a license to practice as a physician
8 assistant, ~~OR OF A LICENSE TO PRACTICE AS AN ANESTHESIOLOGIST~~
9 ~~ASSISTANT~~ in another state, territory, or country shall be deemed to be
10 unprofessional conduct. For purposes of this subsection (2), "discipline"
11 includes any sanction required to be reported pursuant to 45 CFR 60.8.
12 This subsection (2) ~~shall apply~~ APPLIES only to discipline that is based
13 upon an act or omission in such other state, territory, or country that is
14 defined substantially the same as unprofessional conduct pursuant to
15 subsection (1) of this section.

16 (3) (b) Nothing in paragraph (a) of this subsection (3) ~~shall be~~
17 ~~construed to prevent~~ PREVENTS disciplinary action against a licensee for
18 practicing medicine, ~~or~~ practicing as a physician assistant, ~~OR PRACTICING~~
19 ~~AS AN ANESTHESIOLOGIST ASSISTANT~~ in violation of this article.

20 **SECTION 9.** In Colorado Revised Statutes, 12-36-118, **amend**
21 (5) (g) (III) introductory portion, (5) (g) (IV), (5) (i), and (8) as follows:

22 **12-36-118. Disciplinary action by board - immunity - rules.**
23 (5) (g) (III) If the hearings panel finds the charges proven and orders that
24 discipline be imposed, it shall also determine the extent of such
25 discipline, which ~~shall~~ MUST be in the form of a letter of admonition,
26 suspension for a definite or indefinite period, or revocation of license to
27 practice. The hearings panel also may impose a fine of up to five

1 thousand dollars per violation. In determining appropriate disciplinary
2 action, the hearings panel shall first consider sanctions that are necessary
3 to protect the public. Only after the panel has considered such sanctions
4 may it consider and order requirements designed to rehabilitate the
5 licensee or applicant. If discipline other than revocation of a license to
6 practice is imposed, the hearings panel may also order that the licensee be
7 granted probation and allowed to continue to practice during the period
8 of such probation. The hearings panel may also include in any
9 disciplinary order that allows the licensee to continue to practice such
10 conditions as the panel may deem appropriate to assure that the licensee
11 is physically, mentally, morally, and otherwise qualified to practice
12 medicine, ~~or~~ practice as a physician assistant, OR PRACTICE AS AN
13 ANESTHESIOLOGIST ASSISTANT in accordance with generally accepted
14 professional standards of practice, including any or all of the following:

15 (IV) Upon the failure of the licensee to comply with any
16 conditions imposed by the hearings panel pursuant to subparagraph (III)
17 of this paragraph (g), unless due to conditions beyond the licensee's
18 control, the hearings panel may order suspension of the licensee's license
19 to practice medicine, ~~or~~ practice as a physician assistant, OR PRACTICE AS
20 AN ANESTHESIOLOGIST ASSISTANT in this state until such time as the
21 licensee complies with such conditions.

22 (i) Any person whose license to practice medicine, ~~or~~ to practice
23 as a physician assistant, OR TO PRACTICE AS AN ANESTHESIOLOGIST
24 ASSISTANT is revoked or who surrenders his or her license to avoid
25 discipline ~~shall~~ IS not be eligible to apply for any license for two years
26 after the date the license is revoked or surrendered. The two-year waiting
27 period applies to any person whose license to practice medicine, to

1 practice as a physician assistant, TO PRACTICE AS AN ANESTHESIOLOGIST
2 ASSISTANT, or to practice any other health care occupation is revoked by
3 any other legally qualified board or regulatory entity.

4 (8) If any licensee is determined to be mentally incompetent or
5 insane by a court of competent jurisdiction and a court enters, pursuant to
6 part 3 or part 4 of article 14 of title 15 or section 27-65-109 (4) or
7 27-65-127, C.R.S., an order specifically finding that the mental
8 incompetency or insanity is of such a degree that the licensee is incapable
9 of continuing to practice medicine, ~~or practice as a physician assistant, OR~~
10 PRACTICE AS AN ANESTHESIOLOGIST ASSISTANT, THE BOARD SHALL
11 AUTOMATICALLY SUSPEND his or her license, ~~shall automatically be~~
12 ~~suspended by the board~~, and, anything in this article to the contrary
13 notwithstanding, such suspension ~~shall~~ MUST continue until the licensee
14 is found by such court to be competent to practice medicine, ~~or practice~~
15 as a physician assistant, OR PRACTICE AS AN ANESTHESIOLOGIST
16 ASSISTANT.

17 **SECTION 10.** In Colorado Revised Statutes, 12-36-118.5,
18 **amend** (1) and (2) (a) as follows:

19 **12-36-118.5. Confidential agreements to limit practice -**
20 **violation grounds for discipline.** (1) If a physician, ~~or physician~~
21 assistant, OR ANESTHESIOLOGIST ASSISTANT suffers from a physical or
22 mental illness or condition that renders the licensee unable to practice
23 medicine, ~~or practice as a physician assistant, OR PRACTICE AS AN~~
24 ANESTHESIOLOGIST ASSISTANT with reasonable skill and with safety to
25 patients, the physician, ~~or physician assistant, OR ANESTHESIOLOGIST~~
26 ASSISTANT shall notify the board of the illness or condition in a manner
27 and within a period determined by the board. The board may require the

1 licensee to submit to an examination or refer the licensee to a peer health
2 assistance program pursuant to section 12-36-123.5 to evaluate the extent
3 of the illness or condition and its impact on the licensee's ability to
4 practice with reasonable skill and with safety to patients.

5 (2) (a) Upon determining that a physician, ~~or~~ physician assistant,
6 OR ANESTHESIOLOGIST ASSISTANT with a physical or mental illness or
7 condition is able to render limited medical services with reasonable skill
8 and with safety to patients, the board may enter into a confidential
9 agreement with the physician, ~~or~~ physician assistant, OR
10 ANESTHESIOLOGIST ASSISTANT in which the physician, ~~or~~ physician
11 assistant, OR ANESTHESIOLOGIST ASSISTANT agrees to limit his or her
12 practice based on the restrictions imposed by the illness or condition, as
13 determined by the board.

14 **SECTION 11.** In Colorado Revised Statutes, 12-36-123.5,
15 **amend** (3.5) (b) (I) introductory portion, (3.5) (b) (I) (C), (3.5) (b) (II),
16 (3.5) (b) (III), (3.5) (c), (3.5) (e) introductory portion, (3.5) (e) (II), and
17 (5) as follows:

18 **12-36-123.5. Physicians', physician assistants', and**
19 **anesthesiologist assistants' peer health assistance program.**

20 (3.5) (b) (I) As a condition of physician, ~~and~~ physician assistant, AND
21 ANESTHESIOLOGIST ASSISTANT licensure and renewal in this state, every
22 applicant shall pay, pursuant to ~~paragraphs (d) and~~ PARAGRAPH (e) of this
23 subsection (3.5), an amount set by the board, not to exceed sixty-one
24 dollars per year, which maximum amount may be adjusted on January 1,
25 2011, and annually thereafter by the board to reflect:

26 (C) Differences in program utilization by physicians, ~~and~~
27 physician assistants, AND ANESTHESIOLOGIST ASSISTANTS.

1 (II) Based on differences in utilization rates between physicians,
2 ~~and~~ physician assistants, AND ANESTHESIOLOGIST ASSISTANTS, the board
3 may establish a different fee ~~amount~~ AMOUNTS for physicians, ~~than the~~
4 ~~amount—charged~~ physician assistants, AND ANESTHESIOLOGIST
5 ASSISTANTS.

6 (III) The fee imposed pursuant to this paragraph (b) ~~shall be used~~
7 IS to support designated providers that have been selected by the board to
8 provide assistance to physicians, ~~and~~ physician assistants, AND
9 ANESTHESIOLOGIST ASSISTANTS needing help in dealing with physical,
10 emotional, or psychological problems that may be detrimental to their
11 ability to practice medicine, PRACTICE AS A PHYSICIAN ASSISTANT, OR
12 PRACTICE AS AN ANESTHESIOLOGIST ASSISTANT, AS APPLICABLE.

13 (c) The board shall select one or more peer health assistance
14 programs as designated providers. To be eligible for designation by the
15 board, a peer health assistance program ~~shall~~ MUST:

16 (I) Provide for the education of physicians, ~~and~~ physician
17 assistants, AND ANESTHESIOLOGIST ASSISTANTS with respect to the
18 recognition and prevention of physical, emotional, and psychological
19 problems and provide for intervention when necessary or under
20 circumstances ~~which~~ THAT may be established by rules promulgated by
21 the board;

22 (II) Offer assistance to a physician, ~~or~~ physician assistant, OR
23 ANESTHESIOLOGIST ASSISTANT in identifying physical, emotional, or
