**Summary of Legislation**

**With strike below amendment L.001**, this bill allows public school officials discretion in suspensions and expulsions, where punishment is mandatory under current law. It also establishes the mechanism for data sharing between public schools, law enforcement and state agencies. The bill was recommended by the Task Force on School Discipline interim committee. Among many provisions, this bill:

- requires School Resource Officers (SROs) and law enforcement agencies to report data on student arrests and other disciplinary actions to the Division of Criminal Justice (DCJ) in the Department of Public Safety (DPS);
- requires the DCJ to compile and report information to the Colorado Commission on Criminal and Juvenile Justice;
- Requires the district attorney of each judicial district to annually report the number of offenses on school grounds;
- creates a training program for SROs; and
- modifies the safe school reporting requirements.

**State Revenue**

**In FY 2013-14, and each year thereafter, this bill is expected to increase revenue approximately \$2,500.** This bill requires DPS to conduct fee-based courses to train SROs. The fees are paid by the officers in the program, and are funded through the Peace Officers Safety and Training (P.O.S.T) Board cash fund. Because this program is optional, this analysis assumes approximately 20 of the state's 200 SROs will take the course each year. It is estimated that the training program will cost approximately \$2,500 to administer each year.

**Fee Impact on Individuals, Families or Business**

Section 2-2-322, C.R.S., requires legislative service agency review of measures which create or increase any fee collected by a state agency. Table 1 below identifies the fee impact of this bill.

**State Expenditures**

**In FY 2012-13, this bill has costs of \$192,174 and 2.5 FTE, in 2013-14, the costs are \$207,320 and 2.5 FTE.** These new expenditures are within the DPS and the Department of Law, and are described below in Table 2.

**Department of Public Safety (DPS).** No later than August 1, 2013, SROs and other law enforcement officers must report data on student behavior on school grounds to the DCJ. The reported information consists of SRO and law enforcement activity in schools, including offenses investigated. This requires the creation, population and maintenance of a new storage database, and collating disciplinary information from the state's 178 school districts, some of which do not have SROs. The DCJ will be responsible for receiving and organizing this data, making the data public, and forwarding the information to the Colorado Commission on Criminal and Juvenile Justice.

This bill also requires the Peace Officers Standards and Training (P.O.S.T.) Board in the Department of Law (DOL) to create new a curriculum for SROs, in which officers will have the option to participate. DPS will cooperate with DOL in shaping the curriculum, and will administer SRO training, which is offset by fees paid by each participating peace officer. These tasks, combined with the data sharing tasks mentioned above, will require 2.5 FTE in DPS for FY 2012-13 and 2013-14, as shown in Table 2. Workload is expected to decline thereafter after systems are normalized.

**Department of Law.** The department is responsible for the inspection and regulation of all basic and reserve peace officers. The SRO training curriculum may be developed with the assistance of national or state organizations, however the DOL will need to provide legal counsel and support in the development of this curriculum. This workload is expected to cost approximately \$40,000 in FY 2012-13 and \$70,000 in 2013-14, and will appropriated directly to the DOL.

### **Expenditures Not Included**

Pursuant to a Joint Budget Committee policy, certain costs associated with this bill are addressed through the annual budget process and centrally appropriated in the Long Bill or supplemental appropriations bills, rather than in this bill. The centrally appropriated costs subject to this policy are summarized in Table 3.

### **School District Impact**

This bill requires school districts to alter policies in a number of ways. It requires additional data collection as part of any school safety plan, and the use of new methods of discipline, including restorative justice. The bill further requires principals to notify parents when an SRO has notified him or her of a student's arrest or summons. New costs are contingent on the quality of data collections and communications currently occurring in school districts. Further, to the extent SROs are compensated by schools, which is not always the case, districts could see a rise in costs associated with SRO training.

Pursuant to Section 22-32-143, C.R.S., as specified by House Bill 11-1277, school districts and Boards of Cooperative Educational Services (BOCES) may submit estimates of fiscal impacts within seven days of a bill's introduction. As of the date of this fiscal note, no summaries of fiscal

**State Appropriations**

In FY 2012-13, this bill requires an appropriation of \$152,174, General Fund, and 2.5 FTE to the Department of Public Safety, and \$40,000, General Fund, to the Department of Law.
