6 (3.5) "EDUCATION MANAGEMENT PROVIDER" MEANS A NONPROFIT, 7 NOT-FOR-PROFIT, OR FOR-PROFIT ENTITY THAT CONTRACTS WITH A 8 CHARTER SCHOOL TO PROVIDE, MANAGE, OR OVERSEE ALL OR 9 SUBSTANTIALLY ALL OF THE EDUCATIONAL SERVICES PROVIDED BY THE 10 CHARTER SCHOOL.".

11 Renumber succeeding sections accordingly.

12 Page 2, line 4, after "(4)" insert "(a)".

Page 2, line 8, after "may" insert "THAT WAS INITIALLY CHARTERED ON OR
AFTER AUGUST 6, 1997,".

15 Page 2, after line 13 insert:

16 "(b) AN ENTITY THAT HOLDS A CHARTER AUTHORIZED PURSUANT
17 TO THIS PART 1 MAY CHOOSE TO CONTRACT WITH AN EDUCATION

9 (4.5) "EDUCATION MANAGEMENT PROVIDER" MEANS A NONPROFIT, 10 NOT-FOR-PROFIT, OR FOR-PROFIT ENTITY THAT CONTRACTS WITH AN 11 INSTITUTE CHARTER SCHOOL TO PROVIDE, MANAGE, OR OVERSEE ALL OR 12 SUBSTANTIALLY ALL OF THE EDUCATIONAL SERVICES PROVIDED BY THE 13 INSTITUTE CHARTER SCHOOL.".

14 Renumber succeeding sections accordingly.

"(b) AN ENTITY THAT HOLDS A CHARTER AUTHORIZED PURSUANT
TO THIS PART 5 MAY CHOOSE TO CONTRACT WITH AN EDUCATION
MANAGEMENT PROVIDER, WHICH EDUCATION MANAGEMENT PROVIDER
MAY BE A FOR-PROFIT, A NONPROFIT, OR A NOT-FOR-PROFIT ENTITY, SO
LONG AS THE INSTITUTE CHARTER SCHOOL MAINTAINS A GOVERNING
BOARD THAT IS INDEPENDENT OF THE EDUCATION MANAGEMENT
PROVIDER.".
