<u>HB12-1355</u> be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- Amend printed bill, page 2, line 7, strike "understanding conforming
   of statutes." and substitute "understanding report.".
- 3 Page 4, strike lines 12 through 15.
- 4 Renumber succeeding subsection accordingly.
- 5 Page 4, after line 24 insert:

"(7) (a) ON OR BEFORE JANUARY 31, 2013, AND IN ACCORDANCE 6 7 WITH THE PROVISIONS OF SECTION 24-1-136 (9), C.R.S., THE COLORADO 8 SCHOOL OF MINES SHALL REPORT TO THE JOINT BUDGET COMMITTEE. THE 9 AGRICULTURE, LIVESTOCK, AND NATURAL RESOURCES COMMITTEE OF THE 10 HOUSE OF REPRESENTATIVES, OR ITS SUCCESSOR COMMITTEE, AND THE 11 AGRICULTURE, NATURAL RESOURCES, AND ENERGY COMMITTEE OF THE 12 SENATE, OR ITS SUCCESSOR COMMITTEE, CONCERNING THE TRANSFER OF 13 THE GEOLOGICAL SURVEY AND THE OFFICE OF THE STATE GEOLOGIST TO 14 THE COLORADO SCHOOL OF MINES.

(b) AT A MINIMUM, THE REPORT SHALL INCLUDE INFORMATIONCONCERNING:

(I) WHETHER THE PRESIDENT OF THE COLORADO SCHOOL OF MINES
AND THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF NATURAL
RESOURCES ENTERED INTO A MEMORANDUM OF UNDERSTANDING
AFFIRMING THE TRANSFER OF THE COLORADO GEOLOGICAL SURVEY AND

"23-41-210. Annual report to general assembly - repeal. 8 9 (1) (a) ON OR BEFORE DECEMBER 1, 2013, AND EACH DECEMBER 1 10 THEREAFTER, AND IN ACCORDANCE WITH THE PROVISIONS OF SECTION 11 24-1-136 (9), C.R.S., THE COLORADO SCHOOL OF MINES SHALL SUBMIT A 12 WRITTEN REPORT TO THE JOINT BUDGET COMMITTEE, THE AGRICULTURE, 13 LIVESTOCK, AND NATURAL RESOURCES COMMITTEE OF THE HOUSE OF 14 REPRESENTATIVES, OR ITS SUCCESSOR COMMITTEE, AND THE 15 AGRICULTURE, NATURAL RESOURCES, AND ENERGY COMMITTEE OF THE 16 SENATE, OR ITS SUCCESSOR COMMITTEE, CONCERNING THE 17 IMPLEMENTATION OF THIS PART 2.

18 (b) AT A MINIMUM, THE ANNUAL REPORT SHALL INCLUDE19 INFORMATION CONCERNING:

(I) THE PRIORITY OF FUNCTIONS AND OBJECTIVES FOR THE
COLORADO GEOLOGICAL SURVEY, AS DETERMINED BY THE COLORADO
SCHOOL OF MINES, INCLUDING THE PRIORITY OF THOSE OBJECTIVES
DESCRIBED IN SECTION 23-41-205 (1) (a) TO (1) (m);

24 (II) THE IMPLEMENTATION OF THE OBJECTIVES OF THE AVALANCHE25 INFORMATION CENTER;

26 (III) THE SEVERANCE TAX MONEYS RECEIVED BY THE COLORADO
27 GEOLOGICAL SURVEY AND OTHER STATE FUNDING, AND THE SUFFICIENCY
28 OF THOSE MONEYS FOR THE IMPLEMENTATION OF THE FUNCTIONS AND
29 OBJECTIVES OF THE COLORADO GEOLOGICAL SURVEY;

30 (IV) ADDITIONAL FUNDING OR OTHER RESOURCES FROM ANY
31 OTHER SOURCE THAT ARE AVAILABLE TO CARRY OUT THE FUNCTIONS AND
32 OBJECTIVES OF THE COLORADO GEOLOGICAL SURVEY;

33 (V) THE NUMBER OF FULL-TIME-EQUIVALENT EMPLOYEES
34 DEDICATED TO THE IMPLEMENTATION OF THIS PART 2;

35 (VI) COLLABORATION WITH STATE AGENCIES, INDUSTRY,
36 ACADEMIC INSTITUTIONS, OR OTHER ENTITIES CONCERNING THE
37 IMPLEMENTATION OF THIS PART 2; AND

(VII) THE OBJECTIVES FOR THE COLORADO GEOLOGICAL SURVEY,
 THE OFFICE OF THE STATE GEOLOGIST, AND THE AVALANCHE INFORMATION
