After consideration on the merits, the Committee recommends the following:

SB12-155 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 5, line 11, after "DATE" insert "EITHER".
- 2 Page 5, line 14, strike "SECTION 1-10-105 (1)" and substitute "SECTION  
3 1-11-103, 1-11-104, 1-11-105,".
- 4 Page 5, line 15, strike "APPLICABLE." and substitute "APPLICABLE, OR BY  
5 WHICH ANY RECOUNT CONDUCTED IN ACCORDANCE WITH ARTICLE 10.5 OF  
6 TITLE 1, C.R.S., OR SECTION 31-10-1207, C.R.S., IS COMPLETED, AS  
7 APPLICABLE, WHICHEVER DATE IS LATER.".
- 8 Page 5, strike lines 16 through 27 and substitute:  
9 "(b) NOTWITHSTANDING ANY OTHER PROVISION OF THIS SECTION,  
10 THE DENIAL OF PUBLIC INSPECTION OF BALLOTS AUTHORIZED PURSUANT  
11 TO PARAGRAPH (a) OF THIS SUBSECTION (3) SHALL APPLY TO A RECOUNT  
12 THAT IS CONDUCTED IN ACCORDANCE WITH THE PROVISIONS OF ARTICLE  
13 10.5 OF TITLE 1, C.R.S., OR SECTION 31-10-1207, C.R.S., AS APPLICABLE;  
14 EXCEPT THAT, DURING THE PERIOD DESCRIBED IN PARAGRAPH (a) OF THIS  
15 SUBSECTION (3), AN INTERESTED PARTY MAY INSPECT AND REQUEST  
16 COPIES OF BALLOTS IN CONNECTION WITH SUCH RECOUNT WITHOUT  
17 HAVING TO OBTAIN A COURT ORDER GRANTING SUCH INSPECTION. IN  
18 CONNECTION WITH AN INSPECTION BY AN INTERESTED PARTY AS  
19 AUTHORIZED BY THIS PARAGRAPH (b), AN INTERESTED PARTY MAY".

1 Page 6, line 6, after "BALLOTS." add "EXCEPT AS SPECIFIED IN THIS  
2 PARAGRAPH (b), NOTHING IN THIS SECTION IS INTENDED NOR OTHERWISE  
3 SHALL BE CONSTRUED TO AFFECT THE CONDUCT OF A RECOUNT AS  
4 PROVIDED BY LAW OR THE RIGHTS OF AN INTERESTED PARTY IN  
5 CONNECTION WITH SUCH RECOUNT."
