<u>HB12-1254</u> be amended as follows, and as so amended, be referred to the Committee on <u>Appropriations</u> with favorable recommendation:

1 Amend printed bill, page 2, line 3, strike "(2) (a) (II) (A)" and substitute 2 "(2) (a) (II) (A); and add (2) (a.5)".

Page 2, line 4, strike "definitions." and substitute "definitions - notice of
funding through gifts, grants, and donations - repeal.".

5 Page 2, line 19, after "SERVICES" insert "AND INCLUDES TERRITORY".

6 Page 3, after line 2 insert:

7 "(a.5) (I) THE DIVISION IS AUTHORIZED TO SEEK AND ACCEPT 8 GIFTS, GRANTS, OR DONATIONS FROM PRIVATE OR PUBLIC SOURCES FOR 9 THE PURPOSES OF IMPLEMENTING THE AMENDMENT TO 10 SUB-SUBPARAGRAPH (A) OF SUBPARAGRAPH (II) OF PARAGRAPH (a) OF 11 THIS SUBSECTION (2) MADE BY HOUSE BILL 12-1254, ENACTED IN 2012; 12 EXCEPT THAT THE DIVISION MAY NOT ACCEPT A GIFT, GRANT, OR 13 DONATION THAT IS SUBJECT TO CONDITIONS THAT ARE INCONSISTENT WITH 14 SAID SUB-SUBPARAGRAPH (A) OR ANY OTHER LAW OF THE STATE. THE 15 DIVISION SHALL TRANSMIT ALL PRIVATE AND PUBLIC MONEYS RECEIVED 16 THROUGH GIFTS, GRANTS, OR DONATIONS TO THE STATE TREASURER, WHO 17 SHALL CREDIT THE SAME TO THE CONSERVATION TRUST FUND ALLOCATION 18 EXPENSE FUND, WHICH FUND IS HEREBY CREATED AND REFERRED TO IN 19 THIS PARAGRAPH (a.5) AS THE "FUND". THE MONEYS IN THE FUND ARE 20 SUBJECT TO ANNUAL APPROPRIATION BY THE GENERAL ASSEMBLY TO THE

1 DIVISION AND TO THE GOVERNOR'S OFFICE OF INFORMATION TECHNOLOGY 2 FOR THE DIRECT AND INDIRECT COSTS ASSOCIATED WITH IMPLEMENTING 3 THE AMENDMENT TO SUB-SUBPARAGRAPH (A) OF SUBPARAGRAPH (II) OF 4 PARAGRAPH (a) OF THIS SUBSECTION (2) MADE BY HOUSE BILL 12-1254, 5 ENACTED IN 2012. 6 (II) (A) IN SEEKING OR ACCEPTING A GIFT, GRANT, OR DONATION, 7 THE DIVISION SHALL NOTIFY THE LEGISLATIVE COUNCIL STAFF WHEN IT 8 HAS RECEIVED ADEQUATE FUNDING THROUGH GIFTS, GRANTS, OR 9 DONATIONS TO IMPLEMENT THE AMENDMENT TO SUB-SUBPARAGRAPH (A) 10 OF SUBPARAGRAPH (II) OF PARAGRAPH (a) OF THIS SUBSECTION (2) MADE 11 BY HOUSE BILL 12-1254, ENACTED IN 2012, AND SHALL INCLUDE IN THE 12 NOTIFICATION THE INFORMATION SPECIFIED IN SECTION 24-75-1303 (3), 13 C.R.S. 14 (III) THIS PARAGRAPH (a.5) IS REPEALED, EFFECTIVE JULY 1, 2015.". 15
