After consideration on the merits, the Committee recommends the following:

SB12-051 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 2, line 15, strike "SECTION, WHICH POLICY," and
- 2 substitute "SECTION, OTHER THAN CONTRACTS FOR INSTRUCTIONAL
- 3 SERVICES. A POLICY ADOPTED PURSUANT TO THIS SUBSECTION (2),".

- 4 Page 3, line 2, strike "INCLUDING AN".

- 5 Page 3, line 3, strike "EDUCATIONAL SERVICE,".

- 6 Page 3, line 19, strike "INCLUDING EDUCATIONAL SERVICE,".

- 7 Page 4, line 8, strike "INCLUDING EDUCATIONAL".

- 8 Page 4, line 9, strike "SERVICES,".

- 9 Page 6, strike line 15, and substitute "EDUCATION PROVIDER SHALL POST:
- 10 (I) THE NAME OR TITLE OF AND CONTACT INFORMATION FOR AN
- 11 EMPLOYEE OF THE LOCAL EDUCATION PROVIDER WHO IS AVAILABLE TO
- 12 ANSWER QUESTIONS CONCERNING CONTRACTS THAT EXCEED \$100,000
- 13 ENTERED INTO BY THE LOCAL EDUCATION PROVIDER; OR
- 14 (II) A COPY OF EACH CONTRACT THAT EXCEEDS \$100,000
- 15 ENTERED".

- 16 Page 6, line 16, strike "INCLUDING AN EDUCATIONAL SERVICE,".

1 Page 6, line 18, strike "22-32-122. THE" and substitute "22-32-122;
2 EXCEPT THAT THE LOCAL EDUCATION PROVIDER, PRIOR TO POSTING A
3 CONTRACT, MAY REDACT FROM THE CONTRACT ANY INFORMATION FOR
4 WHICH THE LOCAL EDUCATION PROVIDER MAY DENY INSPECTION UNDER
5 THE "COLORADO OPEN RECORDS ACT", PART 2 OF ARTICLE 72 OF TITLE
6 24, C.R.S. IF A".

7 Page 6, line 19, strike "SHALL POST EACH" and substitute "CHOOSES TO
8 POST A CONTRACT, IT SHALL POST THE".

9 Page 6, line 20, after the period, add "THE PROVISIONS OF THIS
10 PARAGRAPH (d) DO NOT APPLY TO CONTRACTS FOR INSTRUCTIONAL
11 SERVICES."
