After consideration on the merits, the Committee recommends the following:

SB12-068 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 3, line 19, strike "2012," and substitute "2013,"
2 and strike "SHALL" and substitute "OF A SCHOOL DISTRICT WITH A TOTAL
3 PUPIL ENROLLMENT OF ONE THOUSAND OR MORE STUDENTS SHALL NOT,
4 AND A PUBLIC SCHOOL OF A SCHOOL DISTRICT WITH A TOTAL PUPIL
5 ENROLLMENT OF FEWER THAN ONE THOUSAND STUDENTS IS ENCOURAGED
6 NOT TO:".

7 Page 3, strike line 20.

8 Page 4, strike lines 6 and 7 and substitute "EXISTING UPON SCHOOL
9 GROUNDS.".

10 Page 4, strike lines 9 through 11, and substitute "SECTION DOES NOT
11 APPLY TO:

12 (a) ANY FOOD OR BEVERAGE THAT IS MADE AVAILABLE TO A
13 STUDENT AS PART OF A MEAL PROGRAM OF THE UNITED STATES
14 DEPARTMENT OF AGRICULTURE;

15 (b) ANY FOOD OR BEVERAGE THAT IS MADE AVAILABLE TO A
16 STUDENT AS PART OF A FUNDRAISING EFFORT CONDUCTED BY ONE OR
17 MORE STUDENTS, TEACHERS, OR PARENTS; OR

18 (c) A SCHOOL OF A SCHOOL DISTRICT THAT DOES NOT HAVE A
19 COORDINATED, DISTRICT-WIDE FOOD SERVICE FOR THE PROVISION OF FOOD
20 TO STUDENTS AND IN WHICH SCHOOL LESS THAN ONE THOUSAND
21 STUDENTS ARE ENROLLED.".

- 1 Page 5, line 3, strike "2012," and substitute "2013,".
- 2 Page 5, strike lines 17 and 18 and substitute "EXISTING UPON SCHOOL
3 GROUNDS.".
- 4 Page 5, line 22, strike "AGRICULTURE." and substitute "AGRICULTURE OR
5 AS PART OF A FUNDRAISING EFFORT CONDUCTED BY ONE OR MORE
6 STUDENTS, TEACHERS, OR PARENTS.".
- 7 Page 6, line 2, strike "7, 2012," and substitute "8, 2012,".
