Bill Summary

Joint Budget Committee. Under current law, a board of cooperative services (BOCES) may authorize either a single-district or a multi-district on-line educational program. The bill permits a BOCES to authorize only a multi-district program.

11	SECTION 5. Safety clause. The general assembly hereby finds,
