Summary of Legislation

The bill provides for the technical recodification of the Colorado Revised Statutes (C.R.S.) over time. Beginning in 2012, the bill:

- directs the General Assembly's Committee on Legal Services (COLS) to identify from one to five statutory titles for thorough review and possible technical recodification;
- authorizes the COLS to direct the Office of Legislative Legal Services (OLLS) to conduct the review and to make appropriate technical recodification recommendations to the COLS for each title reviewed;
- permits the COLS to appoint a subcommittee from among its membership to study titles for recodification;
- permits the COLS to sponsor a bill during the next legislative session for each title for which changes and recodification are recommended;
- permits the COLS, the COLS subcommittee, and OLLS to solicit comments from affected state agencies, the Colorado Bar Association, the Judicial Branch, and other interested persons or organizations, to determine which titles to address and to identify changes to be made;
- requires the process to continue until all C.R.S. titles have been reviewed and recodified, if necessary.

Background

Colorado's statutes were universally recodified in 1953, 1963, and 1973. Under the supervision of the COLS, OLLS annually updates the state's laws. Since 1997, the official statutes have been published in a set of softbound volumes called the Colorado Revised Statutes (C.R.S.). The state's statutes are arranged according to code titles, articles, and sections under a numbering system. Currently, Colorado law contains 44 titles and a complete subject index. The COLS contracts with a publisher to print the C.R.S. All of the editorial work that goes into the annual compilation of updates is performed by OLLS staff.

State Expenditures

For FY 2012-13, General Fund expenditures in the Office of Legislative Legal Services will increase by \$177,951 and 3.6 FTE. For FY 2013-14 and future years, expenditures will increase by \$203,811 General Fund and 4.5 FTE. The fiscal note is based on the following assumptions:

- the COLS will appoint one subcommittee to develop recodification criteria and to select the titles to be reviewed;
- current revision conventions will be maintained, e.g., drafting conventions, numbering conventions, etc.;
- 3 titles will be selected for recodification each year; and
- work required by the bill requires the skills of existing experienced staff from affected subject area teams, meaning that the FTE identified above will be hired at the entry level to backfill for the current staff who will be reassigned during each review cycle.

In order to implement the bill, OLLS will hire one staff attorney and 3.5 legislative assistants. The first-year costs are prorated to reflect the August effective date and the General Fund pay date shift. Table 1 summarizes expenditures under the bill.

Other agency impacts. The bill has the potential to increase the workload of all branches of government. Entities whose governing titles are selected in a review cycle are expected to participate in the process by attending hearings and by complying with requests for information from the COLS or its subcommittee. The fiscal impact of this potential increase has not been estimated.

Expenditures Not Included

Pursuant to a Joint Budget Committee policy, certain costs associated with this bill are addressed through the annual budget process and centrally appropriated in the Long Bill or supplemental appropriations bills, rather than in this bill. The centrally appropriated costs subject to this policy are summarized in Table 2.

The bill has the potential to increase the workload of local governments during the COLS' review of applicable titles. Local governments will participate by attending meetings and responding to COLS's requests for information. The fiscal impact of this increase has not been estimated.

State Appropriations

The Office of Legislative Legal Services in the Legislative Branch requires an appropriation of \$171,976 General Fund and 3.6 FTE for FY 2012-13.
