### **Bill Summary**

**Joint Budget Commitee.** On June 30, 2012, the state treasurer is required to transfer up to \$4,000,000 to the Colorado economic development fund from the amount by which the June 2012 estimate of general fund revenue prepared by the office of state planning and budgeting (OSPB) for the 2011-12 fiscal year exceeds the March 2012 estimate of general fund revenue prepared by OSPB for the 2011-12 fiscal year.

1 *Be it enacted by the General Assembly of the State of Colorado:* 2 **SECTION 1.** In Colorado Revised Statutes, add 24-75-221 as 3 follows: 4 24-75-221. Transfer of general fund revenue to Colorado 5 economic development fund for 2011-12 fiscal year. 6 NOTWITHSTANDING ANY PROVISION OF LAW TO THE CONTRARY, ON JUNE 7 30, 2012, THE STATE TREASURER SHALL TRANSFER FROM THE GENERAL 8 FUND TO THE COLORADO ECONOMIC DEVELOPMENT FUND CREATED IN 9 SECTION 24-46-105 THE LESSER OF FOUR MILLION DOLLARS OR THE 10 AMOUNT BY WHICH THE JUNE 2012 ESTIMATE OF GENERAL FUND REVENUE 11 PREPARED BY THE OFFICE OF STATE PLANNING AND BUDGETING FOR THE 12 2011-12 FISCAL YEAR EXCEEDS THE MARCH 2012 ESTIMATE OF GENERAL 13 FUND REVENUE PREPARED BY THE OFFICE OF STATE PLANNING AND 14 BUDGETING FOR THE 2011-12 FISCAL YEAR. SECTION 2. 15 **Appropriation.** In addition to any other 16 appropriation, there is hereby appropriated, out of any moneys in the 17 Colorado economic development fund created in section 24-46-105 (1), 18 Colorado Revised Statutes, not otherwise appropriated, to the governor -19 lieutenant governor - state planning and budgeting, for the fiscal year 20 beginning July 1, 2012, the sum of \$4,000,000, or so much thereof as may

be necessary, for allocation to economic development programs,

economic development commission - general economic incentives and

marketing, for the provision of incentives to businesses related to the

implementation of this act.

SECTION 3. Safety clause. The general assembly hereby finds,

determines, and declares that this act is necessary for the immediate

preservation of the public peace, health, and safety.
