## A BILL FOR AN ACT

## Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://www.leg.state.co.us/billsummaries.)

The bill creates a special license plate to identify that an owner of a motor vehicle has received the distinguished flying cross. Current law
requires 2 one-time fees of $\$ 25$ in addition to the normal motor vehicle fees for the license plate. One of the fees is credited to the highway users tax fund and the other to the licensing services cash fund.

Be it enacted by the General Assembly of the State of Colorado:
SECTION 1. In Colorado Revised Statutes, 42-3-213, add (1) (a) (XXIII) and (24) as follows:

42-3-213. Special plates - military veterans - rules - retirement. (1) (a) The department shall issue one or more sets of special license plates to the following persons who own a truck that does not exceed sixteen thousand pounds empty weight, a passenger car, a motorcycle, or a noncommercial or recreational vehicle:
(XXIII) A RECIPIENT OF THE DISTINGUISHED FLYing CROSS.
(24) Recipient of a distinguished flying cross. (a) THE DEPARTMENT SHALL DESIGN A SPECIAL LICENSE PLATE TO INDICATE THAT THE OWNER OF A MOTOR VEHICLE TO WHICH THE LICENSE PLATE IS ATTACHED HAS RECEIVED THE DISTINGUISHED FLYING CROSS.
(b) A NATURAL PERSON WHO HAS BEEN AWARDED A DISTINGUISHED FLYING CROSS MAY USE A DISTINGUISHED FLYING CROSS SPECIAL LICENSE PLATE. WHEN APPLYING FOR THE LICENSE PLATE, THE APPLICANT SHALL SUBMIT TO THE DEPARTMENT A COPY OF THE MILITARY ORDER AWARDING THE DISTINGUISHED FLYING CROSS OR ANY OTHER EVIDENCE THE DEPARTMENT MAY ACCEPT.

SECTION 2. Appropriation. (1) In addition to any other appropriation, there is hereby appropriated, out of any moneys in the Colorado state titling and registration account of the highway users tax fund created in section 42-1-211 (2), Colorado Revised Statutes, not otherwise appropriated, to the department of revenue, for the fiscal year
beginning July 1,2012 , the sum of $\$ 2,960$, or so much thereof as may be necessary, to be allocated to the information technology division for the purchase of computer center services.
(2) In addition to any other appropriation, there is hereby appropriated to the governor - lieutenant governor - state planning and budgeting, for the fiscal year beginning July 1,2012 , the sum of $\$ 2,960$, or so much thereof as may be necessary, for allocation to the office of information technology, for the provision of computer center services for the department of revenue related to the implementation of this act. Said sum is from reappropriated funds received from the department of revenue out of the appropriation made in subsection (1) of this section.
(3) In addition to any other appropriation, there is hereby appropriated, out of any moneys in the license plate cash fund created in section 42-3-301 (1) (b), Colorado Revised Statutes, not otherwise appropriated, to the department of revenue, for the fiscal year beginning July 1, 2012, the sum of $\$ 436$, or so much thereof as may be necessary, for allocation to the division of motor vehicles, driver and vehicle services, for the purchase of special license plates related to the implementation of this act.

## SECTION 3. Act subject to petition - effective date -

 applicability. (1) This act takes effect at 12:01 a.m. on the day following the expiration of the ninety-day period after final adjournment of the general assembly (August 8, 2012, if adjournment sine die is on May 9, 2012); except that, if a referendum petition is filed pursuant to section 1 (3) of article $V$ of the state constitution against this act or an item, section, or part of this act within such period, then the act, item, section, or part will not take effect unless approved by the people at the general election1 to be held in November 2012 and, in such case, will take effect on the 2 date of the official declaration of the vote thereon by the governor.
