A BILL FOR AN ACT

101 **CONCERNING STATUTORILY ESTABLISHED TIME INTERVALS.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <http://www.leg.state.co.us/billsummaries>.)

Time intervals in current statutes relate to 10-day or monthly periods or multiples of those periods. The bill changes those periods to 7-day periods or periods that are multiples of 7 days to avoid actions being due on weekends.

Shading denotes HOUSE amendment. Double underlining denotes SENATE amendment.
*Capital letters indicate new material to be added to existing statute.
Dashes through the words indicate deletions from existing statute.*

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 13-1-129, **amend** (4)
3 as follows:

4 **13-1-129. Preferential trial dates.** (4) Upon the granting of a
5 motion for a preferential trial date, the court shall set the case for trial not
6 more than one hundred ~~twenty~~ NINETEEN days from the date the motion
7 was filed. The court shall establish an accelerated discovery schedule in
8 all such cases. No continuance shall be granted beyond the
9 ~~one-hundred-twenty-day~~ ONE-HUNDRED-NINETEEN-DAY period except for
10 physical or mental disability of a party or a party's attorney or upon a
11 showing of other good cause. Any such continuance shall be for no more
12 than one hundred ~~twenty~~ NINETEEN days, and only one such continuance
13 shall be granted to a party.

14 **SECTION 2.** In Colorado Revised Statutes, 13-4-110, **amend** (1)
15 (b) as follows:

16 **13-4-110. Determination of jurisdiction - transfer of cases.**
17 (1) (b) A party in interest shall allege that a case is not properly within
18 the jurisdiction of the court of appeals by motion filed with the court of
19 appeals within ~~twenty~~ TWENTY-ONE days after the date the record is filed
20 with the clerk of the court of appeals, failing which any objection to
21 jurisdiction by a party in interest shall be waived.

22 **SECTION 3.** In Colorado Revised Statutes, 13-6-311, **amend** (1),
23 (2), and (4) as follows:

24 **13-6-311. Appeals from county court - simplified procedure.**
25 (1) (a) If either party in a civil action believes that the judgment of the
26 county court is in error, he OR SHE may appeal to the district court by
27 filing notice of appeal in the county court within ~~fifteen~~ TWENTY-ONE

1 days after the date of entry of judgment and by filing within the said
2 ~~fifteen~~ TWENTY-ONE days an appeal bond with the clerk of the county
3 court. The bond shall be furnished by a corporate surety authorized and
4 licensed to do business in this state as surety, or one or more sufficient
5 private sureties, or may be a cash deposit by the appellant and, if the
6 appeal is taken by the plaintiff, shall be conditioned to pay the costs of the
7 appeal and the counterclaim, if any, and, if the appeal is taken by the
8 defendant, shall be conditioned to pay the costs and judgment if the
9 appealing party fails. The bond shall be approved by the judge or the
10 clerk.

11 (b) Upon filing of the notice of appeal, the posting and approval
12 of the bond, and the deposit by the appellant of an estimated fee in
13 advance for preparing the record, the county court shall discontinue all
14 further proceedings and recall any execution issued. The appellant shall
15 then docket his OR HER appeal in the district court. A motion for new trial
16 is not required as a condition of appeal. If a motion for new trial is made
17 within ~~fifteen~~ TWENTY-ONE days, the time for appeal shall be extended
18 until ~~fifteen~~ TWENTY-ONE days after disposition of the motion, but only
19 matters raised on the motion for new trial shall be considered on an
20 appeal thereafter.

21 (2) (a) Upon the deposit of the estimated record fee, the clerk of
22 the court shall prepare and issue as soon as possible a record of the
23 proceedings in the county court, including the summons, the complaint,
24 proof of service, and the judgment. The record shall also include a
25 transcription of such part of the actual evidence and other proceedings as
26 the parties may designate or, in lieu of transcription, to which they may
27 stipulate. If a stenographic record has been maintained or the parties agree

1 to stipulate, the party appealing shall lodge with the clerk of the court the
2 reporter's transcript of the designated evidence or proceedings or a
3 stipulation covering such items within ~~forty~~ FORTY-TWO days after
4 judgment. If the proceedings have been electrically recorded, the
5 transcription of designated evidence and proceedings shall be prepared in
6 the office of the clerk of the county court, either by him OR HER or under
7 his OR HER supervision, within ~~forty~~ FORTY-TWO days after judgment.

8 (b) The clerk shall notify, in writing, the opposing parties of the
9 completion of the record, and the parties have ~~fifteen~~ TWENTY-ONE days
10 within which to file objections. If none are received, the record shall be
11 certified forthwith by the judge. If objections are made, the parties shall
12 be called for hearing and the objections settled by the county judge as
13 soon as possible and the record then certified.

14 (4) A written brief setting out matters relied upon as constituting
15 error and outlining any arguments to be made shall be filed in the district
16 court by the appellant within ~~twenty~~ TWENTY-ONE days after filing of the
17 record therein. A copy of the brief shall be served on the appellee. The
18 appellee may file an answering brief within ~~twenty~~ TWENTY-ONE days
19 after such service. In the discretion of the district court, time for filing of
20 briefs and answers may be extended.

21 **SECTION 4.** In Colorado Revised Statutes, 13-10-114, **amend**
22 (4) and (5) as follows:

23 **13-10-114. Trial by jury.** (4) For the purposes of this section, a
24 defendant waives his OR HER right to a jury trial under subsection (1) of
25 this section unless, within ~~twenty~~ TWENTY-ONE days after entry of a plea,
26 the defendant makes a request to the court for a jury trial, in writing, and
27 tenders to the court a fee of twenty-five dollars, unless the fee is waived

1 by the judge because of the indigence of the defendant. If the action is
2 dismissed or the defendant is acquitted of the charge, or if the defendant
3 having paid the jury fee files with the court at least ~~ten~~ SEVEN days before
4 the scheduled trial date a written waiver of jury trial, the jury fee shall be
5 refunded.

6 (5) At the time of arraignment for any petty offense in this state,
7 the judge shall advise any defendant not represented by counsel of the
8 defendant's right to trial by jury; of the requirement that the defendant, if
9 he OR SHE desires to invoke his OR HER right to trial by jury, request such
10 trial by jury within ~~twenty~~ TWENTY-ONE days after entry of a plea, in
11 writing; of the number of jurors allowed by law; and of the requirement
12 that the defendant, if he OR SHE desires to invoke his OR HER right to trial
13 by jury, tender to the court within ~~twenty~~ TWENTY-ONE days after entry of
14 a plea a jury fee of twenty-five dollars, unless the fee is waived by the
15 judge because of the indigence of the defendant.

16 **SECTION 5.** In Colorado Revised Statutes, **amend** 13-10-117 as
17 follows:

18 **13-10-117. Time - docket fee - bond.** Appeals may be taken
19 within ~~ten~~ FOURTEEN days after entry of any judgment of a municipal
20 court. No appeal shall be allowed until the appellant has paid to the clerk
21 of the municipal court one dollar and fifty cents as a fee for preparing the
22 transcript of record on appeal. If the municipal court is a court of record,
23 the clerk of the municipal court is entitled to the same additional fees for
24 preparing the record, or portions thereof designated, as is the clerk of the
25 county court on the appeal of misdemeanors, but said fees shall be
26 refunded to the defendant if the judgment is set aside on appeal. No stay
27 of execution shall be granted until the appellant has executed an approved

1 bond as provided in sections 13-10-120 and 13-10-121.

2 **SECTION 6.** In Colorado Revised Statutes, **amend** 13-10-122 as
3 follows:

4 **13-10-122. Docket fee - dismissal.** The appellant shall pay a
5 docket fee as provided by law to the clerk of the appellate court, within
6 ~~ten~~ FOURTEEN days from the date he OR SHE ordered the transcript of
7 record. If he OR SHE does not do so, his OR HER appeal may be dismissed
8 on motion of the municipality.

9 **SECTION 7.** In Colorado Revised Statutes, 13-22-223, **amend**
10 (2) as follows:

11 **13-22-223. Vacating award.** (2) A motion made under this
12 section shall be filed within ~~ninety~~ NINETY-ONE days after the movant
13 receives notice of the award pursuant to section 13-22-219 or within
14 ~~ninety~~ NINETY-ONE days after the movant receives notice of a modified or
15 corrected award pursuant to section 13-22-220, unless the movant alleges
16 that the award was procured by corruption, fraud, or other undue means,
17 in which case the motion must be made within ~~ninety~~ NINETY-ONE days
18 after either the ground is known or by the exercise of reasonable care
19 should have been known by the movant.

20 **SECTION 8.** In Colorado Revised Statutes, 13-22-224, **amend**
21 (1) introductory portion as follows:

22 **13-22-224. Modification or correction of award.** (1) Upon
23 motion made within ~~ninety~~ NINETY-ONE days after the movant receives
24 notice of the award pursuant to section 13-22-219 or within ~~ninety~~
25 NINETY-ONE days after the movant receives notice of a modified or
26 corrected award pursuant to section 13-22-220, the court shall modify or
27 correct the award if:

1 **SECTION 9.** In Colorado Revised Statutes, 13-40-107, **amend**
2 (1) (a), (1) (b), and (1) (c) as follows:

3 **13-40-107. Notice to quit.** (1) A tenancy may be terminated by
4 notice in writing, served not less than the respective period fixed before
5 the end of the applicable tenancy, as follows:

6 (a) A tenancy for one year or longer, ~~three months~~ NINETY-ONE
7 DAYS;

8 (b) A tenancy of six months or longer but less than a year, ~~one~~
9 ~~month~~ TWENTY-EIGHT DAYS;

10 (c) A tenancy of one month or longer but less than six months, ~~ten~~
11 SEVEN days;

12 **SECTION 10.** In Colorado Revised Statutes, 13-40-111, **amend**
13 (1); and **repeal** (2) as follows:

14 **13-40-111. Issuance and return of summons.** (1) Upon filing
15 the complaint as provided in section 13-40-110, the clerk of the court or
16 the attorney for the plaintiff shall issue a summons. The summons shall
17 command the defendant to appear before the court at a place named in
18 such summons and at a time and on a day which shall be not less than ~~five~~
19 ~~business~~ SEVEN days nor more than ~~ten calendar~~ FOURTEEN days from the
20 day of issuing the same to answer the complaint of plaintiff. The
21 summons shall also contain a statement addressed to the defendant
22 stating: "If you fail to file with the court, at or before the time for
23 appearance specified in the summons, an answer to the complaint setting
24 forth the grounds upon which you base your claim for possession and
25 denying or admitting all of the material allegations of the complaint,
26 judgment by default may be taken against you for the possession of the
27 property described in the complaint, for the rent, if any, due or to become

1 due, for present and future damages and costs, and for any other relief to
2 which the plaintiff is entitled. If you are claiming that the landlord's
3 failure to repair the residential premises is a defense to the landlord's
4 allegation of nonpayment of rent, the court will require you to pay into the
5 registry of the court, at the time of filing your answer, the rent due less
6 any expenses you have incurred based upon the landlord's failure to repair
7 the residential premises."

8 (2) ~~For purposes of this section, "business days" means any~~
9 ~~calendar day excluding Saturdays, Sundays, and legal holidays.~~

10 **SECTION 11.** In Colorado Revised Statutes, 13-40-112, **amend**
11 (3) as follows:

12 **13-40-112. Service.** (3) Personal service or service by posting
13 shall be made at least ~~five-business~~ SEVEN days before the day for
14 appearance specified in such summons, and the time and manner of such
15 service shall be endorsed upon such summons by the person making
16 service thereof.

17 **SECTION 12.** In Colorado Revised Statutes, 13-40-115, **amend**
18 (3) as follows:

19 **13-40-115. Judgment - writ of restitution.** (3) A writ of
20 restitution that is issued by the court pursuant TO subsection (1) or (2) of
21 this section shall remain in effect for ~~forty-five~~ FORTY-NINE days after
22 issuance and shall automatically expire thereafter.

23 **SECTION 13.** In Colorado Revised Statutes, 13-51.5-103,
24 **amend** (1) as follows:

25 **13-51.5-103. Request for administrative record - certification**
26 **- time limits.** (1) Unless the court specifically orders otherwise upon a
27 showing of good cause for delay, a defendant governmental body or

1 officer shall file the record pursuant to rule 106 (a) (4) (III), C.R.C.P., or
2 any successor rule thereto within ~~thirty~~ THIRTY-FIVE days after the filing
3 of the complaint.

4 **SECTION 14.** In Colorado Revised Statutes, 13-54.5-102,
5 **amend** (2) as follows:

6 **13-54.5-102. Continuing garnishment - creation of lien.**

7 (2) Garnishment pursuant to subsection (1) of this section shall be a lien
8 and continuing levy against said earnings due for one hundred ~~eighty~~
9 EIGHTY-TWO days following service of the writ or for one hundred ~~eighty~~
10 EIGHTY-TWO days following the expiration of any writs with a priority
11 under section 13-54.5-104, but such lien shall be terminated earlier than
12 one hundred ~~eighty~~ EIGHTY-TWO days if earnings are no longer due, the
13 underlying judgment is vacated, modified, or satisfied in full, or the writ
14 is dismissed; except that a continuing garnishment may be suspended for
15 a specified period of time by the judgment creditor upon agreement with
16 the judgment debtor, which agreement shall be in writing and filed by the
17 judgment creditor with the clerk of the court in which the judgment was
18 entered and a copy of which shall be delivered by the judgment creditor
19 to the garnishee.

20 **SECTION 15.** In Colorado Revised Statutes, 13-54.5-107,
21 **amend** (2) as follows:

22 **13-54.5-107. Service of notice upon judgment debtor.** (2) In
23 cases where the judgment debtor's personal property, other than earnings,
24 is subject to garnishment, service of the notice of exemption and pending
25 levy required by section 13-54.5-106 shall be made by delivering a copy
26 of such notice to the judgment debtor personally or by leaving a copy of
27 such notice at the usual abode of the judgment debtor with some member

1 of his OR HER family over the age of eighteen years. In the event that
2 personal service cannot be made upon the judgment debtor, upon a
3 showing that due diligence has been used to obtain personal service, the
4 court shall order service of such notice of exemption and pending levy to
5 be made, in accordance with section 24-70-106, C.R.S., by publication
6 thereof for a period of ~~ten~~ FOURTEEN days in some newspaper of general
7 circulation published in the county in which said property was so levied
8 upon or, if there is no such newspaper published in such county, by
9 publication in a newspaper of general circulation in an adjoining county,
10 and the court shall order the clerk of the court in which the judgment was
11 entered to mail a copy of such notice to the judgment debtor at his OR HER
12 last-known address, postage prepaid. Such notice, with proof of service
13 thereof, and, in the case of publication, an affidavit of publication and an
14 affidavit of the mailing of notice shall be filed with the clerk of the court
15 in which the judgment was entered.

16 **SECTION 16.** In Colorado Revised Statutes, 13-54.5-108,
17 **amend** (1) and (3) as follows:

18 **13-54.5-108. Judgment debtor to file written objection or**
19 **claim of exemption.** (1) (a) In a case of continuing garnishment where
20 the judgment debtor objects to the calculation of the amount of exempt
21 earnings, the judgment debtor shall have ~~five~~ SEVEN days from receipt of
22 the copy of the writ of continuing garnishment required by section
23 13-54.5-105 within which to resolve the issue of such miscalculation, by
24 agreement with the garnishee, during which time the garnishee shall not
25 tender any moneys to the clerk of the court. If such objection is not
26 resolved within ~~five~~ SEVEN days and after good faith effort, the judgment
27 debtor may file a written objection with the clerk of the court in which the

1 judgment was entered setting forth with reasonable detail the grounds for
2 such objection. The judgment debtor shall, by certified mail, return
3 receipt requested, deliver immediately a copy of such objection to the
4 judgment creditor or his OR HER attorney of record.

5 (b) In a case where a garnishee, pursuant to a writ of garnishment,
6 holds any personal property of the judgment debtor other than earnings
7 which the judgment debtor claims to be exempt, said judgment debtor,
8 within ~~ten~~ FOURTEEN days after being served with the notice of exemption
9 and pending levy required by section 13-54.5-106, shall make and file
10 with the clerk of the court in which the judgment was entered a written
11 claim of exemption setting forth with reasonable detail a description of
12 the property claimed to be exempt, together with the grounds for such
13 exemption. The judgment debtor shall, by certified mail, return receipt
14 requested, deliver immediately a copy of such claim to the judgment
15 creditor or his OR HER attorney of record.

16 (3) Notwithstanding the provisions of subsection (1) of this
17 section, a judgment debtor failing to make a written objection or claim of
18 exemption may, at any time within ~~six months~~ ONE HUNDRED
19 EIGHTY-TWO DAYS from receipt of a copy of the writ of continuing
20 garnishment required by section 13-54.5-105 or from service of the notice
21 of exemption and pending levy required by section 13-54.5-106 and for
22 good cause shown, move the court in which the judgment was entered to
23 hear an objection or a claim of exemption as to any earnings or property
24 levied in garnishment, the amount of which the judgment debtor claims
25 to have been miscalculated or which the judgment debtor claims to be
26 exempt. Such hearing may be granted upon a showing of mistake,
27 accident, surprise, irregularity in proceedings, newly discovered evidence,

1 events not in the control of the judgment debtor, or such other grounds as
2 the court may allow.

3 **SECTION 17.** In Colorado Revised Statutes, 13-54.5-109,
4 **amend** (1) (a), (2), and (3) as follows:

5 **13-54.5-109. Hearing on objection or claim of exemption.**

6 (1) (a) Upon the filing of an objection pursuant to section 13-54.5-108
7 (1) (a) or the filing of a claim of exemption pursuant to section
8 13-54.5-108 (1) (b), the court in which the judgment was entered shall set
9 a time for the hearing of such objection or claim, which shall be not more
10 than ~~ten calendar~~ FOURTEEN days after filing. The clerk of the court where
11 such objection or claim is filed shall immediately inform the judgment
12 creditor or his OR HER attorney of record and the judgment debtor or his
13 OR HER attorney of record by telephone, by mail, or in person of the date
14 set for such hearing.

15 (2) Upon such hearing, the court shall summarily try and
16 determine whether the amount of the judgment debtor's exempt earnings
17 was correctly calculated by the garnishee or whether the property held by
18 the garnishee is exempt and shall enter an order or judgment setting forth
19 the determination of the court. If the amount of exempt earnings is found
20 to have been miscalculated or if said property is found to be exempt, the
21 court shall order the clerk of the court to remit the amount of
22 over-garnished earnings, or the garnishee to remit such exempt property,
23 to the judgment debtor within ~~three business~~ SEVEN days.

24 (3) Where the judgment debtor moves the court to hear an
25 objection or claim of exemption within the time provided by section
26 13-54.5-108 (3) and the judgment giving rise to such claim has been
27 satisfied against property or earnings of the judgment debtor, the court

1 shall hear and summarily try and determine whether the amount of the
2 judgment debtor's earnings paid to the judgment creditor was correctly
3 calculated and whether the judgment debtor's property sold in execution
4 was exempt and shall issue an order setting forth the determination of the
5 court. If such amount of earnings is found to have been miscalculated or
6 if such property is found to be exempt, the court shall order the judgment
7 creditor to remit the amount of the over-garnished earnings or such
8 exempt property or the value thereof to the judgment debtor within ~~three~~
9 ~~business~~ SEVEN days.

10 **SECTION 18.** In Colorado Revised Statutes, 13-54.5-110,
11 **amend** (2) as follows:

12 **13-54.5-110. No discharge from employment for any**
13 **garnishment - general prohibition.** (2) If an employer discharges an
14 employee in violation of the provisions of this section, the employee may,
15 within ~~ninety~~ NINETY-ONE days, bring a civil action for the recovery of
16 wages lost as a result of the violation and for an order requiring the
17 reinstatement of the employee. Damages recoverable shall be lost wages
18 not to exceed six weeks, costs, and reasonable attorney fees.

19 **SECTION 19.** In Colorado Revised Statutes, **amend** 13-55-101
20 as follows:

21 **13-55-101. Defendant to file written claim.** Except in cases of
22 garnishment pursuant to article 54.5 of this title, in cases where a sheriff
23 or other officer by virtue of a writ of execution, writ of attachment, or
24 other order of court issued by a court of record or clerk thereof levies
25 upon, seizes, or takes into his possession any property of the defendant
26 debtor, which said property, or part thereof, the defendant claims as
27 exempt under the provisions of the statutes of the state, said defendant

1 debtor, within ~~ten~~ FOURTEEN days after being served with notice of such
2 levy or seizure, shall make and file with the clerk of the court of record
3 out of which such writ of execution, writ of attachment, or other order
4 was issued a written claim of such exemption setting forth with
5 reasonable detail the description of the property so claimed to be exempt
6 together with the grounds of such claim of exemption.

7 **SECTION 20.** In Colorado Revised Statutes, **amend** 13-55-102
8 as follows:

9 **13-55-102. Service of notice of levy.** Notice of such levy or
10 seizure of any property under a writ of execution, writ of attachment, or
11 other order of court shall be served upon the defendant debtor by
12 delivering a copy of such notice to the defendant debtor personally or by
13 leaving a copy of such notice at the usual abode of the defendant debtor
14 with some member of his family over the age of fifteen years. In the event
15 the defendant is a nonresident, or absent from the state or conceals
16 himself OR HERSELF so personal service cannot be had upon him OR HER,
17 then service of such notice of levy or seizure shall be made by publication
18 thereof for a period of ~~ten~~ FOURTEEN days in some newspaper published
19 in the county in which said property was so levied upon or seized, or, if
20 there is no newspaper published in such county, then like publication
21 shall be made in a newspaper in an adjoining county, and the clerk of the
22 court of record shall mail a copy of such notice to the defendant debtor
23 directed to him OR HER at his OR HER last-known address, postage
24 prepaid. Such notice, with proof of service thereof and, in case of
25 publication, affidavit of publication and affidavit of mailing of notice
26 shall be filed with the clerk of the court of record from which such writ
27 of execution, writ of attachment, or other order of court was issued.

1 **SECTION 21.** In Colorado Revised Statutes, 13-55-104, **amend**
2 (1) as follows:

3 **13-55-104. Hearing on claim.** (1) Upon the filing of such claim
4 of exemption, the court of record shall set a time for the hearing of such
5 claim of exemption, which shall not be less than ~~five~~ SEVEN days nor
6 more than ~~fifteen~~ FOURTEEN days thereafter. A written notice of the time
7 and place of such hearing shall be given by the defendant or his OR HER
8 attorney to the officer who made such levy or seizure, and to the plaintiff
9 in said action or his OR HER attorney of record, by leaving a copy of such
10 notice with said officer or his deputy at his office and by leaving a copy
11 thereof with the plaintiff or his OR HER attorney of record, or notice may
12 be given to the plaintiff by mailing a copy of such notice of hearing to the
13 attorney of record of the plaintiff at least ~~five~~ SEVEN days in advance of
14 date set for the hearing.

15 **SECTION 22.** In Colorado Revised Statutes, **amend** 14-2-107 as
16 follows:

17 **14-2-107. When licenses to marry issued - validity.** Licenses
18 to marry shall be issued by the county clerk and recorder only during the
19 hours that the office of the county clerk and recorder is open as prescribed
20 by law and at no other time, and such licenses shall show the exact date
21 and hour of their issue. A license shall not be valid for use outside the
22 state of Colorado. Within the state, such licenses shall not be valid for
23 more than ~~thirty~~ THIRTY-FIVE days after the date of issue. If any license
24 to marry is not used within ~~thirty~~ THIRTY-FIVE days, it ~~shall be~~ IS void and
25 shall be returned to the county clerk and recorder for cancellation.

26 **SECTION 23.** In Colorado Revised Statutes, 14-2-109, **amend**
27 (1) as follows:

1 **14-2-109. Solemnization and registration.** (1) A marriage may
2 be solemnized by a judge of a court, by a court magistrate, by a retired
3 judge of a court, by a public official whose powers include solemnization
4 of marriages, by the parties to the marriage, or in accordance with any
5 mode of solemnization recognized by any religious denomination or
6 Indian nation or tribe. Either the person solemnizing the marriage or, if

16 late fee shall be assessed pursuant to this subsection (1), the date of
17 forwarding shall be deemed to be the date of postmark.

3 disallowed. If the personal representative fails to mail notice to a claimant

6 deemed to be allowed. After any claim has been deemed to be allowed or
7 disallowed, the personal representative may change the status of the
8 allowance or disallowance of the claim by notice to the claimant; except
9 that the personal representative may not change a disallowance of a claim
10 after the time for the claimant to file a petition for allowance or to
11 commence a proceeding on the claim has run and the claim has been
12 barred. Every claim that is disallowed in whole or in part by the personal
13 representative is barred so far as not allowed unless the claimant files a
14 petition for allowance in the court or commences a proceeding against the

16 mailing of the notice of disallowance or partial allowance if the notice
17 warns the claimant of the impending bar.

18 (4) Unless otherwise provided in any judgment in another court
19 entered against the personal representative, allowed claims bear interest
20 at the legal rate for the period commencing ~~sixty~~ SIXTY-THREE days after
21 the time for original presentation of the claim has expired unless based on
22 a contract making a provision for interest, in which case they bear interest
23 in accordance with that provision.

24 **SECTION 46.** In Colorado Revised Statutes, 15-12-1303, **amend**
25 (1) and (3) as follows:

26 **15-12-1303. Hearing - notice - service.** (1) The petitioner shall
27 prepare a notice of the filing of the petition which notice shall include the

3 termination of the conservatorship is set for hearing. Unless a hearing on

5 on the pleadings without a hearing after the time period for the filing of
6 the last responsive pleading has expired. After the filing of the
7 conservator's initial motion for instructions, the conservator may file
8 subsequent motions for instruction as appropriate.

27 that the judgment or a finding or conclusion is unsupported by the

1 evidence or is contrary to the evidence, the appellant shall include in the

20 and complaint or warrant, the separate complaint if any has been issued,

9 made at or near the time by, or from information transmitted by, a person
10 with knowledge; that the records were kept in the course of a regular

14 to the officer and may provide the original of the attestation to the officer

17 the records produced, without further necessity of extrinsic evidence.

18 (c) Upon the filing of a motion for an extension of time, the court

20 and the Colorado criminal investigator or peace officer named in the court
21 order agree to a later time. The court may grant an extension for a

4 time for appealing an order that exonerated the bail bond has expired. The
5 bonding agent shall also deliver to the property owner the original
6 cancelled note as evidence that the indebtedness secured by any lien

8 been fully satisfied and the original deed of trust, security agreement, or
9 other instrument which secured the bail bond obligation. If a timely notice
10 of appeal is filed, the ~~thirty-day~~ THIRTY-FIVE-DAY period shall begin on
11 the day the appellate court's affirmation of the order becomes final. If the
12 bonding agent fails to comply with the requirements of this subparagraph
13 (IV), the property owner may petition the district court to issue an order
14 directing the clerk of such court to execute a full reconveyance of title, a
15 certificate of discharge, or a full release of any lien against real property
16 created to secure performance of the conditions of the bail bond. The
17 petition shall be verified and shall allege facts showing that the bonding
18 agent has failed to comply with the provisions of this subparagraph (IV).

19 (b) If the bond is secured by real estate, the amount of the owner's
20 unencumbered equity shall be determined by deducting the amount of all
21 encumbrances listed in the owner and encumbrances certificate from the
22 actual value of such real estate as shown on the current notice of
23 valuation. The owner of the real estate shall file with the bond the
24 following, which shall constitute a material part of the bond:

25 (II) Evidence of title issued by a title insurance company or agent
26 licensed pursuant to article 11 of title 10, C.R.S., within ~~thirty~~
27 THIRTY-FIVE days ~~of~~ AFTER the date upon which the bond is filed; and

1 (c) (II) Upon satisfaction of the terms of the bond, the clerk of the
2 court shall, within ~~ten~~ FOURTEEN days ~~of~~ AFTER such satisfaction, execute
3 a release of the deed of trust and an affidavit which states that the
4 obligation for which the deed of trust had been recorded has been
5 satisfied, either fully or partially, and that the release of such deed of trust
6 may be recorded at the expense of the record owner of the property
7 described in such deed of trust.

9 bond by a defendant, the terms and conditions of said bond are changed
10 or altered either by order of court or upon the motion of the district
11 attorney or the defendant, the court, after a hearing, may order a
12 compensated surety to refund a portion of the premium paid by the
13 defendant, if necessary, to prevent unjust enrichment. If more than ~~ten~~
14 ~~working~~ FOURTEEN days have elapsed after posting of a bond by a
15 defendant, the court shall not order the refund of any premium.

16 **SECTION 64.** In Colorado Revised Statutes, 16-4-109, **amend**

18 **16-4-109. Disposition of security deposits upon forfeiture or**
19 **termination of bond.** (2) Where the defendant has been released upon
20 deposit of cash, stocks, bonds, or property or upon a surety bond secured

22 primary condition of the bond, the court shall declare a forfeiture. Notice
23 of the order of forfeiture shall be mailed by the court to the defendant, all
24 sureties, and all depositors or assignees of any deposits of cash or
25 property if such sureties, depositors, or assignees have direct contact with
26 the court, at their last known addresses. Such notice shall be sent within
27 ~~ten~~ FOURTEEN days after the entry of the order of forfeiture. If the

1 defendant does not appear and surrender to the court having jurisdiction
2 within ~~thirty~~ THIRTY-FIVE days from the date of the forfeiture or within
3 that period satisfy the court that appearance and surrender by the
4 defendant is impossible and without fault by such defendant, the court
5 may enter judgment for the state against the defendant for the amount of
6 the bail and costs of the court proceedings. Any cash deposits made with
7 the clerk of the court shall be applied to the payment of costs. If any
8 amount of such cash deposit remains after the payment of costs, it shall
9 be applied to payment of the judgment.

12 **16-4-110. Enforcement when forfeiture not set aside.** By
13 entering into a bond, each obligor, whether he OR SHE is the principal or
14 a surety, submits to the jurisdiction of the court. His OR HER liability
15 under the bond may be enforced, without the necessity of an independent
16 action, as follows: The court shall order the issuance of a citation directed
17 to the obligor to show cause, if any there be, why judgment should not be
18 entered against him OR HER forthwith and execution issue thereon. Said
19 citation may be served personally or by certified mail upon the obligor
20 directed to the address given in the bond. Hearing on the citation shall be
21 held not less than ~~twenty~~ TWENTY-ONE days after service. The defendant's
22 attorney and the prosecuting attorney shall be given notice of the hearing.
23 At the conclusion of the hearing, the court may enter a judgment for the
24 state and against the obligor, and execution shall issue thereon as on other
25 judgments. The district attorney shall have execution issued forthwith
26 upon the judgment and deliver it to the sheriff to be executed by levy
27 upon the stocks, bond, or real estate which has been accepted as security

1 for the bond.

11 and on the bail insurance company by regular mail within ~~ten~~ FOURTEEN
12 days after the entry of said forfeiture. If the compensated surety on the
13 bond is a cash bonding agent, only the cash bonding agent shall be
14 notified of the forfeiture. Service of notice of the bail forfeiture on the
15 defendant is not required.

16 (II) The notice described in subparagraph (I) of this paragraph (b)
17 shall include, but need not be limited to:

18 (B) An advisement that the compensated surety has the right to
19 request a show cause hearing pursuant to subparagraph (III) of this
20 paragraph (b) within ~~fifteen~~ FOURTEEN days after receipt of notice of
21 forfeiture, by procedures set by the court; and

22 (C) An advisement that if the compensated surety does not request
23 a show cause hearing pursuant to subparagraph (III) of this paragraph (b),
24 judgment shall be entered upon expiration of ~~thirty~~ THIRTY-FIVE days
25 following the entry of forfeiture.

26 (III) A compensated surety, upon whom notice of a bail forfeiture
27 order has been served, shall have ~~fifteen~~ FOURTEEN days after receipt of

1 notice of such forfeiture to request a hearing to show cause why judgment
2 on the forfeiture should not be entered for the state against the
3 compensated surety. Such request shall be granted by the court and a
4 hearing shall be set within ~~thirty~~ THIRTY-FIVE days after entry of forfeiture
5 or at the court's earliest convenience. At the conclusion of the hearing
6 requested by the compensated surety, if any, the court may enter judgment
7 for the state against the compensated surety, or the court may in its
8 discretion order further hearings. Upon expiration of ~~thirty~~ THIRTY-FIVE
9 days after the entry of forfeiture, the court shall enter judgment for the
10 state against the compensated surety if the compensated surety did not
11 request within ~~fifteen~~ FOURTEEN days after receipt of notice of such
12 forfeiture a hearing to show cause.

13 (IV) If such a show cause hearing was timely set but the hearing
14 did not occur within ~~thirty~~ THIRTY-FIVE days after the entry of forfeiture,
15 any entry of judgment at the conclusion of the hearing against the
16 compensated surety shall not be vacated on the grounds that the matter
17 was not timely heard. If judgment is entered against a compensated surety
18 upon the conclusion of a requested show cause hearing, and such hearing
19 did not occur within ~~thirty~~ THIRTY-FIVE days after the entry of forfeiture,
20 execution upon said judgment shall be automatically stayed for no more
21 than one hundred ~~twenty~~ TWENTY-SIX days after entry of forfeiture.

22 (V) (C) A compensated surety shall be exonerated from liability
23 upon the bond by satisfaction of the bail forfeiture judgment, surrender
24 of the defendant, or order of the court. If the surety provides proof to the
25 court that the defendant is in custody in any other jurisdiction within the
26 state, within ~~ninety~~ NINETY-ONE days after the entry of judgment, the
27 court shall on its own motion direct that the bail forfeiture judgment be

1 vacated and the bond exonerated; except that, if the court extradites the
2 defendant, all necessary and actual costs associated with the extradition
3 shall be borne by the surety up to the amount of the bond. If the court
4 elects to extradite the defendant, any judgment will be stayed until the
5 time the defendant appears in the court where the bond returns.

6 (c) Execution upon said bail forfeiture judgment shall be
7 automatically stayed for ~~ninety~~ NINETY-ONE days from the date of entry
8 of judgment; except that, if judgment is entered against a compensated
9 surety upon the conclusion of a requested show cause hearing, and such
10 hearing did not occur within ~~thirty~~ THIRTY-FIVE days after the entry of
11 forfeiture, the judgment shall be automatically stayed as set forth in
12 subparagraph (IV) of paragraph (b) of this subsection (5).

13 (f) If a bail forfeiture judgment remains unpaid for ~~thirty~~
14 THIRTY-FIVE days after the name of the bonding agent is placed on the
15 board, the court shall send notice by certified mail to the bail insurance
16 company for whom the bonding agent has executed the bond that if said
17 judgment is not paid within ~~fifteen~~ FOURTEEN days after the date of
18 mailing of said notice, the name of the bail insurance company shall be
19 placed on the board and such company shall be prohibited from executing
20 any further bail bonds in this state until the judgment giving rise to
21 placement on the board is satisfied, vacated, or otherwise discharged by
22 order of the court.

23 (i) A compensated surety shall be exonerated from liability upon
24 the bond by satisfaction of the bail forfeiture judgment, surrender of the
25 defendant, or by order of the court. If the defendant appears in court,
26 either voluntarily or in custody after surrender or arrest, within ~~ninety~~
27 NINETY-ONE days after the entry of judgment, the court, at the time the

1 defendant first appears in court, shall on its own motion direct that the
2 bail forfeiture judgment be vacated and the bond exonerated; except that,
3 if the state extradites such defendant, all necessary and actual costs
4 associated with such extradition shall be borne by the surety up to the
5 amount of the bond.

6 **SECTION 67.** In Colorado Revised Statutes, 16-4-204, **amend**
7 (2) as follows:

8 **16-4-204. Appellate review of terms and conditions of bail or**
9 **appeal bond.** (2) The petition shall be in writing, shall be served as
10 provided by court rule for service of motions, and shall have appended
11 thereto a transcript of the hearing held pursuant to section 16-4-107 or
12 16-4-203. The opposing party may file a response thereto within ~~five~~
13 SEVEN days or as provided by court rule.

14 **SECTION 68.** In Colorado Revised Statutes, **amend** 16-5-203 as
15 follows:

16 **16-5-203. Furnishing witnesses' names.** Whether a prosecution
17 is commenced by indictment, information, or felony complaint, the
18 district attorney shall make available to the defendant not later than
19 ~~twenty calendar~~ TWENTY-ONE days after the defendant's first appearance
20 at the time of or following the filing of charges a written list of the names
21 and addresses of the witnesses then known to the district attorney whom
22 he or she intends to call upon at trial. The district attorney shall also
23 furnish the defendant in writing prior to trial the names and addresses of
24 any additional witnesses who have become known to him or her prior to
25 trial and whom he or she intends to call upon at trial, but this shall not
26 preclude the calling of witnesses whose names or the materiality of whose
27 testimony are first learned by the district attorney upon the trial. However,

1 the court may, in its discretion, enter an order that denies the disclosure
2 to the defendant of the names and addresses of witnesses, or that requires
3 the defense counsel not to disclose such information to the defendant,
4 subject to rule 16 part I (d) (2) and part III (d) of the Colorado rules of
5 criminal procedure. The names and addresses of witnesses who are the
6 subject of the order may be withheld pending a ruling of the court, but the
7 prosecution shall notify the defense counsel in writing that a motion to
8 withhold witness information has been filed and that such information
9 will be withheld pending the court's order. Where the defendant has not
10 had or waived a preliminary hearing, there shall be filed with the
11 information the affidavit of some credible person verifying the
12 information upon the personal knowledge of the affiant that the offense
13 was committed.

14 **SECTION 69.** In Colorado Revised Statutes, 16-5-204, **amend**
15 (1) (b) as follows:

16 **16-5-204. Witnesses before a grand jury - procedure.** (1) (b) If
17 a witness has been confined in accordance with paragraph (a) of this
18 subsection (1), he OR SHE may, upon petition filed with the court, request
19 a hearing to be held within ~~ten~~ FOURTEEN days to review the contempt
20 order at which hearing he OR SHE shall have the right to be represented by
21 counsel. The court, at the hearing, may rescind, modify, or affirm the
22 order.

23 **SECTION 70.** In Colorado Revised Statutes, 16-5-205.5, **amend**
24 (3) as follows:

25 **16-5-205.5. Grand jury reports.** (3) Within ~~ten~~ FOURTEEN days

5 requested. Any responses shall be submitted to the prosecuting attorney

7 **SECTION 71.** In Colorado Revised Statutes, 16-5-206, **amend**
8 (3) as follows:

9 **16-5-206. Summons in lieu of warrant.** (3) A summons issued
10 under this section may be served in the same manner as the summons in
11 a civil action or by mailing it to the defendant's last-known address by
12 certified mail with return receipt requested not less than ~~five~~ SEVEN days
13 prior to the time the defendant is requested to appear. Service by mail is
14 complete upon the return of the receipt signed by the defendant.

15 **SECTION 72.** In Colorado Revised Statutes, **amend** 16-5-208 as
16 follows:

17 **16-5-208. Information not filed - reasons.** In all cases where on
18 preliminary hearing in the county court concerning the commission of a
19 felony the accused is bound over and is committed to jail, or recognized
20 and held to bail, it is the duty of the district attorney to file an information
21 in the district court. If the district attorney determines in any such case
22 that an information ought not to be filed, he OR SHE shall file with the
23 clerk of the district court having jurisdiction of the supposed offense a
24 written statement containing his OR HER reasons, in fact and in law, for
25 not filing an information in the case, and such statement shall be filed
26 within ~~sixty~~ SIXTY-THREE days following the date upon which the
27 offender was held for appearance.

1 **SECTION 73**. In Colorado Revised Statutes, **amend** 16-7-102 as
2 follows:

3 **16-7-102. Required notice of defense of alibi.** If the defendant
4 intends to introduce evidence that the defendant was at a place other than
5 the location of the offense, the defendant shall serve upon the prosecuting
6 attorney as soon as practicable, but not later than ~~thirty~~ THIRTY-FIVE days
7 before trial, a statement in writing specifying the place where the
8 defendant claims to have been and the names and addresses of the
9 witnesses the defendant will call to support the defense of alibi. Upon
10 receiving the defendant's statement, the prosecuting attorney shall advise
11 the defendant of the names and addresses of any additional witnesses who
12 may be called to refute such alibi as soon as practicable after the names
13 of such witnesses become known. Neither the prosecuting attorney nor
14 the defendant shall be permitted at the trial to introduce evidence
15 inconsistent with the specification statement unless the court for good
16 cause and upon just terms permits the specification statement to be
17 amended. If the defendant fails to make the specification required by this
18 section, the court shall exclude evidence offered in support of the defense
19 of alibi unless the court finds upon good cause shown that such evidence
20 should be admitted in the interest of justice.

21 **SECTION 74**. In Colorado Revised Statutes, 16-8-115, **amend**
22 (1) as follows:

23 **16-8-115. Release from commitment after verdict of not guilty**
24 **by reason of insanity or not guilty by reason of impaired mental**
25 **condition.** (1) The court may order a release hearing at any time on its
26 own motion, on motion of the prosecuting attorney, or on motion of the
27 defendant. The court shall order a release hearing upon receipt of the

1 report of the chief officer of the institution in which the defendant is
2 committed that the defendant no longer requires hospitalization, as
3 provided in section 16-8-116, or upon motion of the defendant made after
4 one hundred ~~eighty~~ EIGHTY-TWO days following the date of the initial
5 commitment order. Except for the first hearing following the initial
6 commitment order, unless the court for good cause shown permits, the
7 defendant is not entitled to a hearing within one year subsequent to a
8 previous hearing.

9 **SECTION 75.** In Colorado Revised Statutes, 16-8-115.5, **amend**
10 (5) and (8) as follows:

11 **16-8-115.5. Enforcement and revocation of conditional release**
12 **from commitment.** (5) The Colorado mental health institute at Pueblo
13 shall examine the defendant to evaluate the defendant's ability to remain
14 on conditional release. The examination shall be consistent with the
15 procedure provided in section 16-8-106. If the defendant refuses to
16 submit to and cooperate with the examination, the committing court shall
17 revoke the conditional release. The examination shall be completed
18 within ~~twenty~~ TWENTY-ONE days after the defendant has been delivered
19 to the institute as a result of the defendant's arrest. The institute shall mail
20 or deliver a written report of the examination to the committing court and
21 the district attorney in the committing jurisdiction promptly after the
22 examination is completed. The defendant may request an examination as
23 provided in section 16-8-108.

24 (8) Within ~~thirty~~ THIRTY-FIVE days after the defendant is delivered
25 to the Colorado mental health institute in Pueblo pursuant to subsection
26 (4) of this section, and if the defendant is not released from custody
27 pursuant to paragraph (b) of subsection (6) of this section, the committing

1 court shall hold a hearing on the petition for revocation of conditional
2 release. At such hearing, any evidence having probative value shall be
3 admissible, but the defendant shall be permitted to offer testimony and to
4 call, confront, and cross-examine witnesses. If the court finds by a
5 preponderance of the evidence that the defendant has become ineligible
6 to remain on conditional release as defined in section 16-8-102 (4.5), it
7 shall enter an order revoking the defendant's conditional release and
8 recommitting the defendant. At any time thereafter, the defendant may be
9 afforded a release hearing as provided in section 16-8-115. If the court
10 does not find by a preponderance of the evidence that the defendant has
11 become ineligible to remain on conditional release as defined in section
12 16-8-102 (4.5), it shall dismiss the petition and reinstate or modify the
13 original order of conditional release.

14 **SECTION 76.** In Colorado Revised Statutes, 16-8-116, **amend**
15 (2) as follows:

16 **16-8-116. Release by hospital authority.** (2) Within ~~thirty~~
17 THIRTY-FIVE days after receiving the report of the chief officer of the
18 institution having custody of the defendant, the court shall set a hearing
19 on the discharge of the defendant in accordance with section 16-8-115,
20 whether or not such report is contested.

21 **SECTION 77.** In Colorado Revised Statutes, 16-8-118, **amend**
22 (1) (a) and (1) (b) as follows:

23 **16-8-118. Temporary removal for treatment and**
24 **rehabilitation.** (1) The chief officer of the institution in which a
25 defendant has been committed under this article or article 8.5 of this title
26 may authorize treatment and rehabilitation activities involving temporary
27 physical removal of such person from the institution in which the

1 defendant has been placed, if prior to such authorization the following
2 procedures are carried out:

3 (a) Such chief officer shall give written notice by certified mail,
4 with return receipt requested, to the committing court and the district
5 attorney that on or after ~~thirty~~ THIRTY-FIVE days from the date of mailing
6 such notice he OR SHE will authorize treatment and rehabilitation activities
7 involving temporary physical removal of the defendant from the
8 institution, unless written objections to such authorization are received by
9 him OR HER within ~~thirty~~ THIRTY-FIVE days from the date of mailing such
10 notice.

11 (b) The clerk of the committing court shall deliver a copy of the
12 notice mentioned in paragraph (a) of this subsection (1) to the attorney of
13 record for the defendant. The district attorney or the attorney of record for
14 the defendant may file objections with the clerk of the committing court
15 to the proposed action of the chief officer of the institution in which such
16 defendant is held. A copy of any such objections shall be delivered by the
17 party making such objections, either by mail or by personal service, to
18 such chief officer prior to the expiration of ~~thirty~~ THIRTY-FIVE days from
19 the mailing of the notice by the chief officer of the institution.

20 **SECTION 78.** In Colorado Revised Statutes, 16-8.5-103, **amend**
21 (1), (3), (4), and (6) as follows:

22 **16-8.5-103. Determination of competency to proceed.**

23 (1) Whenever the question of a defendant's competency to proceed is

9 requested by the court, it shall be paid for by the court.

10 (6) If a party makes a timely request for a hearing, the hearing
11 shall be held within ~~thirty~~ THIRTY-FIVE days after the request for a hearing
12 or, if applicable, within ~~thirty~~ THIRTY-FIVE days after the filing of the
13 second evaluation report, unless the time is extended by the court after a
14 finding of good cause.

15 **SECTION 79.** In Colorado Revised Statutes, 16-8.5-113, **amend**
16 (2), (3), and (5) as follows:

17 **16-8.5-113. Restoration to competency.** (2) Within ~~ten~~
18 FOURTEEN days after receipt of a report from the department or other
19 court-approved provider of restoration services certifying that the
20 defendant is competent to proceed, either party may request a hearing or
21 a second evaluation. The court shall determine whether to allow the
22 second evaluation or proceed to a hearing on competency. If the second
23 evaluation is requested by the court or by an indigent defendant, it shall
24 be paid for by the court.

25 (3) If a second evaluation is allowed, any pending requests for a
26 hearing shall be continued until receipt of the second evaluation report.
27 The report of the expert conducting the second evaluation report shall be

1 completed and filed with the court within ~~sixty~~ SIXTY-THREE days after
2 the court order allowing the second evaluation, unless the time period is
3 extended by the court after a finding of good cause.

4 (5) If a party makes a timely request for a hearing, the hearing
5 shall be held within ~~thirty~~ THIRTY-FIVE days after the request for a hearing
6 or, if applicable, within ~~thirty~~ THIRTY-FIVE days after the filing of the
7 second evaluation report, unless the time is extended by the court after a
8 finding of good cause.

9 **SECTION 80.** In Colorado Revised Statutes, 16-10-109, **amend**
10 (2) and (3) as follows:

11 **16-10-109. Trial by jury for petty offenses.** (2) A defendant
12 charged with a petty offense shall be entitled to a jury trial if, within
13 ~~twenty~~ TWENTY-ONE days after entry of a plea, the defendant makes a
14 request to the court for a jury trial, in writing, and tenders to the court a
15 jury fee of twenty-five dollars unless the fee is waived by the judge
16 because of the indigence of the defendant. The jury shall consist of three
17 jurors unless a greater number, not to exceed six, is requested by the
18 defendant in said jury demand. If the charge is dismissed or the defendant
19 is acquitted of the charge or if the defendant, having paid the jury fee,
20 files with the court at least ~~ten~~ SEVEN days before the scheduled trial date
21 a written waiver of jury trial, the jury fee shall be refunded.

22 (3) At the time of arraignment for any petty offense in this state,
23 the judge shall advise any defendant not represented by counsel of the
24 defendant's right to trial by jury, of the requirement that the defendant, if
25 he OR SHE desires to invoke his OR HER right to trial by jury, request such
26 trial by jury within ~~twenty~~ TWENTY-ONE days after entry of a plea, in
27 writing, of the number of jurors allowed by law, and of the requirement

1 that the defendant, if he OR SHE desires to invoke his OR HER right to trial
2 by jury, tender to the court within ~~twenty~~ TWENTY-ONE days after entry of
3 a plea a jury fee of twenty-five dollars unless the fee is waived by the
4 judge because of the indigence of the defendant.

5 **SECTION 81.** In Colorado Revised Statutes, 16-10-402, **amend**
6 (1) (b) as follows:

7 **16-10-402. Use of closed-circuit television - child or**
8 **developmentally disabled witnesses.** (1) (b) To obtain an order
9 authorizing the use of closed-circuit television for testimony by a child or
10 developmentally disabled witness, the party shall file a written motion
11 with the court no less than ~~ten~~ FOURTEEN days prior to the trial.

12 **SECTION 82.** In Colorado Revised Statutes, 16-11-101.7,
13 **amend** (3) as follows:

14 **16-11-101.7. Repayment of crime stopper reward - crime**
15 **stopper reward reimbursement fund - created.** (3) All moneys
16 collected by the court pursuant to this section, together with transmittal
17 information which includes the court's docket number, the defendant's
18 name, and the crime stopper organization which is designated to receive
19 the repayment of reward, shall be promptly forwarded to the division of
20 criminal justice created by section 24-33.5-502, C.R.S. Upon receipt, the
21 division of criminal justice shall promptly transmit the moneys to the state
22 treasurer who shall deposit them in the crime stopper reward
23 reimbursement fund which is hereby created. Moneys in the fund shall be
24 continuously appropriated to the division of criminal justice for the
25 purposes of this section. The disbursement of any such moneys to the
26 designated crime stopper organization shall be made by the division of
27 criminal justice within ~~thirty~~ THIRTY-FIVE days after the date of deposit in

1 the crime stopper reward reimbursement fund.

2 **SECTION 83.** In Colorado Revised Statutes, 16-11-102.4,
3 **amend** (1) (a), (1) (d), (1) (e), (1) (f), (1) (g), and (1) (h) as follows:

4 **16-11-102.4. Genetic testing of convicted offenders.**

5 (1) Beginning July 1, 2007, each of the following convicted offenders
6 shall submit to and pay for collection and a chemical testing of the
7 offender's biological substance sample to determine the genetic markers
8 thereof, unless the offender has already provided a biological substance
9 sample for such testing pursuant to a statute of this state:

10 (a) Every offender who, on or after July 1, 2007, is in the custody
11 of the department of corrections based on a sentence imposed before that
12 date, including an offender on parole. The department shall collect the
13 sample at least ~~thirty~~ THIRTY-FIVE days prior to the offender's discharge
14 or release from custody, release on parole, or transfer to community
15 corrections placement.

16 (d) Every offender who, on or after July 1, 2007, is in a county jail
17 or a community corrections facility pursuant to article 27 of title 17,
18 C.R.S., based on a sentence imposed before that date for a felony
19 conviction. The sheriff or the community corrections program shall
20 collect the sample at least ~~thirty~~ THIRTY-FIVE days prior to the offender's
21 release from the custody of the county jail or community corrections
22 facility.

23 (e) Every offender who, on or after July 1, 2007, is in a county jail
24 or a community corrections facility based on a sentence imposed before
25 that date for conviction of a misdemeanor offense involving unlawful
26 sexual behavior or for which the factual basis involved an offense
27 involving unlawful sexual behavior. The sheriff or the community

1 corrections program shall collect the sample at least ~~thirty~~ THIRTY-FIVE
2 days prior to the offender's release from the custody of the county jail or
3 community corrections facility.

4 (f) Every offender who, on or after July 1, 2007, is in the custody
5 of the youthful offender system based on a sentence imposed before that
6 date, including an offender on community supervision. The department
7 of corrections shall collect the sample at least ~~thirty~~ THIRTY-FIVE days
8 prior to the offender's discharge or release from custody or release to
9 community supervision.

10 (g) Every offender sentenced on or after July 1, 2007, for a felony
11 conviction; except that this paragraph (g) shall not apply to an offender
12 granted a deferred judgment and sentencing as authorized in section
13 18-1.3-102, C.R.S., unless otherwise required to submit to a sample
14 pursuant to this section, or unless the deferred judgment and sentencing
15 is revoked and a sentence is imposed. The sample shall be collected:

16 (I) From an offender sentenced to the department of corrections,
17 by the department during the intake process but in any event within ~~thirty~~
18 THIRTY-FIVE days after the offender is received by the department;

19 (II) From an offender sentenced to county jail or community
20 corrections, by the sheriff or by the community corrections program
21 within ~~thirty~~ THIRTY-FIVE days after the offender is received into the
22 custody of the county jail or the community corrections facility;

23 (III) From an offender sentenced to probation, by the judicial
24 department within ~~thirty~~ THIRTY-FIVE days after the offender is placed on
25 probation;

26 (IV) From an offender sentenced to the youthful offender system,
27 by the department of corrections within ~~thirty~~ THIRTY-FIVE days after the

1 offender is received at the youthful offender system; and

2 (V) From an offender who receives any other sentence or who
3 receives a suspended sentence, by the judicial department within ~~thirty~~
4 THIRTY-FIVE days after the offender is sentenced or the sentence is
5 suspended.

6 (h) Every offender who, on or after July 1, 2007, is sentenced for
7 a conviction of, or who receives a deferred judgment and sentence for, an
8 offense involving unlawful sexual behavior or for which the underlying
9 factual basis involves unlawful sexual behavior. The sample shall be
10 collected:

11 (I) From an offender sentenced to county jail or community
12 corrections, by the sheriff or by the community corrections program
13 within ~~thirty~~ THIRTY-FIVE days after the offender is received into the
14 custody of the county jail or the community corrections facility;

15 (II) From an offender sentenced to probation, by the judicial
16 department or a probation department within ~~thirty~~ THIRTY-FIVE days after
17 the offender is placed on probation;

18 (III) From an offender who receives a deferred judgment and
19 sentence, by the judicial department or a probation department within
20 ~~thirty~~ THIRTY-FIVE days after the offender receives the deferred judgment

26 **SECTION 84.** In Colorado Revised Statutes, 16-11-205, **amend**
27 (4) introductory portion as follows:

1 **16-11-205. Arrest of probationer - revocation.** (4) Within ~~five~~
2 ~~working~~ SEVEN days after the arrest of any probationer as provided in this
3 section, or within a reasonable time after the issuance of a summons
4 under this section, the probation officer shall complete his OR HER
5 investigation and either:

6 **SECTION 85.** In Colorado Revised Statutes, 16-11-206, **amend**
7 (4) and (5) as follows:

8 **16-11-206. Revocation hearing.** (4) If the probationer is in
9 custody, the hearing shall be held within ~~fifteen~~ FOURTEEN days after the
10 filing of the complaint, unless delay or continuance is granted by the court
11 at the instance or request of the probationer or for other good cause found
12 by the court justifying further delay.

13 (5) If the court determines that a violation of a condition of
14 probation has been committed, it shall, within ~~five~~ SEVEN days after the
15 said hearing, either revoke or continue the probation. If probation is
16 revoked, the court may then impose any sentence or grant any probation
17 pursuant to the provisions of this part 2 which might originally have been
18 imposed or granted.

19 **SECTION 86.** In Colorado Revised Statutes, 16-12-204, **amend**
20 (1) as follows:

21 **16-12-204. Stay of execution - postconviction review.** (1) The
22 trial court, upon the imposition of a death sentence, shall set the time of

1 a copy of the judgment, sentence, and mittimus.

2 **SECTION 87.** In Colorado Revised Statutes, 16-12-209, **amend**
3 (2) as follows:

4 **16-12-209. Limitation on postconviction review.** (2) If the
5 defendant files a motion for postconviction review raising any of the
6 grounds specified in subsection (1) of this section, the motion shall be
7 filed with the trial court within ~~thirty~~ THIRTY-FIVE days after the date upon
8 which the grounds are discovered.

9 **SECTION 88.** In Colorado Revised Statutes, 16-13-307, **amend**
10 (3.5) and (13) as follows:

11 **16-13-307. Jurisdiction - venue - parties - process.** (3.5) An
12 action brought pursuant to this part 3 regarding a class 1 public nuisance
13 shall be filed within ~~sixty~~ SIXTY-THREE days following the seizure of the
14 property pursuant to section 16-13-315. The plaintiff may file the
15 complaint after the expiration of ~~sixty~~ SIXTY-THREE days from the date of
16 seizure only if the complaint is accompanied by a written petition for late
17 filing. Such petition for late filing shall demonstrate good cause for the
18 late filing of the complaint. The ~~sixty-day~~ SIXTY-THREE-DAY time
19 limitation established by this subsection (3.5) shall not apply where the
20 seizure of the property occurred pursuant to a warrant authorizing such
21 seizure or otherwise under any statute or rule of criminal procedure, if the
22 property is held as evidence in a pending criminal investigation or in a
23 pending criminal case.

24 (13) Unknown persons who may claim an interest in the property,
25 persons whose whereabouts are unknown despite a diligent good faith
26 search, and persons upon whom the plaintiff has been unable to effect
27 service as otherwise provided in the Colorado rules of civil procedure

1 despite diligent good faith efforts may be served pursuant to a court order
2 by publishing a copy of a summons twice in a newspaper of general
3 circulation. The summons shall describe the property and state where the
4 complaint and attendant documents may be obtained, and a party shall
5 have ~~thirty~~ THIRTY-FIVE days after the last publication date to respond.

6 **SECTION 89.** In Colorado Revised Statutes, 16-13-308, **amend**
7 (1) (f) as follows:

8 **16-13-308. Temporary restraining order - preliminary**
9 **injunction - when to issue.** (1) (f) Any person with an ownership
10 interest adversely affected by a temporary restraining order issued
11 pursuant to this subsection (1) may file a motion to vacate the temporary
12 restraining order. Such motion shall be filed within ~~ten~~ FOURTEEN days of
13 the time said person is served with or otherwise has notice of the
14 temporary restraining order. The motion shall be set for hearing within
15 ~~ten~~ FOURTEEN days after its filing. At said hearing, the court shall
16 determine whether the various provisions of the temporary restraining
17 order should remain in effect pending final determination of the action.
18 No part of the temporary restraining order shall be vacated unless the
19 proponent of the motion demonstrates that there is no probable cause to
20 believe that a public nuisance exists or that the public nuisance acts
21 underlying the action occurred, or that the proponent has a reasonable
22 likelihood of prevailing on the merits of the case with respect to the
23 temporary seizure or closure of the property. No issue regarding the
24 forfeiture of the property shall be raised at the hearing on the motion,
25 except the court may consider an innocent owner defense pursuant to
26 section 16-13-303 (5.2) by a proponent who has not been charged in a
27 parallel criminal action arising from the same activity giving rise to the

1 forfeiture proceedings. When the innocent owner defense is raised as
2 grounds for vacating the order, the issues at the hearing shall be limited
3 to modifying the order to provide for the use of the property during the
4 pendency of the action by an innocent owner, but only if such use is
5 consistent with preserving it for forfeiture as to any other interest. Such
6 a modifying order may include, without limitation, reasonable provisions
7 for the continued occupancy of a residence, or the operation of a business
8 and the sale or disposition of business inventory. However, no such
9 modifying order shall include the release of currency. The determination
10 of the facts by the court at the hearing is independent of and shall not be
11 considered in the determination of the same or similar facts in the
12 adjudication of any criminal charges arising out of the same occurrences.
13 Any motion to vacate a temporary restraining order shall state specifically
14 the factual and legal grounds upon which it is based, and only those
15 grounds may be considered at the hearing. Until vacated, the temporary
16 restraining order shall remain in full force and effect.

17 **SECTION 90.** In Colorado Revised Statutes, 16-13-311, **amend**
18 (3) (e), (3) (f), (3) (h), and (3.5) as follows:

19 **16-13-311. Disposition of seized personal property.**

20 (3) (e) Within ~~thirty~~ THIRTY-FIVE days after the date the order of
21 forfeiture is entered, the district attorney may submit a motion, an
22 affidavit, and any supporting documentation to the court to request
23 compensation consistent with this section. Within ~~thirty~~ THIRTY-FIVE days
24 after the date the order of forfeiture is entered, any victim of the criminal
25 act giving rise to the forfeiture may submit a request for compensation,
26 an affidavit, and supporting documentation to the district attorney to
27 request compensation from the forfeiture proceeds.

1 (f) Within ~~ten~~ FOURTEEN days after the date a seizing agency
2 notifies the court that all property forfeited has been sold and all proceeds
3 and money have been deposited in the registry of the court where the
4 forfeiture order was entered, the seizing agency may submit a motion, an
5 affidavit, and supporting documentation to the court for reimbursement
6 of expenses consistent with this section. In its motion, the seizing agency
7 shall identify any other seizing agencies that participated in the seizure
8 and specify the details of any intergovernmental agreement regarding
9 sharing of proceeds. The seizing agency shall send a copy of this motion
10 to the district attorney.

11 (h) Any party shall have ~~ten~~ FOURTEEN days after filing of the
12 proposed order to file any objections to the proposed order filed by the
13 district attorney.

14 (3.5) Instead of liens and encumbrances on real property being
15 satisfied from the proceeds of sale, real property may be sold subject to
16 all liens or encumbrances on record. The purchase of the property by the
17 successful bidder under this subsection (3.5) shall be conditioned on the
18 bidder satisfying and obtaining the release of the first and second priority
19 liens within ~~sixty~~ SIXTY-THREE days ~~of~~ AFTER the sale, or obtaining
20 written authorization from those lien holders for the bidder to receive the
21 sheriff's deed which shall be issued after such satisfaction or
22 authorization. The purchaser of the property shall take title free of any
23 lien, encumbrance, or cloud on the title recorded after title vests in the
24 state pursuant to section 16-13-316.

25 **SECTION 91.** In Colorado Revised Statutes, 16-13-505, **amend**
26 (2) (a), (2) (b), (2) (c), and (7) as follows:

27 **16-13-505. Forfeiture proceedings.** (2) (a) The prosecuting

1 attorney shall file a petition in forfeiture to perfect title in seized
2 contraband property no later than ~~sixty~~ SIXTY-THREE days after the
3 seizure. The prosecuting attorney may file the petition after the expiration
4 of ~~sixty~~ SIXTY-THREE days from the date of seizure only if the petition is
5 accompanied by a written statement of good cause for the late filing. The
6 ~~sixty-day~~ SIXTY-THREE-DAY time limitation established by this paragraph
7 (a) shall not apply where the seizure of the property occurred pursuant to
8 a warrant authorizing such seizure or otherwise under any statute or rule
9 of criminal procedure if the property is held as evidence in a pending
10 criminal investigation or in a pending criminal case. The petition shall be
11 accompanied by a supporting affidavit, and both shall describe the
12 property seized with reasonable particularity and shall include a list of
13 witnesses to be called in support of the claim for forfeiture, including the
14 addresses and telephone numbers thereof.

15 (b) If the court finds from the petition and supporting affidavit
16 that probable cause exists to believe that the seized property is contraband
17 property as defined in this part 5, it shall, without delay, issue a citation
18 directed to interested parties to show cause why the property should not
19 be forfeited. The citation shall fix the date and time for a first appearance
20 on the petition. The date fixed shall be no less than ~~thirty~~ THIRTY-FIVE
21 days and no more than ~~sixty~~ SIXTY-THREE days from the date of the
22 issuance of the citation.

23 (c) At the first appearance on the petition, the court shall set a date
24 and time for a hearing on the merits of the petition within ~~forty-five~~
25 FORTY-NINE days ~~of~~ AFTER the first appearance.

26 (7) If the seized property is of a type for which title or registration
27 is required by law, or if the owner of the property and his OR HER address

1 are known in fact, or if the seized property is subject to a perfected
2 security interest, the prosecuting attorney shall give notice of the
3 forfeiture action to the claimant, either by personal service of the petition,
4 supporting affidavit, and citation upon him OR HER or by sending copies
5 of such documents by certified mail, return receipt requested, to the
6 last-known address of such claimant. If the documents are properly
7 mailed to an address which the prosecutor has reasonable grounds to
8 believe is the last-known address of the potential claimant, said
9 documents shall be deemed served whether or not the claimant responds
10 to the notice to claim them at the post office. Unknown persons who may
11 claim any interest in the property, persons whose addresses are unknown,
12 and persons upon whom the prosecutor has been unable to effect service
13 as otherwise provided in this subsection (7) despite diligent good faith
14 efforts may be served pursuant to a court order by publishing a copy of
15 the citation twice in a newspaper of general circulation in the county in
16 which the proceeding is instituted. The fact of such publication shall be
17 conclusively established by the publisher's affidavit of publication. The
18 first publication shall be more than ~~ten~~ FOURTEEN days and the last
19 publication not less than ~~five~~ SEVEN days before the first appearance date
20 on the citation.

21 **SECTION 92.** In Colorado Revised Statutes, 16-14-104, **amend**
22 (1) as follows:

23 **16-14-104. Trial or dismissal.** (1) Within one hundred ~~eighty~~
24 EIGHTY-TWO days after the receipt of the request by the court and the
25 prosecuting official, or within such additional time as the court for good
26 cause shown in open court may grant, the prisoner or the prisoner's
27 counsel being present, the indictment, information, or criminal complaint

1 shall be brought to trial; but the parties may stipulate for a continuance or
2 a continuance may be granted on notice to the prisoner's attorney and
3 opportunity to be heard. If, after such a request, the indictment,
4 information, or criminal complaint is not brought to trial within that
5 period, no court of this state shall any longer have jurisdiction thereof, nor
6 shall the untried indictment, information, or criminal complaint be of any
7 further force or effect, and the court shall dismiss it with prejudice.

8 **SECTION 93.** In Colorado Revised Statutes, 16-15-102, **amend**
9 (6), (8) (d) introductory portion, (9), and (11) as follows:

10 **16-15-102. Ex parte order authorizing the interception of wire,**
11 **oral, or electronic communications.** (6) An order entered under this
12 section may not authorize or approve the interception of any wire, oral,
13 or electronic communication for any period longer than is necessary to
14 achieve the objective of the authorization nor in any event longer than
15 ~~thirty~~ THIRTY-FIVE days. Such ~~thirty-day~~ THIRTY-FIVE-DAY period begins
16 the first day on which the investigative or law enforcement officer begins
17 to conduct an interception under the order or ~~ten~~ FOURTEEN days after the
18 order is entered, whichever occurs earlier. An extension of an order may
19 be granted but only upon application for an extension made in accordance
20 with subsection (2) of this section and the court making the findings
21 required by subsection (4) of this section. The period of an extension shall
22 be no longer than the authorizing judge deems necessary to achieve the
23 purposes for which it was granted and in no event for longer than ~~thirty~~
24 THIRTY-FIVE days. Every order and each extension thereof shall contain
25 a provision that the authorization to intercept shall be executed as soon as
26 practicable, shall be conducted in such a way as to minimize the
27 interception under this section, and must terminate upon attainment of the

1 authorized objective, or in any event in ~~thirty~~ THIRTY-FIVE days. No more
2 than three extensions may be granted for any order entered under this
3 section. In the event that the intercepted communication is in a code or
4 foreign language and an expert in that foreign language or code is not
5 reasonably available during the interception period, minimization may be
6 accomplished as soon as practicable after such interception. An
7 interception made pursuant to this section may be conducted in whole or
8 in part by government personnel or by an individual operating pursuant
9 to a contract with the government and acting under the supervision of an
10 investigative or law enforcement officer authorized to conduct the
11 interception.

12 (8) (d) Within a reasonable time, but not later than ~~ninety~~
13 NINETY-ONE days after the filing of an application for an order of
14 approval under this section, which application is denied, or after the
15 termination of the period of an order or extensions thereof, the judge to
16 whom the application was presented shall cause to be served, on the
17 persons named in the order or the application, and such other parties to
18 intercepted communications as the judge may determine in his OR HER
19 discretion is in the interest of justice, notice of the following:

20 (9) The contents of any intercepted wire, oral, or electronic
21 communication or the evidence derived therefrom shall not be received
22 in evidence or otherwise disclosed in any trial, hearing, or other
23 proceeding in a state court, unless each party, not less than ~~ten~~ FOURTEEN
24 days before the trial, hearing, or proceeding, has been furnished with a
25 copy of the court order, and accompanying application, under which the
26 interception was authorized or approved. This ~~ten-day~~ FOURTEEN-DAY
27 period may be waived by the court if it finds that it was not possible to

1 furnish the party with the information ten days before the trial, hearing,
2 or proceeding and that the party will not be prejudiced by the delay in
3 receiving this information.

4 (11) In addition to any other right to appeal, the state of Colorado
5 has the right to appeal from an order granting a motion to suppress made
6 under subsection (10) of this section, or the denial of an application for
7 an order of approval, if the person making or authorizing the application
8 certifies to the judge granting the motion or denying an application that
9 the appeal is not taken for purposes of delay. Such appeal shall be taken
10 within ~~thirty~~ THIRTY-FIVE days after the date the order was entered and
11 shall be diligently prosecuted.

12 **SECTION 94.** In Colorado Revised Statutes, **amend** 16-17-102
13 as follows:

14 **16-17-102. Application - character certificate.** After a
15 conviction, all applications for commutation of sentence or pardon for
16 crimes committed shall be accompanied by a certificate of the respective
17 superintendent of the correctional facility, showing the conduct of an
18 applicant during his OR HER confinement in the correctional facility,
19 together with such evidences of former good character as the applicant
20 may be able to produce. Before the governor approves such application,
21 it shall be first submitted to the present district attorney of the district in
22 which the applicant was convicted and to the judge who sentenced and
23 the attorney who prosecuted at the trial of the applicant, if available, for
24 such comment as they may deem proper concerning the merits of the
25 application, so as to provide the governor with information upon which
26 to base his OR HER action. The governor shall make reasonable efforts to
27 locate the judge who sentenced and the attorney who prosecuted at the

1 trial of the applicant and shall afford them a reasonable time, not less than
2 ~~ten~~ FOURTEEN days, to comment on such applications. The requirements
3 of this section shall be deemed to have been met if the persons to whom
4 the application is submitted for comment do not comment within ~~ten~~
5 FOURTEEN days ~~of~~ AFTER their receipt of the application or within such
6 other reasonable time in excess of ~~ten~~ FOURTEEN days as specified by the
7 governor, or if the sentencing judge or prosecuting attorney cannot be
8 located, are incapacitated, or are otherwise unavailable for comment
9 despite the good-faith efforts of the governor to obtain their comments.
10 Good character previous to conviction, good conduct during confinement
11 in the correctional facility, the statements of the sentencing judge and the
12 district attorneys, if any, and any other material concerning the merits of
13 the application shall be given such weight as to the governor may seem
14 just and proper, in view of the circumstances of each particular case, a
15 due regard being had to the reformation of the accused. The governor
16 shall have sole discretion in evaluating said comments and in soliciting
17 other comments he OR SHE deems appropriate.

18 **SECTION 95.** In Colorado Revised Statutes, 16-18.5-104,
19 **amend** (5) (a) (II) (B), (5) (b) (II), and (5) (c) (II) as follows:

20 **16-18.5-104. Initial collections investigation - payment**
21 **schedule.** (5) Following the investigation required by subsection (3) of
22 this section, the collections investigator may also:

23 (a) (II) (B) Within ~~twenty~~ TWENTY-ONE days after the payment of
24 all such amounts of restitution, the collections investigator or the victim,
25 or the assignee of the state or the victim, shall record a certificate of
26 satisfaction of judgment issued by the clerk of the court with each clerk
27 and recorder where a transcript was recorded. The satisfaction of

1 judgment shall be conclusive evidence that the lien was extinguished.

2 (b) (II) The lien created by this paragraph (b), shall remain in
3 effect without the necessity of renewal for twelve years or until all
4 amounts of restitution, including interest, costs, time payment fees, and
5 late fees are paid. Within ~~twenty~~ TWENTY-ONE days after the payment of
6 all such amounts of restitution, the collections investigator or the victim,
7 or the assignee of the state or the victim, shall file a satisfaction of
8 judgment with the secretary of state. The satisfaction of judgment shall
9 be conclusive evidence that the lien was extinguished.

10 (c) (II) The lien created by this paragraph (c), shall remain in
11 effect for the same period of time as any other lien on motor vehicles as
12 specified in section 42-6-127, C.R.S., or until all amounts of restitution,
13 including interest, costs, time payment fees, and late fees are paid,
14 whichever occurs first. A lien created pursuant to this paragraph (c) may
15 be renewed pursuant to section 42-6-127, C.R.S. Within ~~twenty~~
16 TWENTY-ONE days after the payment of all such amounts of restitution,
17 the collections investigator or the victim or the assignee of the state or the
18 victim shall release the lien pursuant to the procedures specified in
19 section 42-6-125, C.R.S. When a lien created by this paragraph (c) is
20 released, the authorized agent and the executive director of the
21 department of revenue shall proceed as provided in section 42-6-126,
22 C.R.S.

23 **SECTION 96.** In Colorado Revised Statutes, 16-18.5-105,
24 **amend** (2) and (3) introductory portion as follows:

25 **16-18.5-105. Monitoring - default - penalties.** (2) In addition to
26 any other costs that may accrue, for each payment of restitution that a
27 defendant fails to make within ~~five~~ SEVEN days after the date that the

1 payment is due pursuant to any payment schedule established pursuant to
2 this article, the late penalty fee established in section 16-11-101.6 shall
3 be assessed, and the associated provisions of section 16-11-101.6 may
4 apply. The late fees shall be collected from the defendant after the
5 defendant has satisfied all orders for restitution. All payments for late fees
6 shall be credited to the judicial collection enhancement fund created in
7 section 16-11-101.6 (2).

8 (3) Whenever a defendant fails to make a payment of restitution
9 within ~~five~~ SEVEN days after the date that the payment is due pursuant to
10 a payment schedule established pursuant to this article, in addition to any
11 other remedy, the collections investigator may:

12 **SECTION 97.** In Colorado Revised Statutes, **amend** 16-19-116
13 as follows:

14 **16-19-116. Commitment to await requisition - bail.** If from the
15 examination before the judge it appears that the person held is the person
16 charged with having committed the crime alleged and, except in cases
17 arising under section 16-19-107, that he OR SHE has fled from justice, the
18 judge shall, by a warrant reciting the accusation, commit him OR HER to
19 the county jail for such a time not exceeding ~~thirty~~ THIRTY-FIVE days and
20 as specified in the warrant as will enable the arrest of the accused to be
21 made under a warrant of the governor on a requisition of the executive
22 authority of the state having jurisdiction of the offense, unless the accused
23 gives bail as provided in section 16-19-117, or until he OR SHE is legally
24 discharged.

25 **SECTION 98.** In Colorado Revised Statutes, 16-21-104, **amend**
26 (1) as follows:

27 **16-21-104. Fingerprinting - ordered by court.** (1) If the

1 offender has not been fingerprinted and photographed for the charges
2 pending before the court, the court at the first appearance of the offender
3 after the filing of charges shall order the offender to report to the
4 investigating agency within ~~ten~~ FOURTEEN days for fingerprinting and
5 photographing. The investigating agency shall endorse upon a copy of the
6 order the completion of the fingerprinting and photographing and return
7 the same to the court. At least one set of fingerprints and one set of
8 photographs ordered pursuant to this section shall be forwarded by the
9 investigating agency to the Colorado bureau of investigation in a form
10 and manner prescribed by such bureau.

11 **SECTION 99.** In Colorado Revised Statutes, 16-22-113, **amend**
12 (1.3) (a), (1.3) (b) (I), and (1.3) (b) (II) as follows:

13 **16-22-113. Petition for removal from registry.** (1.3) (a) If a
14 person is eligible to petition to discontinue his or her duty to register
15 pursuant to paragraph (d) of subsection (1) of this section, the court, at
16 least ~~sixty~~ SIXTY-THREE days before dismissing the case, shall notify each
17 of the parties described in paragraph (a) of subsection (2) of this section,
18 the person, and the victim of the offense for which the person was
19 required to register, if the victim has requested notice and has provided
20 current contact information, that the court will consider whether to order
21 that the person may discontinue his or her duty to register when the court
22 dismisses the case as a result of the person's successful completion of the
23 deferred judgment and sentence or deferred adjudication. The court shall
24 set the matter for hearing if any of the parties described in paragraph (a)
25 of subsection (2) of this section or the victim of the offense object, or if
26 the person requests a hearing. If the court enters an order discontinuing
27 the person's duty to register, the person shall send a copy of the order to

1 each local law enforcement agency with which the person is registered
2 and to the CBI. If the victim of the offense has requested notice, the court
3 shall notify the victim of its decision either to continue or discontinue the
4 person's duty to register.

5 (b) (I) If a juvenile is eligible to petition to discontinue his or her
6 duty to register pursuant to paragraph (e) of subsection (1) of this section,
7 the court, at least ~~sixty~~ SIXTY-THREE days before discharging the
8 juvenile's sentence, shall notify each of the parties described in paragraph
9 (a) of subsection (2) of this section, the juvenile, and the victim of the
10 offense for which the juvenile was required to register, if the victim has
11 requested notice and has provided current contact information, that the
12 court shall consider whether to order that the juvenile may discontinue his
13 or her duty to register when the court discharges the juvenile's sentence.
14 The court shall set the matter for hearing if any of the parties described
15 in paragraph (a) of subsection (2) of this section or the victim of the
16 offense object, or if the juvenile requests a hearing, and shall consider the
17 criteria in paragraph (e) of subsection (1) of this section in determining
18 whether to continue or discontinue the duty to register. If the court enters
19 an order discontinuing the juvenile's duty to register, the department of
20 human services shall send a copy of the order to each local law
21 enforcement agency with which the juvenile is registered, the juvenile
22 parole board, and to the CBI. If the victim of the offense has requested
23 notice, the court shall notify the victim of its decision either to continue
24 or discontinue the juvenile's duty to register.

25 (II) If a juvenile is eligible to petition to discontinue his or her
26 registration pursuant to paragraph (e) of subsection (1) of this section and
27 is under the custody of the department of human services and yet to be

1 released on parole by the juvenile parole board, the department of human
2 services may petition the court to set a hearing pursuant to paragraph (e)

20 C.R.S., the prosecution may file an interlocutory appeal of a decision
21 transferring the case to another county.

25 appellate court shall review any sentence which is imposed unless, within

1 sentence will be sought; said notice must state the grounds upon which it
2 is based.

27 (c) (II) The defendant or the district attorney shall have ~~ninety-five~~

1 NINETY-EIGHT days after the disposal motion is sent to file an objection
2 in the court in which the disposal motion was filed. The objection shall
3 state specific grounds supporting the preservation of the DNA evidence.
4 If the district attorney files an objection, the district attorney shall provide
5 copies of the objection to the defendant and the law enforcement agency.
6 If the defendant files an objection, the defendant shall provide copies of
7 the objection to the district attorney and the law enforcement agency.

8 **SECTION 104.** In Colorado Revised Statutes, 18-1.3-101,
9 **amend** (1) as follows:

10 **18-1.3-101. Deferred prosecution.** (1) Except as otherwise
11 provided in section 18-6-801 (4), in any case, the court may, prior to trial
12 or entry of a plea of guilty and with the consent of the defendant and the
13 prosecution, order the prosecution of the offense to be deferred for a
14 period not to exceed two years; except that the period of deferred
15 prosecution may be extended for an additional time up to one hundred

26 **18-1.3-102. Deferred sentencing of defendant.** (1) In any case
27 in which the defendant has entered a plea of guilty, the court accepting

1 the plea has the power, with the written consent of the defendant and his
2 or her attorney of record and the district attorney, to continue the case for
3 a period not to exceed four years from the date of entry of a plea to a
4 felony or two years from the date of entry of a plea to a misdemeanor, or
5 petty offense, or traffic offense for the purpose of entering judgment and

17 defendant, the defendant's attorney of record, and the district attorney,
18 under which the defendant is obligated to adhere to such stipulation. The
19 conditions imposed in the stipulation shall be similar in all respects to
20 conditions permitted as part of probation. Any person convicted of a
21 crime, the underlying factual basis of which included an act of domestic
22 violence, as defined in section 18-6-800.3 (1), shall stipulate to the
23 conditions specified in section 18-1.3-204 (2) (b). In addition, the
24 stipulation may require the defendant to perform community or charitable
25 work service projects or make donations thereto. Upon full compliance
26 with such conditions by the defendant, the plea of guilty previously
27 entered shall be withdrawn and the charge upon which the judgment and

1 sentence of the court was deferred shall be dismissed with prejudice.
2 Such stipulation shall specifically provide that, upon a breach by the
3 defendant of any condition regulating the conduct of the defendant, the

5 When, as a condition of the deferred sentence, the court orders the
6 defendant to make restitution, evidence of failure to pay the said
7 restitution shall constitute prima facie evidence of a violation. Whether
8 a breach of condition has occurred shall be determined by the court
9 without a jury upon application of the district attorney or a probation
10 officer and upon notice of hearing thereon of not less than ~~five~~ SEVEN
11 days to the defendant or the defendant's attorney of record. Application
12 for entry of judgment and imposition of sentence may be made by the
13 district attorney or a probation officer at any time within the term of the
14 deferred judgment or within ~~thirty~~ THIRTY-FIVE days thereafter. The
15 burden of proof at such hearing shall be by a preponderance of the
16 evidence, and the procedural safeguards required in a revocation of
17 probation hearing shall apply.

5 The postsecondary educational institution's reply shall include a statement
6 of whether or not it will accept the person as a student. Acceptance by a
7 state postsecondary educational institution shall be pursuant to section
8 23-5-106, C.R.S.

9 **SECTION 107.** In Colorado Revised Statutes, 18-1.3-207,
10 **amend** (1.1) as follows:

11 **18-1.3-207. Work and education release programs.**

12 (1.1) Before a final ruling by the court authorizing a probationer to
13 participate in a supervised education release program, the court shall
14 notify the prosecuting attorney and the postsecondary educational
15 institution requesting their comments on the pending release. The notice
16 shall include all relevant information pertaining to the probationer and to
17 the nature of the crime for which he or she was convicted. Both the
18 prosecuting attorney and the postsecondary educational institution shall
19 reply to the court in writing within ~~ten~~ FOURTEEN days ~~of~~ AFTER receipt
20 of the notification or within such other reasonable time in excess of ~~ten~~
21 FOURTEEN days as specified by the court. The postsecondary educational
22 institution's reply shall include a statement of whether or not it will accept

24 educational institution shall be pursuant to section 23-5-106, C.R.S.

1 **corrections programs.** (1) (k) Any offender who escapes from a
2 residential community corrections program or who absconds from a

5 and shall not be credited with any time on escape or absconder status.
6 Within ~~thirty~~ THIRTY-FIVE days after an offender's escape or abscondment,

9 subsection (1) of the time credit deductions that would have been earned
10 by the offender.

14 (1) (a) Any person convicted of a crime of violence shall be sentenced

17 more than twice the maximum of, the presumptive range provided for

27 however, any reports, recorded statements, and notes, including results of

1 physical or mental examinations and scientific tests, experiments, or
2 comparisons, of any expert whom the defense intends to call as a witness
3 at the sentencing hearing shall be provided to the prosecuting attorney as
4 soon as practicable but not later than ~~thirty~~ THIRTY-FIVE days before trial:

5 (c.5) (I) Any material subject to this subsection (3) that the
6 defendant believes contains information that is privileged to the extent
7 that the prosecution cannot be aware of it in connection with its
8 preparation for, or conduct of, the trial to determine guilt on the
9 substantive charges against the defendant shall be submitted by the

15 (5) (a) After the examinations are completed and reports are filed,
16 the court shall conduct a hearing within ~~five~~ SEVEN days following the
17 court's receipt of all reports from appointed experts. The hearing shall be
18 limited to the sole issue of whether the convicted person is mentally
19 incompetent to be executed. At the hearing, all parties may present
20 evidence, cross-examine witnesses, and present argument or, by
21 stipulation, may submit the matter for the court's determination on the

16 may file with the Colorado supreme court a petition to obtain a review of
17 the district court's decision and requesting a stay of execution pending the
18 review.

19 (2) The supreme court shall expedite its review of the district
20 court's decision and, if the designated week of execution in an existing
21 warrant of conviction has not passed, shall not take more than ~~five~~
22 ~~working~~ SEVEN days to render its decision.

6 and notes, including results of physical or mental examinations and
7 scientific tests, experiments, or comparisons, of any expert whom the
8 prosecuting attorney intends to call as a witness at the sentencing hearing
9 shall be provided to the defense as soon as practicable but not later than
10 ~~forty-five~~ FORTY-NINE days before trial:

11 (d) The defendant shall provide the prosecuting attorney with the
12 following information and materials no later than ~~thirty~~ THIRTY-FIVE days
13 before the first trial date set for the beginning of the defendant's trial or
14 within such other time frame as the supreme court may establish by rule;
15 however, any reports, recorded statements, and notes, including results of
16 physical or mental examinations and scientific tests, experiments, or
17 comparisons, of any expert whom the defense intends to call as a witness
18 at the sentencing hearing shall be provided to the prosecuting attorney as
19 soon as practicable but not later than ~~thirty~~ THIRTY-FIVE days before trial:

20 (e) (I) Any material subject to this subsection (3.5) that the
21 defendant believes contains information that is privileged to the extent
22 that the prosecution cannot be aware of it in connection with its
23 preparation for, or conduct of, the trial to determine guilt on the
24 substantive charges against the defendant shall be submitted by the
25 defendant to the trial judge under seal no later than ~~forty-five~~ FORTY-NINE
26 days before trial.

27 **SECTION 126.** In Colorado Revised Statutes, 18-3-407, **amend**

1 (2) (a) as follows:

2 **18-3-407. Victim's and witness's prior history - evidentiary**
3 **hearing - victim's identity - protective order.** (2) In any criminal
4 prosecution for class 4 felony internet luring of a child, as described in

16 section 18-9-204; mistreatment, neglect, or abandonment under article 42
17 of title 35, C.R.S.; or unlawful ownership of a dangerous dog as described
18 in section 18-9-204.5, may prevent disposition of the animal by an
19 impound agency by posting a bond with the court in an amount sufficient
20 to provide for the animal's care and provision at the impound agency for

22 custody. The owner or custodian of any impounded animal may request
23 a hearing in a court of competent jurisdiction within ~~ten~~ FOURTEEN days
24 after impoundment to determine whether the costs associated with the
25 bond are fair and reasonable for the care of and provision for the
26 impounded animal. Such bond shall be filed with the court within ~~ten~~
27 FOURTEEN days after the animal is impounded. At the end of the time for

1 which expenses are covered by the bond, if the owner or custodian desires
2 to prevent disposition of the animal, the owner or custodian shall post a
3 new bond with the court within ~~ten~~ FOURTEEN days after the prior bond's
4 expiration. However, if, in the opinion of a licensed veterinarian, the
5 animal is experiencing extreme pain or suffering or is severely injured
6 past recovery, severely disabled past recovery, or severely diseased past
7 recovery, the animal may be euthanized without a court order. At the end
8 of the time for which expenses are covered by the bond, the impound
9 agency may determine disposition of the animal unless there is a court
10 order prohibiting such disposition. The owner or custodian shall be liable
11 for the cost of the care of, provision for, or disposal of the animal.

12 **SECTION 131.** In Colorado Revised Statutes, 18-9-309.5,

15 shown to the satisfaction of the court, either by verified complaint or

26 determine whether such temporary restraining order shall be continued
27 pending final determination of the action. Until such hearing takes place,

15 written promise to appear commits a class 3 misdemeanor.

8 rights are to be determined that the person has the right to waive his or
9 her right to appear and contest and that failure to appear and contest may
10 likely result in termination of the parent's or the alleged parent's parental
11 rights to the child. Proof of giving the notice shall be filed with the court
12 before the petition is heard or otherwise acted upon. If no person has been
13 identified as the birth parent, the court shall order that notice be provided
14 to all possible birth parents by publication or public posting of the notice
15 at times and in the places and manner the court deems appropriate.

16 (d) (I) The court shall vacate the proceeding and, at the time of the
17 review of the case pursuant to paragraph (c) of subsection (1) of this
18 section, enter an order terminating the parent-child legal relationship of
19 the other birth parent or possible birth parent if the other birth parent or
20 possible birth parent:

21 (B) Has failed to appear and contest or to file an answer to the
22 petition for termination or to file a paternity action within the prescribed
23 ~~twenty~~ TWENTY-ONE days following the date of the service, publication,
24 or posting of the notice as provided in the notice pursuant to paragraph
25 (b) of this subsection (2); or

26 **SECTION 137.** In Colorado Revised Statutes, 19-5-103.7,
27 **amend** (2), (4) (a) (V), (7) (c) (I) (A), (7) (c) (II), (7) (d), and (7) (f) (I)

1 (B) as follows:

2 **19-5-103.7. Anticipated expedited relinquishment - children**
3 **under one year of age - notice to other or possible parent -**
4 **administrative procedures.** (2) The licensed child placement agency
5 may give notice of the anticipated expedited relinquishment prior to or
6 after the filing of the affidavit and petition with the court, but not more
7 than ~~sixty~~ SIXTY-THREE days prior to the anticipated birth of the child to
8 be relinquished.

9 (4) (a) Notice of the anticipated expedited relinquishment given
10 pursuant to this section shall include the name, mailing address, and
11 physical address of the licensed child placement agency providing the
12 notice and shall inform the other birth parent or possible birth parent of
13 the following:

14 (V) That failure to declare an intent to contest the termination of
15 parental rights may likely result in a termination of the person's parental
16 rights to the child, and that, to declare an intent to contest the termination
17 of the parent-child legal relationship, the other birth parent or possible
18 birth parent shall:

19 (A) No later than ~~twenty~~ TWENTY-ONE days after the date of notice
20 pursuant to paragraph (b) of subsection (3) of this section or before a
21 relinquishment petition is filed with the court, whichever occurs later,
22 either return a reply form to the licensed child placement agency by
23 certified mail, return receipt requested, or personally appear at the
24 licensed child placement agency to declare an intent to contest the
25 termination of parental rights; and

26 (B) No later than ~~twenty~~ TWENTY-ONE days after the date of notice
27 pursuant to paragraph (b) of subsection (3) of this section or before a

1 relinquishment petition is filed with the court, whichever occurs later, file
2 a claim of paternity pursuant to article 4 of this title and notify the
3 licensed child placement agency pursuant to section 19-4-105.5 (4);

4 (7) (c) (I) Notwithstanding any provision of this section to the
5 contrary, if the other birth parent or possible birth parent replies to notice
6 provided by publication pursuant to subsection (3) of this section by
7 contacting the licensed child placement agency in a manner other than is
8 specified in paragraph (b) of this subsection (7), and the other birth parent
9 or possible birth parent provides his or her full name and address, the
10 licensed child placement agency shall:

11 (A) Within ~~three-business~~ SEVEN days after the contact, and by
12 certified mail, return receipt requested, send a reply form to the other
13 birth parent or possible birth parent with a written statement informing
14 the person that the date he or she contacted the licensed child placement
15 agency in response to the notice received shall be considered his or her
16 date of reply if he or she returns the form no later than ~~ten~~ FOURTEEN days
17 after the date noted on the return receipt, and that, if he or she returns the
18 form more than ~~ten~~ FOURTEEN days after the date noted on the return

22 paragraph (c) shall be the date the other birth parent or possible birth
23 parent contacts the licensed child placement agency in response to the
24 notice received if he or she returns the form no later than ~~ten~~ FOURTEEN
25 days after the date noted on the return receipt of the form. If the other
26 birth parent or possible birth parent returns the form more than ~~ten~~
27 FOURTEEN days after the date noted on the return receipt, the date the

1 reply is received by the licensed child placement agency shall be

4 if the other birth parent or possible birth parent files a claim of paternity

7 notice shall be deemed to satisfy the requirements of subsection (5) of this
8 section, so long as the claim of paternity is filed and notice is provided to
9 the licensed child placement agency no later than ~~twenty~~ TWENTY-ONE

11 before a relinquishment petition is filed with the court.

21 notice that he is the father or likely father of the child;

23 birth parent or any other possible birth parent and no person has appeared
24 claiming to be the other birth parent and claiming custodial rights, the
25 court shall enter an order terminating the unknown birth parent's
26 parent-child legal relationship with reference to the child. Subject to the
27 disposition of an appeal upon the expiration of ~~thirty~~ THIRTY-FIVE days

1 after an order terminating a parent-child legal relationship is issued under
2 subsection (3) of this section or this subsection (4), the order cannot be
3 questioned by any person, in any manner, or upon any ground, except
4 fraud upon the court or fraud upon a party. Upon an allegation of fraud,
5 the termination order cannot be questioned by any person, in any manner
6 or upon any ground, after the expiration of ~~ninety~~ NINETY-ONE days from
7 the date that the order was entered.

8 (5) Notice of the proceeding shall be given to every person
9 identified as the other birth parent or a possible birth parent in the manner
10 appropriate under the Colorado rules of juvenile procedure for the service
11 of process or in any manner the court directs. The notice shall inform the
12 parent or alleged parent whose rights are to be determined that failure to
13 file an answer or to appear within ~~thirty~~ THIRTY-FIVE days after service
14 and, in the case of an alleged father, failure to file a claim of paternity
15 under article 4 of this title within ~~thirty~~ THIRTY-FIVE days after service, if
16 a claim has not previously been filed, may likely result in termination of
17 the parent's or the alleged parent's parental rights to the minor. The notice
18 also shall inform the parent or alleged parent whose rights are to be
19 determined that such person has the right to waive his or her right to
20 appear and contest and that failure to appear and contest may likely result
21 in termination of the parent's or the alleged parent's parental rights to the
22 minor. Proof of giving the notice shall be filed with the court before the
23 petition is heard. If no person has been identified as the birth parent, the
24 court shall order that notice be provided to all possible parents by
25 publication or public posting of the notice at times and in places and
26 manner the court deems appropriate.

27 **SECTION 140.** In Colorado Revised Statutes, 19-5-203, **amend**

1 (1) (d) (II), (1) (d.5) (II), (1) (j), and (1) (k) as follows:

2 **19-5-203. Availability for adoption.** (1) A child may be
3 available for adoption only upon:

4 (d) (II) Written and verified consent of the parent in a stepparent
5 adoption, accompanied by an affidavit or sworn testimony of such parent,
6 that the other birth parent has abandoned the child for a period of one year
7 or more or that the other birth parent has failed without cause to provide
8 reasonable support for such child for a period of one year or more. Upon
9 filing of the petition in adoption, the court shall issue a notice directed to
10 the other parent, which notice shall state the nature of the relief sought,
11 the names of the petitioner and the child, and the time and place set for
12 hearing on the petition. If the address of the other parent is known,
13 service of such notice shall be in the manner provided by the Colorado
14 rules of civil procedure for service of process. Upon affidavit by the
15 petitioner that, after diligent search, the address of the other parent
16 remains unknown, the court shall order service upon the other parent by
17 one publication of the notice in a newspaper of general circulation in the
18 county in which the hearing is to be held. The hearing shall not be held
19 sooner than ~~thirty~~ THIRTY-FIVE days after service of the notice is
20 complete, and, at such time, the court may enter a final decree of adoption
21 notwithstanding the time limitation in section 19-5-210 (2).

22 (d.5) (II) In a petition for a second-parent adoption, the court shall
23 require a written home study report prepared by a county department of
24 social services, designated qualified individual, or child placement agency
25 and approved by the department pursuant to section 19-5-207.5 (2). If the
26 child of a sole legal parent was adopted by that parent less than ~~six~~
27 ~~months~~ ONE HUNDREDEIGHTY-TWODAYS prior to the filing of an adoption

1 petition by a second prospective parent and if the second prospective
2 parent was included in the home study report that was prepared pursuant
3 to section 19-5-207 for the adoption of the child by the first parent, then
4 that home study report shall be a valid home study report for the purpose
5 of the second parent's adoption. If the filing of a petition for adoption by
6 the second prospective parent occurs ~~six months~~ ONE HUNDRED
7 EIGHTY-TWO DAYS or more after the adoption by the first parent, a
8 separate home study report shall be required pursuant to section 19-5-207.

9 (j) Submission of an affidavit or sworn testimony of the adoptive
10 relative in a kinship adoption that the birth parent or birth parents have
11 abandoned the child for a period of one year or more or that the birth
12 parent or birth parents have failed without cause to provide reasonable
13 support for such child for a period of one year or more, and that the
14 relative seeking the kinship adoption has had physical custody of the child
15 for a period of one year or more and the child is not the subject of a
16 pending dependency and neglect proceeding pursuant to article 3 of this
17 title. Upon filing of the petition in adoption, the court shall issue a notice
18 directed to the birth parent or birth parents, which notice shall state the
19 nature of the relief sought, the names of the petitioner and the child, and
20 the time and place set for hearing on the petition. If the address of the
21 birth parent is known, service of such notice shall be in the manner
22 provided by the Colorado rules of civil procedure for service of process.
23 Upon affidavit by the petitioner that describes with specificity the diligent
24 search made by the petitioner, and that states that, after diligent search,
25 the address of the birth parent or birth parents remains unknown, the court
26 shall order service upon the birth parent or birth parents by one
27 publication of the notice in a newspaper of general circulation in the

1 county in which the hearing is to be held. The hearing shall not be held
2 sooner than ~~thirty~~ THIRTY-FIVE days after service of the notice is
3 complete, and, at such hearing, the court may enter a final decree of
4 adoption notwithstanding the time limitation in section 19-5-210 (2).

5 (k) Submission of an affidavit or sworn testimony of the legal
6 custodian or legal guardian in a custodial adoption that the birth parent or
7 birth parents have abandoned the child for a period of one year or more
8 or that the birth parent or birth parents have failed without cause to
9 provide reasonable support for such child for a period of one year or more
10 and that the legal custodian or legal guardian seeking the custodial
11 adoption has had the child in his or her physical custody for a period of
12 one year or more. Upon filing of the petition in adoption, the court shall
13 issue a notice directed to the birth parent or birth parents, which notice
14 shall state the nature of the relief sought, the names of the petitioner and
15 the child, and the time and place set for hearing on the petition. If the
16 address of the birth parent or birth parents is known, service of such
17 notice shall be in the manner provided by the Colorado rules of civil
18 procedure for service of process. Upon affidavit by the petitioner that
19 describes with specificity the diligent search made by the petitioner, and
20 that states that, after diligent search, the address of the birth parent or
21 birth parents remains unknown, the court shall order service upon the
22 birth parent or birth parents by one publication of the notice in a
23 newspaper of general circulation in the county in which the hearing is to
24 be held. The hearing shall not be held sooner than ~~thirty~~ THIRTY-FIVE days
25 after service of the notice is complete, and, at such hearing, the court may
26 enter a final decree of adoption notwithstanding the time limitation in
27 section 19-5-210 (2).

1 **SECTION 141**. In Colorado Revised Statutes, 19-5-208, **amend**

23 **standard.** (1) No final decree of adoption shall be attacked by reason of
24 any jurisdictional or procedural defect after the expiration of ~~ninety~~
25 NINETY-ONE days following the entry of the final decree; except that, in
26 cases of stepparent adoption, no final decree of adoption shall be attacked
27 by reason of fraud upon the court or fraud upon a party, whether or not

1 there is a jurisdictional or procedural defect, after the expiration of one

23 docket listing the name, address, and telephone number of every person
24 who has participated in a rule-making proceeding by written statement,
25 or by oral comment at a hearing. Any person who commences suit for
26 judicial review of the rule shall notify each person on the agency's docket
27 of the fact that a suit has been commenced. The notice shall be sent by

1 first-class certified mail within ~~ten~~ FOURTEEN days after filing of the

11 the nature of quo warranto, within ~~thirty~~ THIRTY-FIVE days after entry of
12 such order, and not otherwise. The formation of the rail district shall not
13 be directly or collaterally questioned in any suit, action, or proceeding,
14 except as expressly authorized in this section.

15 **SECTION 152.** In Colorado Revised Statutes, **amend** 37-90-114
16 as follows:

17 **37-90-114. Other administrative hearings.** Any person
18 claiming to be injured within the boundaries of a designated ground water
19 basin by any act of the state engineer or commission under the provisions
20 of this article, or the failure of the state engineer or commission to take
21 any action under the provisions of this article, except as provided for the
22 small capacity wells in section 37-90-105, shall file a written petition with
23 the commission stating the basis of the alleged injury. Thereafter, only
24 upon request by a petitioner and upon ~~thirty~~ THIRTY-FIVE days' written
25 notice to any adverse party, the commission shall conduct a hearing upon
26 the petition in the manner provided in section 37-90-113. If notice of any
27 such act has been published pursuant to section 37-90-112 and no hearing

1 has been requested pursuant to such notice, this section shall not be
2 construed to create a subsequent or additional right to request a hearing
3 concerning such act.

4 **SECTION 153.** In Colorado Revised Statutes, 37-90-115, **amend**
5 (1) (b) (I) as follows:

6 **37-90-115. Judicial review of actions of the ground water**
7 **commission or the state engineer.** (1) (b) (I) The notice of such appeal
8 shall be served by the appellant upon the state engineer or the commission
9 and all interested parties within ~~thirty~~ THIRTY-FIVE days after the notice
10 of such decision or act and, unless such appeal is taken within said time,
11 the action of the state engineer or the commission shall be final and
12 conclusive. For purposes of service only, "all interested parties" shall be

25 with the secretary of the district not less than ~~thirty~~ THIRTY-FIVE days

12 commission and ground water users within the district. No such measures
13 or regulations shall be instituted until after a public hearing. Notice of
14 such hearing shall be published. Such notice shall state the time and place
15 of the hearing and in general terms the corrective measures or regulations
16 proposed. Within ~~sixty~~ SIXTY-THREE days after such hearing, the board
17 shall announce the measures or regulations ordered to be taken and shall
18 cause notice of such action to be published. The board has the authority
19 to compel compliance with such measures or regulations by an action
20 brought in the district court of the county in which any failure to comply
21 is found to exist.

22 (b) Any person adversely affected or aggrieved by the
23 announcement of control or conservation measures or regulations adopted
24 by the district board may appeal such decision to the ground water
25 commission by filing a notice of appeal and the grounds therefor with the
26 commission not later than ~~thirty~~ THIRTY-FIVE days after the date of last
27 publication. The commission shall hear all such appeals pursuant to

1 section 37-90-113. The commission shall have authority to affirm or
2 reject the measures or regulations adopted by the district or to modify
3 such measures or regulations but only upon consent from the district
4 board. Judicial review of commission actions in such appeals may be
5 taken pursuant to section 37-90-115.

6 (c) Any person adversely affected or aggrieved by an act of the
7 district board, other than the announcement of control or conservation
8 measures or regulations, has the right to be heard by the board. Such
9 person shall file a written request for a hearing that states the basis of the
10 alleged injury. Unless agreed otherwise by all parties to a hearing or
11 unless otherwise approved by the district due to extenuating
12 circumstances, a hearing shall be held within one hundred ~~eighty~~
13 EIGHTY-TWO days after filing the request for such a hearing. Upon ~~thirty~~
14 THIRTY-FIVE days' written notice to all adverse parties, the district shall
15 conduct a hearing upon the matter. Hearing procedures shall be as
16 informal as possible, with due regard for the rights of the parties. All
17 parties shall have the right to subpoena witnesses and to be heard either
18 in person or by attorney. The district board may have such hearings
19 conducted before an agent or hearing officer. After such hearing, the
20 district board shall issue a written decision containing its findings and
21 conclusions and shall serve its decision upon all parties by first-class
22 mail. Judicial review of such district decisions may be taken in the
23 manner and governed by the standards set forth for review of commission
24 and state engineer decisions in section 37-90-115.

25 (2) Subject to review by the ground water commission pursuant
26 to subsection (1) of this section, the board may institute control measures
27 or regulations to prescribe satisfactory and economical measuring

1 methods for the measurement of water levels in and the amount of water
2 withdrawn from wells and to require reports to be made at the end of each
3 pumping season showing the date and water level at the beginning of the
4 pumping season, the date and water level at the end of the pumping
5 season, and any period of more than ~~thirty~~ THIRTY-FIVE days cessation of
6 pumping during such pumping season.

7 **SECTION 156.** In Colorado Revised Statutes, 37-90-137, **amend**
8 (2) (b) (II) (B), (2) (b) (II) (E), and (3) (c) as follows:

9 **37-90-137. Permits to construct wells outside designated**
10 **basins - fees - permit no ground water right - evidence - time**
11 **limitation - well permits - rules - repeal.** (2) (b) (II) If the state
12 engineer, after a hearing, finds that circumstances in a particular instance
13 so warrant, or if a court decree is entered for the proposed well location
14 after notice has been given in accordance with sub-subparagraph (B) of
15 this subparagraph (II), the state engineer may issue a permit without
16 regard to the limitation specified in sub-subparagraph (B) of
17 subparagraph (I) of this paragraph (b); except that no hearing shall be
18 required and the state engineer may issue a well permit without regard to
19 the limitation specified in sub-subparagraph (B) of subparagraph (I) of
20 this paragraph (b):

21 (B) If the proposed well is part of a water court proceeding
22 adjudicating the water right for the well, or if the proposed well is part of
23 an adjudication of a plan for augmentation or change of water right and
24 if evidence is provided to the water court that the applicant has given
25 notice of the water court application, at least ~~ten~~ FOURTEEN days before
26 making the application, by registered or certified mail, return receipt
27 requested, to the owners of record of all wells within six hundred feet of

1 the proposed well;

2 (E) If the proposed well is an oil and gas well, there is an existing
3 production water well that is not an oil and gas well within six hundred
4 feet of the surface location of the proposed oil and gas well, the state
5 engineer has provided written notice of the application by certified mail
6 to the owners of such wells that are not oil and gas wells within ~~thirty~~
7 THIRTY-FIVE days after receipt of a complete application for the proposed
8 well, and the state engineer has given those to whom notice was provided
9 ~~thirty~~ THIRTY-FIVE days after the date of mailing of such notice to file
10 comments on the proposed well's application.

11 (3) (c) If evidence that the well has been constructed and that the
12 pump was installed, as required pursuant to paragraph (a) of this
13 subsection (3), has not been received as of the expiration date of the
14 permit to construct a well, the state engineer shall so notify the applicant
15 by certified mail. The notice shall give the applicant the opportunity to
16 submit evidence that the well was constructed and that the pump was
17 installed before the expiration date. The evidence must be received by the
18 state engineer within ~~twenty~~ TWENTY-ONE days after receipt of the notice
19 by the applicant and must be accompanied by a filing fee of thirty dollars.
20 If the state engineer finds the evidence to be satisfactory, the permit shall
21 remain in force and effect. The state engineer shall consider any records
22 available in the state engineer's office, any evidence provided to the state
23 engineer, and all other matters set forth in this section in determining
24 whether the permit should remain in force and effect.

25 **SECTION 157.** In Colorado Revised Statutes, 37-90-140, **amend**
26 (1) (d), (3), and (5) as follows:

27 **37-90-140. Inclusion of lands.** (1) (d) Within ~~twenty~~

1 TWENTY-ONE days after the filing of the petition, the board shall examine
2 the petition, and, if it finds that it bears the requisite number of signatures
3 and otherwise meets the stated requirements, it shall accept the petition
4 and shall fix a time and place, not less than ~~thirty~~ THIRTY-FIVE days nor
5 more than ~~fifty~~ FORTY-TWO days after the date of such acceptance, for a
6 hearing thereon. The secretary of the board shall publish a notice of such
7 hearing by one publication in a newspaper of general circulation in every
8 county in which any portion of the district and the proposed additional
9 territory to be included in the district are located. The publication shall be
10 at least ~~ten~~ FOURTEEN days prior to the date of the hearing. Such notice
11 shall state the nature of the petition, the description of the proposed
12 additional territory, and that any person owning any interest in real

15 writing why the petition should not be granted.

16 (3) The board shall appoint three taxpaying electors of the district,
17 including two from the area sought to be included, as judges of the
18 election. The secretary of the board shall have published a notice of the
19 time and place of said election to be held in the territory proposed for
20 inclusion in the district by one publication in a newspaper of general
21 circulation in the territory proposed for inclusion in the district. Such
22 election shall not be held less than ~~twenty~~ TWENTY-ONE days after said
23 publication of notice.

24 (5) Any action of the board with respect to the inclusion of
25 territory within an existing district may be reviewed by the district court
26 in appeal proceedings filed within ~~ten~~ FOURTEEN days after the board's

26 **37-92-102. Legislative declaration - basic tenets of Colorado**
27 **water law.** (4) Any appropriation made pursuant to subsection (3) of this

1 section shall also be subject to the following principles and limitations:

2 (b) (II) For the purposes of this paragraph (b), "adequate public
3 notice and comment process" shall include the following:

4 (A) Notice of the proposed decrease and the date of the public
5 meeting at which it will first be considered shall be printed in the resume
6 in the water court having jurisdiction over the decree that is the subject
7 of the decrease. The first public meeting of the board at which the
8 decrease is to be considered shall occur at least ~~sixty~~ SIXTY-THREE days
9 after the month in which the resume is published. Notice shall also be
10 published in a newspaper of statewide distribution within ~~thirty~~
11 THIRTY-FIVE to ~~forty-five~~ FORTY-NINE days prior to such first public
12 meeting.

13 (C) On the written request of any person made within ~~thirty~~
14 THIRTY-FIVE days after the date of the first public meeting, the board shall
15 delay the subsequent public meeting for up to one year to allow such
16 person the opportunity for the collection of scientific data material to the

18 of the proceedings.

19 (D) On the written request of any person made within ~~thirty~~

17 and oral argument and render its decision to affirm or set aside the board's

19 promptly enter an order decreasing the board's appropriation decree in
20 accordance with the board's written determination. If the board's
21 determination is set aside, the court shall enter its order of relief under the
22 provisions of section 24-4-106 (7), C.R.S. Appellate review of the court's
23 order shall be as allowed in other water matters.

24 (5) Within ~~thirty~~ THIRTY-FIVE days after initiating any water rights
25 filing for the adjudication of a recreational in-channel diversion, any
26 county, municipality, city and county, water district, water and sanitation
27 district, water conservation district, or water conservancy district shall

8 registered or certified mail, return receipt requested, to:

9 (4) The referee, without conducting a formal hearing, shall make
10 such investigations as are necessary to determine whether or not the
11 statements in the application and statements of opposition are true and to
12 become fully advised with respect to the subject matter of the applications
13 and statements of opposition. The referee shall consult with the
14 appropriate division engineer or the state engineer or both. The engineer
15 consulted shall file a report in writing within ~~thirty~~ THIRTY-FIVE days,
16 unless such time is extended by the referee, which original report shall be
17 filed in the proceedings, and a copy shall be sent by the division engineer
18 to the applicant or the applicant's attorney, who shall then send copies to
19 all parties of record if they have not otherwise been served and so certify
20 before any ruling shall be entered or become effective. A water judge
21 who is acting as a referee in the water judge's division shall have the same
22 authority as provided for the referee in this subsection (4). If the
23 application is rereferred to the water judge by the referee prior to
24 consultation, the division engineer shall file a written recommendation in

4 referee shall rerefer the matter to the water judge at any time before the
5 referee's hearing upon a motion to rerefer by the applicant or any opposer
6 certifying that party's intent to protest an adverse ruling of the referee. A
7 motion to rerefer shall not be a prerequisite to a protest of the ruling of
8 the referee. A copy of the order shall be sent by the water clerk to the
9 applicant and to each person who has filed a statement of opposition and
10 to the state engineer and the division engineer by regular or electronic
11 mail.

12 **SECTION 164.** In Colorado Revised Statutes, 37-92-304, **amend**
13 (2) and (3) as follows:

14 **37-92-304. Proceedings by the water judge.** (2) Within ~~twenty~~
15 TWENTY-ONE days after the date of mailing thereof, any person, including

25 filing fee to maintain a party status in the case. All fees collected pursuant

1 (3) As to the rulings with respect to which a pleading has been
2 filed and as to matters which have been rereferred to the water judge by
3 the referee, there shall be de novo hearings. The court shall not be bound
4 by findings of the referee. The division engineer shall appear to furnish
5 pertinent information and may be examined by any party, and, if
6 requested by the division engineer, the attorney general shall represent the
7 division engineer. The applicant shall appear either in person or by
8 counsel and shall have the burden of sustaining the application, whether
9 it has been granted or denied by the ruling or has been rereferred by the
10 referee, and in the case of a change of water right or a plan for
11 augmentation the burden of showing absence of any injurious effect. All
12 parties of record shall remain parties in the proceedings before the water
13 judge. Any person may move to intervene in proceedings before the water
14 court upon payment of a fee, equal to that for filing an answer to a civil
15 action in district court, except for the state engineer who shall pay no fee,
16 and upon a showing of mistake, inadvertence, surprise, or excusable
17 neglect or to support a referee's ruling. The water court shall grant the
18 motion to intervene only if intervention is sought no less than ~~thirty~~
19 THIRTY-FIVE days before any pretrial conference or due date for trial data
20 certificates and if intervention will not unduly delay or prejudice the
21 adjudication of the rights of the original parties. Service of copies of
22 applications, written pleadings, or any other documents is not necessary
23 for jurisdictional purposes, but the water judge may order service of
24 copies of any documents on any persons and in any manner which he OR
25 SHE deems appropriate.

26 **SECTION 165.** In Colorado Revised Statutes, 37-92-305, **amend**
27 (7) as follows:

1 **37-92-305. Standards with respect to rulings of the referee and**
2 **decisions of the water judge.** (7) Prior to the cancellation or expiration

14 **repeal.** (3) (b) Beginning January 1, 2003, the state engineer may
15 approve the operation of a well described in paragraph (a) of this
16 subsection (3) under a substitute water supply plan if the following
17 conditions are met:

18 (III) The state engineer has given the owners of water rights and
19 decreed conditional water rights ~~thirty~~ THIRTY-FIVE days after the date of
20 mailing of such notice to file comments on the substitute water supply
21 plan. Such comments shall include any claim of injury, any terms and
22 conditions that should be imposed upon the plan to prevent injury to a
23 party's water rights or decreed conditional water rights, and any other
24 information the opposer wishes the state engineer to consider in
25 reviewing the substitute water supply plan request.

26 (IV) The state engineer, after consideration of the comments, has
27 determined that the operation and administration of such plan will replace

1 all out-of-priority stream depletions in time, location, and amount in a
2 manner that will prevent injury to other water rights and decreed
3 conditional water rights, including water quality and continuity to meet
4 the requirements of use to which the senior appropriation has normally
5 been put pursuant to section 37-80-120 (3), and will not impair
6 compliance with the South Platte river compact. The state engineer shall
7 impose such terms and conditions as are necessary to ensure that these
8 standards are met. In making the determinations specified in this
9 subparagraph (IV), the state engineer shall hold a public hearing to
10 address the issues. The public hearing shall be held no sooner than
11 thirty-five days and no later than ~~fifty~~ FORTY-NINE days after the date of
12 mailing of notice of the request for approval of the substitute water supply
13 plan. Notice of the time and place of the hearing shall be provided no
14 later than ~~twenty~~ TWENTY-ONE days prior to the hearing to all parties who
15 have subscribed to the substitute water supply plan notification list for
16 water division 1. At the hearing, every party shall be allotted a reasonable
17 amount of time by the state engineer to present its case or defense by oral
18 and documentary evidence and to conduct cross examination. At its own
19 expense, any party may cause the hearing to be recorded by a court
20 reporter or by an electronic recording device. Additionally, in making the
21 determinations specified in this subparagraph (IV), the state engineer
22 shall use the standards listed in paragraph (c) of this subsection (3) for
23 evaluating such plans. It is the legislative intent that the adoption of these
24 standards is only an interim compromise, to give greater certainty to
25 senior surface water users in Colorado than past practices of the state
26 engineer have given, until augmentation plans for these wells have been
27 approved by the water judge for water division 1 and final determinations

1 about the methodologies for calculating the amount and timing of stream
2 depletions have been made by the water judge. These interim standards
3 shall not create any presumptions, shift the burden of proof, or serve as
4 a defense in any application for approval of a plan for augmentation.

5 (c) (VIII) If amendments, including but not limited to the addition
6 of more wells or the addition of different replacement water sources, are
7 proposed to a substitute water supply plan after the initial written notice
8 of the plan was given, the notice, comment, and hearing process described
9 in this paragraph (c) shall be repeated for such amendments. If, in the
10 opinion of the state engineer, an amendment is necessary to prevent
11 immediate injury to other water rights that will occur prior to the
12 expiration of the ~~thirty-day~~ THIRTY-FIVE-DAY comment period provided
13 in subparagraph (III) of paragraph (b) of this subsection (3), the ~~thirty-day~~
14 THIRTY-FIVE-DAY comment period shall be shortened to ~~fifteen~~ FOURTEEN
15 days, the public hearing shall be held no later than ~~twenty-five~~
16 TWENTY-EIGHT days after the date of the mailing of notice of the request
17 for the amendment, and the amendment may be implemented before the
18 comment deadline and the public hearing. For amendments implemented
19 prior to a public hearing, the state engineer shall issue a decision
20 approving or denying the amendment no later than seven days after the
21 conclusion of the public hearing. The state engineer may revoke or further
22 condition the approval of any amendment after the comment and hearing
23 process.

24 (e) When the state engineer approves or denies a substitute water
25 supply plan, the state engineer shall serve a copy of the decision on all
26 parties to the application by first-class mail or, if such parties have so
27 elected, by electronic mail. Every decision of the state engineer shall

1 provide a detailed statement of the basis and rationale for the decision,
2 including a complete explanation of how all stream depletions were
3 calculated, the location where they occur, how all replacement water
4 sources were quantified, and what terms and conditions were imposed to
5 prevent injury to other water rights and why they were imposed. The
6 decision shall also include a description of the consideration given to any
7 written comments that were filed by other parties. Neither the approval
8 nor the denial by the state engineer shall create any presumptions, shift
9 the burden of proof, or serve as a defense in any legal action that may be
10 initiated concerning the substitute water supply plan. Any appeal of a
11 decision made by the state engineer concerning a substitute water supply
12 plan pursuant to this subsection (3) shall be made to the water judge in
13 water division 1 within ~~thirty~~ THIRTY-FIVE days after the date of service
14 of the decision. The water judge shall hear and determine such appeal
15 using the procedures and standards set forth in sections 37-92-304 and
16 37-92-305 for determination of matters rereferred to the water judge by
17 the referee. The proponent of the substitute water supply plan shall be
18 deemed to be the applicant for purposes of application of such procedures
19 and standards. The filing fee for the appeal shall be two hundred
20 seventy-one dollars for the proponent of the substitute water supply plan
21 and seventy dollars for any other party to the appeal. Moneys from such
22 fee shall be transmitted to the state treasurer and deposited in the water
23 adjudication cash fund, which fund is hereby created in the state treasury.
24 The general assembly shall appropriate moneys in the fund for the judicial
25 department's adjudications pursuant to this subsection (3).

26 (5) (a) Beginning January 1, 2002, for new water use plans
27 involving out-of-priority diversions or a change of water right, if no

1 application for approval of a plan for augmentation or a change of water
2 right has been filed with a water court and the water use plan or change
3 proposed and the depletions associated with such water use plan or
4 change will be for a limited duration not to exceed five years, except as
5 otherwise provided in subparagraph (II) of paragraph (b) of this
6 subsection (5), the state engineer may approve such plan or change as a
7 substitute water supply plan if the following conditions are met:

8 (III) The state engineer has given the owners of water rights and
9 decreed conditional water rights ~~thirty~~ THIRTY-FIVE days after the date of
10 mailing of such notice to file comments on the substitute water supply
11 plan. Such comments shall include any claim of injury or any terms and
12 conditions that should be imposed upon the plan to prevent injury to a
13 party's water rights or decreed conditional water rights and any other
14 information the opposer wishes the state engineer to consider in
15 reviewing the substitute water supply plan request.

16 (7) Beginning January 1, 2002, the state engineer may approve a
17 substitute water supply plan if the state engineer determines such plan is
18 needed to address an emergency situation and that the plan will not cause
19 injury to the vested water rights or decreed conditional water rights of
20 others or impair compliance with any interstate compact. Such plan shall
21 not be implemented for more than ~~ninety~~ NINETY-ONE days. For purposes
22 of this section, "emergency situation" means a situation affecting public
23 health or safety where a substitute water supply plan needs to be
24 implemented more quickly than the other procedures set forth in this
25 section allow. For 2003, an "emergency situation" may also mean an
26 immediate need for the use of augmentation wells necessitated by
27 extreme drought conditions if such augmentation wells are also included

1 in a request filed previously, or filed simultaneously with a request under
2 this subsection (7), for approval of a substitute water supply plan under
3 subsection (3) or (4) of this section. Approval pursuant to this section of
4 the use of augmentation wells shall include the terms and conditions
5 needed to account for and replace all out-of-priority stream depletions
6 that will result from such use, including post-pumping depletions. Within
7 ~~five~~ SEVEN days after the date of approval of the use of an augmentation
8 well under this subsection (7), the state engineer shall give notice of the
9 approval to all parties who have subscribed to the substitute water supply
10 plan notification list for water division 1. In all other situations, notice to
11 other water users shall not be required. Neither the approval nor the
12 denial by the state engineer shall create any presumptions, shift the
13 burden of proof, or be a defense in any legal action that may be initiated
14 concerning an emergency substitute water supply plan or in any
15 proceedings under subsection (3) or (4) of this section.

16 (10) (d) When the state engineer approves or denies a substitute
17 water supply plan pursuant to this subsection (10), the state engineer shall
18 serve a copy of the decision on all parties who have subscribed to the
19 substitute water supply plan notification list for water division 1 and all
20 parties to the water court case in which the plan for augmentation was
21 decreed by first-class mail or, if such parties have so elected, by
22 electronic mail. Neither the approval nor the denial by the state engineer
23 shall create any presumptions, shift the burden of proof, or serve as a
24 defense in any legal action involving the substitute water supply plan.
25 Any appeal of a decision made by the state engineer concerning a
26 substitute water supply plan approved or denied pursuant to this
27 subsection (10) shall be made within ~~thirty~~ THIRTY-FIVE days after the

1 date of service of the decision. Any such appeal shall be filed under the
2 same case number as the decreed plan for augmentation and shall be
3 heard under the retained jurisdiction of the water judge, using the
4 procedures and standards set forth in sections 37-92-304 and 37-92-305,
5 for determination of matters rereferred to the water judge by the referee.
6 The water judge shall hear and determine any such appeal on an
7 expedited basis. The applicant for the substitute water supply plan shall
8 not use the proposed substitute water supply in the decreed plan for
9 augmentation until any appeal under this paragraph (d) is decided by the
10 water court. Following the determination on appeal by the water court, the
11 applicant's use of water under the substitute water supply plan shall be
12 governed by such water court determination, unless the terms of the
13 augmentation plan decree provide otherwise.

14 (11) (b) For a substitute water supply plan pursuant to this
15 subsection (11), the state engineer may approve the temporary operation
16 of a coal bed methane well that withdraws tributary ground water only if
17 the following conditions are met:

18 (II) All parties who have subscribed to the substitute water supply
19 plan notification list for the water division in which the proposed plan is
20 located have ~~thirty~~ THIRTY-FIVE days after the date of mailing of such
21 notice to file comments on the substitute water supply plan. Such
22 comments shall include any claim of injury, any terms and conditions that
23 should be imposed upon the plan to prevent injury to a party's water rights
24 or decreed conditional water rights, and any other information a party
25 wishes the state engineer to consider in reviewing the substitute water
26 supply plan request; and

27 (e) Neither the approval nor the denial by the state engineer shall

1 create any presumptions, shift the burden of proof, or serve as a defense
2 in any legal action that may be initiated concerning the substitute water
3 supply plan. Any appeal of a decision made by the state engineer
4 concerning a substitute water supply plan pursuant to this subsection (11)
5 shall be to the water judge of the applicable water division within ~~thirty~~
6 THIRTY-FIVE days after the date of service of the decision. The water
7 judge shall hear and determine such appeal on an expedited basis using
8 the procedures and standards set forth in sections 37-92-304 and
9 37-92-305 for determination of matters referred to the water judge by the
10 referee.

11 **SECTION 167.** In Colorado Revised Statutes, 37-92-309, **amend**
12 (3) (a) and (4) (a) as follows:

13 **37-92-309. Interruptible water supply agreements - special**
14 **review procedures - rules - water adjudication cash fund - legislative**
15 **declaration.** (3) The state engineer is authorized to approve and
16 administer interruptible water supply agreements that permit a temporary
17 change in the point of diversion, location of use, and type of use of an
18 absolute water right without the need for an adjudication pursuant to this
19 article, subject to the following:

20 (a) The applicant for approval of an interruptible water supply
21 agreement shall provide written notice of the application by first-class
22 mail or electronic mail to all parties who have subscribed to the substitute
23 water supply plan notification list, as described in section 37-92-308 (6),
24 for the division or divisions in which the water right is located and in
25 which it will be used, and proof of such notice shall be filed with the state
26 engineer. The application shall be accompanied by a detailed written
27 report, prepared by a professional engineer or other professional

1 acceptable to the state engineer, that evaluates the historical consumptive
2 use, return flows, and the potential for material injury to other water
3 rights relating to the interruptible water supply agreement and that
4 proposes conditions to prevent such injury. The state engineer shall give
5 the owners of water rights ~~thirty~~ THIRTY-FIVE days after the date of
6 mailing of such notice to file comments on the operation of the
7 interruptible water supply agreement. Such comments shall include any
8 claim of injury or any terms and conditions that should be imposed upon
9 the agreement so that it will not cause injury to a party's water rights or
10 decreed conditional water rights, if such conditional rights will be
11 exercised during operation of the interruptible water supply agreement,
12 and any other information the party wishes the state engineer to consider
13 in reviewing the application.

14 (4) (a) When the state engineer approves or denies an interruptible
15 water supply agreement, the state engineer shall serve a copy of the
16 decision upon all parties to the application by first-class mail or, if such
17 parties have so elected, by electronic mail. Neither the approval nor the
18 denial of the agreement by the state engineer shall create any
19 presumptions, shift the burden of proof, or serve as a defense in any legal
20 action that may be initiated concerning the interruptible water supply
21 agreement. Any appeal of a decision made by the state engineer
22 concerning the operation of an interruptible water supply agreement
23 pursuant to this section shall be expedited, shall be limited to the issue of
24 injury, and shall be made within ~~thirty~~ THIRTY-FIVE days after mailing of
25 the decision to the water judge in the applicable water division. All
26 parties to the appeal shall pay to the water clerk a fee to cover the direct
27 costs associated with the expedited appeal. The water judge shall hear and

1 determine such appeal using the procedures and standards set forth in
2 sections 37-92-304 and 37-92-305 for determination of matters rereferred
3 to the water judge by the referee; except that the water judge shall not
4 deem any failure to appeal all or any part of the decision of the state
5 engineer or failure to state any grounds for appeal to preclude any party
6 from raising any claims of injury in a future proceeding before the water
7 judge. The proponent of the interruptible water supply agreement shall be
8 deemed to be the applicant for purposes of application of such procedures
9 and standards. Moneys from such fee shall be transmitted to the state
10 treasurer and deposited in the water adjudication cash fund, which fund
11 is hereby created in the state treasury. The general assembly shall
12 appropriate moneys in the fund for the judicial department's expedited
13 adjudications pursuant to this section.

14 **SECTION 168.** In Colorado Revised Statutes, 37-92-602, **amend**
15 (3) (c) (II) (A), (3) (e), and (3) (f) as follows:

16 **37-92-602. Exemptions - presumptions - legislative**
17 **declaration.** (3) (c) (II) (A) If such relocated well will not change
18 substantially the usage of water which can lawfully be made by means of
19 the existing well, a permit to construct and use the relocated well shall be
20 issued, and the existing well shall be abandoned within ~~ninety~~
21 NINETY-ONE days after the completion of the relocated well.

22 (e) The state engineer shall act upon an application filed under
23 this subsection (3) within ~~forty-five~~ FORTY-NINE days after such filing and
24 shall support his OR HER ruling with a written statement of the basis
25 therefor, and the provisions of article 4 of title 24, C.R.S., shall apply.

26 (f) Any person aggrieved by a decision of the state engineer
27 granting or denying an application filed under this subsection (3) may

1 within ~~thirty~~ THIRTY-FIVE days after such decision file a petition for
2 review with the water clerk of the water division in which the well is
3 located. Upon receipt of such petition, the water judge of said water
4 division shall promptly conduct such hearings as are necessary to
5 determine whether or not the decision of the state engineer shall be
6 upheld. In any case in which the state engineer's decision is reversed, the
7 water judge shall order the state engineer to grant or to deny the
8 application, as such reversal may require, and may specify such terms and
9 conditions as are appropriate. Appeals from any decision of the water
10 judge shall be made as in other civil actions.

11 **SECTION 169.** In Colorado Revised Statutes, 38-35-203, **amend**
12 (1) introductory portion as follows:

13 **38-35-203. Action to enforce.** (1) No spurious lien or spurious
14 document shall hold or affect any real or personal property longer than
15 ~~thirty~~ THIRTY-FIVE days after the lien or document has been recorded or
16 filed in the office of any state or local official or employee, including the
17 office of the clerk and recorder of any county or city and county or the
18 office of the Colorado secretary of state, unless within the ~~thirty~~
19 THIRTY-FIVE days:

20 **SECTION 170.** In Colorado Revised Statutes, 38-35-204, **amend**
21 (1) (a) as follows:

22 **38-35-204. Order to show cause.** (1) Any person whose real or
23 personal property is affected by a recorded or filed lien or document that
24 the person believes is a spurious lien or spurious document may petition
25 the district court in the county or city and county in which the lien or
26 document was recorded or filed or the federal district court in Colorado
27 for an order to show cause why the lien or document should not be

1 declared invalid. The petition shall set forth a concise statement of the
2 facts upon which the petition is based and shall be supported by an
3 affidavit of the petitioner or the petitioner's attorney. The order to show
4 cause may be granted ex parte and shall:

5 (a) Direct any lien claimant and any person who recorded or filed
6 the lien or document to appear as respondent before the court at a time
7 and place certain not less than ~~ten~~ FOURTEEN days nor more than ~~twenty~~
8 TWENTY-ONE days after service of the order to show cause why the lien
9 or document should not be declared invalid and why such other relief
10 provided for by this section should not be granted;

11 **SECTION 171.** In Colorado Revised Statutes, 38-38-101, **amend**
12 (1) (h) as follows:

13 **38-38-101. Holder of evidence of debt may elect to foreclose.**

14 (1) **Documents required.** Whenever a holder of an evidence of debt
15 declares a violation of a covenant of a deed of trust and elects to publish
16 all or a portion of the property therein described for sale, the holder or the
17 attorney for the holder shall file the following with the public trustee of
18 the county where the property is located:

19 (h) A separate document notifying the public trustee that the
20 property referred to in the notice of election and demand is property that
21 requires posting under section 38-38-802. If the document required by
22 this paragraph (h) is not filed at the time the documents required by
23 paragraphs (a) to (e) of this subsection (1) are filed with the public
24 trustee, and the holder determines at a later date that the property requires
25 posting, the holder shall request that the public trustee rerecord the notice
26 of election and demand. Thereafter, all deadlines for the foreclosure
27 action shall be determined according to the date of the rerecording of the

1 notice of election and demand as though the foreclosure was commenced
2 on such date, and the public trustee shall collect a fee of seventy-five
3 dollars from the holder. If the document required by this paragraph (h) is
4 filed in error, the holder may withdraw it by filing with the public trustee
5 an affidavit signed by the holder or the attorney for the holder affirming
6 both that the document required by this paragraph (h) was filed in error
7 and that the property has not been posted pursuant to section 38-38-802.
8 In order to be effective, and thereby notify the public trustee that the
9 property is not eligible for posting, such affidavit shall be filed with the
10 public trustee no later than ~~fifteen calendar~~ FOURTEEN days after the date
11 of the determination of the public trustee that the filing is complete in
12 accordance with section 38-38-102 (1).

13 **SECTION 172. Effective date - applicability.** (1) (a) This act
14 takes effect on July 1, 2012, and, except as provided in subsection (2) of
15 this section, applies to:

16 (I) Time intervals that are counted forward and, under the
17 provisions of this act, commence and end with dates on or after July 1,
18 2012; and

19 (II) Time intervals that are counted backwards and under the
20 provisions of this act commence and end with dates after June 30, 2012.

21 (b) For purposes of this subsection (1), in determining the date that
22 a time interval commences, the first day of the period is counted.

23 (2) This act does not apply to modify the settings of any dates or
24 time intervals set by an order of a court entered before July 1, 2012.

25 (3) The general assembly requests the supreme court to provide by
26 rule, order, or other similar guidance examples of various time intervals
27 related to civil and criminal procedures that are counted forward and that

1 are counted backward and to which this act applies and to which this act
2 does not apply pursuant to subsection (1) of this section.

3 **SECTION 173. Safety clause.** The general assembly hereby
4 finds, determines, and declares that this act is necessary for the immediate
5 preservation of the public peace, health, and safety.
