Summary of Legislation

The bill requires the General Assembly to reduce General Fund appropriations by the rate of unemployment and transfers that amount to the State Education Fund. The reductions apply across all branches of state government, but not to the Department of Education or the Department of Health Care Policy and Financing. The reduction is based on the March 1, 2012, unemployment rate as published by the United States Department of Labor Bureau of Labor Statistics (BLS), multiplied by General Fund appropriations in FY 2011-12.

State Transfers

Effective January 1, 2013, the State Treasurer will transfer \$206,804,368 from the General Fund to the State Education Fund. The transfer amount is based on Colorado's 8.3 percent unemployment rate as reported by the BLS for February 2012 (most recent available), and amounts listed in the *Appropriations Report: Fiscal Year 2011-12*, published by the Joint Budget Committee. The fiscal note will be updated when the March unemployment rate is published by the BLS.

State Appropriations

For FY 2012-13, negative appropriations totaling \$206,804,368 General Fund are required to implement the bill. Specific reductions by executive department and for the Judicial and Legislative branches are shown in Table 1.
