"SECTION 5. Appropriation. (1) In addition to any other appropriation, there is hereby appropriated, out of any moneys in the medical marijuana program cash fund created in section 25-1.5-106 (16) (a), Colorado Revised Statutes, not otherwise appropriated, to the department of public health and environment, for the center for health and environmental information, for the fiscal year beginning July 1, 2011, the sum of \$93,600, or so much thereof as may be necessary, for the implementation of this act.

(2) In addition to any other appropriation, there is hereby appropriated to the department of public safety, for the Colorado crime information center, for the fiscal year beginning July 1, 2011, the sum of \$93,600, or so much thereof as may be necessary. Said sum is from reappropriated funds received from the department of public health and environment out of the appropriation made in subsection (1) of this section.

SECTION 6. Appropriation. In addition to any other appropriation, there is hereby appropriated, out of any moneys in the general fund not otherwise appropriated, to the department of public health and environment, for the fiscal year beginning July 1, 2012, the sum of \$2,000,000, or so much thereof as may be necessary, for allocation to the Tony Grampsas youth services program related to the implementation of this act."
