Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB12-1358 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 2, line 8, after "marijuana" insert "businesses".
- 2 Page 2, line 9, strike "license" and substitute "begin licensing".
- 3 Page 3, line 26, strike "THE EFFECTIVE DATE OF THIS" and substitute "JULY  
4 1, 2012,".
- 5 Page 3, line 27, strike "PARAGRAPH (d),".
- 6 Page 4, strike lines 7 through 14.
- 7 Page 4, line 19, strike "THE COLORADO BUREAU OF INVESTIGATION AND".
- 8 Page 5, line 16, strike "the local licensing authority has" and substitute  
9 "the local licensing authority has".
- 10 Page 5, strike lines 17 and 18 and substitute "approved the application for  
11 a local license and issued a local license as provided for in sections  
12 ~~12-43.3-301 to 12-43.3-303~~ IT HAS COMPLETED EACH CRIMINAL HISTORY  
13 BACKGROUND CHECK ASSOCIATED WITH THE APPLICATION. IF THE STATE  
14 LICENSING AUTHORITY ISSUES THE APPLICANT A STATE LICENSE AND THE  
15 LOCAL LICENSING AUTHORITY SUBSEQUENTLY DENIES THE APPLICANT A  
16 LICENSE, THE STATE LICENSING AUTHORITY SHALL IMMEDIATELY RESCIND  
17 THE APPLICANT'S STATE LICENSE. THE STATE".

1 Page 5, after line 23, insert:

2           **"SECTION 5. Appropriation.** (1) In addition to any other  
3 appropriation, there is hereby appropriated, out of any moneys in the  
4 medical marijuana program cash fund created in section 25-1.5-106 (16)  
5 (a), Colorado Revised Statutes, not otherwise appropriated, to the  
6 department of public health and environment, for the center for health and  
7 environmental information, for the fiscal year beginning July 1, 2011, the  
8 sum of \$93,600, or so much thereof as may be necessary, for the  
9 implementation of this act.

10           (2) In addition to any other appropriation, there is hereby  
11 appropriated to the department of public safety, for the Colorado crime  
12 information center, for the fiscal year beginning July 1, 2011, the sum of  
13 \$93,600, or so much thereof as may be necessary. Said sum is from  
14 reappropriated funds received from the department of public health and  
15 environment out of the appropriation made in subsection (1) of this  
16 section.

17           **SECTION 6. Appropriation.** In addition to any other  
18 appropriation, there is hereby appropriated, out of any moneys in the  
19 general fund not otherwise appropriated, to the department of public  
20 health and environment, for the fiscal year beginning July 1, 2012, the  
21 sum of \$2,000,000, or so much thereof as may be necessary, for allocation  
22 to the Tony Grampsas youth services program related to the  
23 implementation of this act."

24 Renumber succeeding section accordingly.

25 Page 1, line 101, strike "**MARIJUANA.**" and substitute "**MARIJUANA, AND,**  
26 **IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.**".
