SB12-164 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

- 1 Amend printed bill, page 11, strike lines 14 through 17 and substitute:
 - 2 "~~(b) The provisions of paragraph (a) of this subsection (1) shall~~
 - 3 ~~not apply to a private college or university that, as of May 29, 2008, was~~
 - 4 ~~authorized to do business in Colorado and that awarded degrees."~~
- 5 Page 11, line 18, strike "(d)" and substitute "(c)"
- 6 Page 12, strike lines 20 through 22 and substitute "INFORMATION RELATED
7 TO AN ACTION BY THE INSTITUTION'S ACCREDITING BODY CONCERNING THE
8 INSTITUTION'S ACCREDITATION STATUS, INCLUDING BUT NOT LIMITED TO
9 REAFFIRMATION OR LOSS OF ACCREDITATION, APPROVAL OF A REQUEST
10 FOR CHANGE, A CAMPUS EVALUATION VISIT, A FOCUSED VISIT, OR
11 APPROVAL OF ADDITIONAL LOCATIONS. IN ADDITION, THE INSTITUTION
12 SHALL IMMEDIATELY NOTIFY THE DEPARTMENT IF THE INSTITUTION'S
13 ACCREDITING BODY IS NO LONGER".

15 ~~provisions of this subsection (4) shall not apply to a bible college or~~
16 ~~seminary that, as of May 29, 2008, was authorized to do business in~~
17 ~~Colorado and that awarded degrees."~~
- 18 Page 15, line 26, after "RECOMMEND" insert "THAT THE COMMISSION
19 RENEW THE INSTITUTION'S AUTHORIZATION OR".

- 1 Page 16, line 11, strike "RECOMMENDATION AND PROVIDE" and substitute
2 "RECOMMENDATION, AND THE DEPARTMENT AND THE COMMISSION SHALL
3 PROCEED IN ACCORDANCE WITH THE PROVISIONS OF THE "STATE
4 ADMINISTRATIVE PROCEDURE ACT", ".
5 Page 16, strike lines 12 through 21.
6 Page 17, line 1, after "MORE" insert "OF".
7 Page 17, line 2, after "(2)" insert "OR (3)".
8 Page 17, line 26, after "(2)" insert "OR (3)".
9 Page 17, line 27, strike "SECTION." and substitute "SECTION, AND THE
10 DEPARTMENT AND THE COMMISSION SHALL PROCEED IN ACCORDANCE
11 WITH THE PROVISIONS OF THE "STATE ADMINISTRATIVE PROCEDURE ACT",
12 ARTICLE 4 OF TITLE 24, C.R.S.".
13 Page 19, strike lines 10 through 27.
14 Page 21, line 12, strike "THAT THE INSTITUTION".
15 Page 21, strike lines 13 and 14 and substitute "THAT VIOLATES SECTION
16 23-2-104 (4);".
